

EXECUTIVE SUMMARY

Under *Contract No. HY/2012/07*, Gammon Construction Limited (GCL) is commissioned by the Highways Department (HyD) to undertake the design and construction of the Southern Connection Viaduct Section of the Tuen Mun – Chek Lap Kok Link Project (TM-CLK Link Project) while AECOM Asia Company Limited was appointed by HyD as the Supervising Officer. For implementation of the environmental monitoring and audit (EM&A) programme under the Contract, ERM-Hong Kong, Limited (ERM) has been appointed as the Environmental Team (ET). Ramboll Hong Kong Ltd. was employed by the HyD as the Independent Environmental Checker (IEC) and Environmental Project Office (ENPO) in accordance with *Environmental Permit No. EP-354/2009/A*. Further applications for variation of environmental permit (VEP), *EP-354/2009/B*, *EP-354/2009/C* and *EP-354/2009/D*, were granted on 28 January 2014, 10 December 2014 and 13 March 2015, respectively.

The southern landfall of TM-CLK Link lies alongside the Hong Kong - Zhuhai - Macao Bridge Hong Kong Boundary Crossing Facilities (HKBCF) where a reclamation area is constructed by *Contract No. HY/2010/02* under *Environmental Permit No. EP-353/2009/K* and *EP-354/2009/D*. Upon the agreement and confirmation between the Supervising Officer Representatives and Contractors of *HY/2010/02* and *HY/2012/07* in September 2015, part of the reclamation area for southern landfall under *EP-353/2009/K* and *EP-354/2009/D* was handed-over to *Contract No. HY/2012/07*. Another part of the southern landfall area under *EP-354/2009/D* was handed-over to *Contract No. HY/2012/07* after completion of reclamation works by *Contract No. HY/2010/02* in June 2016.

The construction phase of the Contract commenced on 31 October 2013 and will be tentatively completed by 2019. The impact monitoring of the EM&A programme, including air quality, noise, water quality and marine ecological monitoring as well as environmental site inspections, commenced on 31 October 2013.

This is the Seventieth Monthly EM&A report presenting the EM&A works carried out during the period from 1 to 31 August 2019 for the Southern Connection Viaduct Section in accordance with the Updated EM&A Manual of the TM-CLK Link Project. As informed by the Contractor, there are no major works to be undertaken in the monitoring period of August 2019.

A summary of monitoring and audit activities conducted in the reporting period is listed below:

24-hour TSP Monitoring 5 sessions

1-hour TSP Monitoring 5 sessions

Water Quality Monitoring 13 sessions

Noise Monitoring 5 sessions

Impact Dolphin Monitoring 2 sessions

Joint Environmental Site Inspection 4 sessions

Breaches of Action and Limit Levels for Air Quality

No exceedance of Action and Limit Levels was recorded for 1-hr TSP and 24-hr TSP for air quality monitoring in the reporting month.

Breaches of Action and Limit Levels for Noise

No exceedance of Action and Limit Levels was recorded for construction noise monitoring in the reporting month.

Breaches of Action and Limit Levels for Water Quality

A total of Twenty-three (23) Action Level exceedances and one (1) Limit Level exceedances of surface & middle-depth or bottom-depth dissolved oxygen (DO) were recorded for water quality impact monitoring in the reporting month.

Impact Dolphin Monitoring

One (1) Limit Level exceedance was observed for the quarterly dolphin monitoring data between June to August 2019, whilst no unacceptable impact from the construction activities of the TM-CLKL Southern Connection Viaduct Section on Indo-Pacific humpback dolphin *Sousa chinensis* (i.e. Chinese White Dolphin) was noticeable from general observations. Due to monthly variation in dolphin occurrence within the Study Area, it would be more appropriate to draw conclusion on whether any impacts on dolphins have been detected related to the construction activities of the TM-CLKL Southern Connection Viaduct Section in the quarterly EM&A reports, in which comparison on distribution, group size and encounter rates of dolphins between the quarterly impact monitoring period and baseline monitoring period will be made.

No marine works were undertaken during the reporting period, therefore, daily 250 m marine mammal exclusion zone monitoring was not undertaken during the reporting period.

Environmental Complaints, Non-compliance & Summons

No complaints, notification of summons or successful prosecution recorded in the reporting period.

Reporting Change

There are currently no construction works under this Contract starting in August 2019. EPD have approved the temporary suspension of Air quality

and Impact Noise Monitoring on 28 August 2019 as well as the temporary suspension of Water Quality Monitoring on 30 August 2019.

Upcoming Works for the Next Reporting Period

There are no major works to be undertaken in the next monitoring period of September 2019.

Future Key Issues

Potential environmental impacts arising from the above upcoming construction activities in the next reporting month of September 2019 is mainly associated with waste management issues.

1 INTRODUCTION

1.1 BACKGROUND

According to the findings of the Northwest New Territories (NWNT) Traffic and Infrastructure Review conducted by the Transport Department, Tuen Mun Road, Ting Kau Bridge, Lantau Link and North Lantau Highway would be operating beyond capacity after 2016. This forecast has been based on the estimated increase in cross boundary traffic, developments in the Northwest New Territories (NWNT), and possible developments in North Lantau, including the Airport developments, the Lantau Logistics Park (LLP) and the Hong Kong – Zhuhai – Macao Bridge (HZMB). In order to cope with the anticipated traffic demand, two new road sections between NWNT and North Lantau – Tuen Mun – Chek Lap Kok Link (TM-CLKL) and Tuen Mun Western Bypass (TMWB) are proposed.

An Environmental Impact Assessment (EIA) of TM-CLKL (the Project) was prepared in accordance with the EIA Study Brief (No. ESB-175/2007) and the *Technical Memorandum of the Environmental Impact Assessment Process (EIAO-TM*). The EIA Report was submitted under the Environmental Impact Assessment Ordinance (EIAO) in August 2009. Subsequent to the approval of the EIA Report (EIAO Register Number AEIAR-146/2009), an Environmental Permit (*EP-354/2009*) for TM-CLKL was granted by the Director of Environmental Protection (DEP) on 4 November 2009, and EP variation (*EP-354/2009/A*) was issued on 8 December 2010.

Under *Contract No. HY/2012/07*, Gammon Construction Limited (GCL) is commissioned by the Highways Department (HyD) to undertake the design and construction of the Southern Connection Viaduct Section of TM-CLKL ("the Contract") while AECOM Asia Company Limited was appointed by HyD as the Supervising Officer. For implementation of the environmental monitoring and audit (EM&A) programme under the Contract, ERM-Hong Kong, Limited (ERM) has been appointed as the Environmental Team (ET). Ramboll Hong Kong Ltd. was employed by HyD as the Independent Environmental Checker (IEC) and Environmental Project Office (ENPO) in accordance with *Environmental Permit No. EP-354/2009/A*. Further applications for variation of environmental permit (VEP), *EP-354/2009/B*, *EP-354/2009/C* and *EP-354/2009/D*, were granted on 28 January 2014, 10 December 2014 and 13 March 2015, respectively.

The southern landfall of TM-CLK Link lies alongside the Hong Kong - Zhuhai - Macao Bridge Hong Kong Boundary Crossing Facilities (HKBCF) where a reclamation area is constructed by *Contract No. HY/2010/02* under *Environmental Permit No. EP-353/2009/K* and *EP-354/2009/D*. Upon the agreement and confirmation between the Supervising Officer Representatives and Contractors of *HY/2010/02* and *HY/2012/07* in September 2015, part of the reclamation area for southern landfall under *EP-353/2009/K* and *EP-354/2009/D* was handed-over to *Contract No. HY/2012/07*. Another part of the

southern landfall area under *EP-354/2009/D* was handed-over to *Contract No. HY/2012/07* after completion of reclamation works by *Contract No. HY/2010/02* in June 2016.

The construction phase of the Contract commenced on 31 October 2013 and will be tentatively completed by 2019. The impact monitoring phase of the EM&A programme, including air quality, noise, water quality and marine ecological monitoring as well environmental site inspections, commenced on 31 October 2013.

The general layout plan of the Contract components is presented in *Figures 1.1* & 1.2a to 1.




1.4 SUMMARY OF CONSTRUCTION WORKS

The construction phase of the Contract commenced on 31 October 2013. The three-month rolling construction programme is shown in Appendix B. The jetty removal works and reinstatement was hand over to *Contract No.: HY/2012/08*.

As informed by the Contractor, details of there are no major works carried out in this reporting month.

The Environmental Sensitive Receivers in the vicinity of the Project are shown in *Figure 1.3*.

2 EM&A RESULTS

The EM&A programme required environmental monitoring for air quality, noise, water quality and marine ecology as well as environmental site inspections for air quality, noise, water quality, waste management, marine ecology and landscape and visual impacts. The EM&A requirements and related findings for each component are summarized in the following sections.

2.1 AIR QUALITY

2.1.1 Monitoring Requirements and Equipment

In accordance with the Updated EM&A Manual, impact 1-hour TSP monitoring was conducted three (3) times every six (6) days and impact 24-hour TSP monitoring was carried out once every six (6) days when the highest dust impact was expected. The Action and Limit Levels of the air quality monitoring is provided in *Appendix D*.

High Volume Samplers (HVSs) were used for 1-hour TSP and 24-hour TSP monitoring at ASR8A and ASR9 in accordance with the requirements of the Updated EM&A Manual. The TSP monitoring stations are illustrated in *Figure 2.1* and detailed in *Table 2.1*. Wind meter was deployed at Area 4 for logging wind speed and wind direction. Copies of the calibration certificates for the equipment are presented in *Appendix E*. Details of the deployed equipment are given in *Table 2.2*.



2.1.2 Monitoring Schedule for the Reporting Month

The schedule for air quality monitoring in August 2019 is provided in *Appendix F*. Air quality monitoring of 1-hr and 24-hr TSP at ASR9 was cancelled in August 2019 due to power shortage. There are currently no construction works under this Contract starting in August 2019. EPD have approved the temporary suspension of Air Quality Monitoring on 28 August 2019.

2.1.3 Results and Observations

The monitoring results for 1-hour TSP and 24-hour TSP are summarized in *Tables 2.3* and 2.4 respectively. Detailed impact air quality monitoring results are presented in *Appendix G*.

The major dust sources in the reporting period included construction activities under the Contract as well as nearby traffic emissions.

No exceedance of Action and Limit levels of 1-hr TSP and 24-hr TSP were recorded for air quality monitoring in the reporting month. No action is thus required to be undertaken in accordance with the Event Action Plan presented in *Appendix K*.

Meteorological information collected at ASR8A including wind speed and wind direction is provided in *Appendix H*.

2.2 Noise Monitoring

2.2.1 Monitoring Requirements and Equipment

In accordance with the Updated EM&A Manual, impact noise monitoring was conducted once per week during the construction phase of the Contract. The Action and Limit Level of the noise monitoring is provided in *Appendix D*.

Noise monitoring was performed on 6, 12, 15, 21 and 27 August 2019 using sound level meter at the designated monitoring station NSR1A (*Figure 2.2; Table 2.5*) in accordance with the requirements stipulated in the Updated EM&A Manual. Acoustic calibrator was deployed to check the sound level meters at a known sound pressure level. Details of the deployed equipment are provided in *Table 2.6*. Copies of the calibration certificates for the equipment are presented in *Appendix E*.

2.2.2 Monitoring Schedule for the Reporting Month

The schedule for construction noise monitoring in the reporting period is provided in *Appendix F*. There are currently no construction works under this Contract starting in August 2019. EPD have approved the temporary suspension of Impact Noise Monitoring on 28 August 2019.

Results for noise monitoring are summarized in *Table 2.7* and the monitoring data is provided in *Appendix I*.



Major noise sources during the noise monitoring included noise from nearby traffic noise and aircraft noise.

All noise monitoring results were below the Action and Limit Levels in the reporting period. No action is thus required to be undertaken in accordance with the Event Action Plan presented in *Appendix K*.

2.3 WATER QUALITY MONITORING

2.3.1 Monitoring Requirements and Equipment

Impact water quality monitoring was carried out to ensure that any deterioration of water quality was detected, and that timely action was taken to rectify the situation. Impact water quality monitoring was undertaken three days per week during the construction period in accordance with the Updated EM&A Manual. The Action and Limit Levels of the water quality monitoring are provided in *Appendix D*. EPD have approved the temporary suspension Water Quality Monitoring on 30 August 2019 as there are currently no marine works.



In addition to the parameters presented monitoring location/position, time, water depth, sampling depth, tidal stages, weather conditions and any special phenomena or works underway nearby were also recorded.

Water Quality Monitoring Station CS(Mf)3 was relocated to CS(Mf)3(N) since 2 May 2017.

2.3.2 Results and Observations

Results of water quality monitoring were adopted from the published EM&A data of *Contract No. HY/2012/08 Tuen Mun-Chek Lap Kok Link – Northern Connection Sub-sea Tunnel Section* ⁽¹⁾.

A total of twenty-three (23) Action Level exceedances and one (1) Limit Level exceedances of surface and middle-depth DO or bottom-depth DO were recorded for water quality impact monitoring in the reporting month. This includes twelve (12) Action Level exceedances of surface and middle-depth DO and eleven (11) Action Level exceedances bottom-depth DO and one (1) Limit level exceedance of bottom DO. There were no marine works conducted in the reporting month. The exceedance was considered not related to this Contract upon further investigation and the investigation report is presented in *Appendix M*. No action is required to be undertaken in accordance with the Event Action Plan as presented in *Appendix K*.

2.4 DOLPHIN MONITORING

2.4.1 Monitoring Requirements

Impact dolphin monitoring is required to be conducted by a qualified dolphin specialist team to evaluate whether there have been any effects on the Indo-Pacific humpback dolphin *Sousa chinensis* (i.e. Chinese White Dolphin) from the Contract. In order to fulfil the EM&A requirements and make good use of available resources, the on-going impact line transect dolphin monitoring data collected by HyD's *Contract No. HY/2011/03 Hong Kong-Zhuhai-Macao Bridge. Hong Kong Link Road - Section between Scenic Hill and Hong Kong Boundary Crossing Facilities* on the monthly basis is adopted to avoid duplicates of survey effort.

2.4.2 Monitoring Equipment

Table 2.10 summarizes the equipment used for the impact dolphin monitoring.

2.4.3 Monitoring Parameter, Frequencies and Duration


Dolphin monitoring should cover all transect lines in Northeast Lantau (NEL) and the Northwest Lantau (NWL) survey areas twice per month throughout the entire construction period. The monitoring data should be compatible with, and should be made available for, long-term studies of small cetacean ecology in Hong Kong. In order to provide a suitable long-term dataset for comparison, identical methodology and line transects employed in baseline dolphin monitoring was followed in the impact dolphin monitoring.

2.4.4 Monitoring Location

The impact dolphin monitoring was carried out in the NEL and NWL along the line transect as depicted in *Figure 2.4*. The co-ordinates of all transect lines are shown in *Table 2.11* below ⁽¹⁾.

2.4.5 Action & Limit Levels

The Action and Limit levels of dolphin impact monitoring are shown in *Appendix D*. The Event and Action plan is presented in *Appendix K*.

2.4.6 Monitoring Schedule for the Reporting Month

Dolphin monitoring was carried out 13, 14, 20, 26 and 29 August 2019 (*Appendix F*).

2.4.7 Results and Observations

A total of 263.53 km of survey effort was collected, with 100% of the total survey effort being conducted under favourable weather conditions (i.e. Beaufort Sea State 3 or below with good visibility) during the surveys in August 2019. Among the two areas, 94.63 km and 168.90 km of survey effort were collected from NEL and NWL survey areas, respectively. The total survey effort conducted on primary and secondary lines were 195.51 km and 68.02 km, respectively. The northern end of transect no .24 was not travelled during the first set of survey due to safety reasons. The survey efforts are summarized in *Appendix J*.

No Chinese White Dolphin was sighted during the two sets of monitoring surveys in August 2019.

Encounter rates of Chinese White Dolphins are deduced from the survey effort and on-effort sighting data made under favourable conditions (Beaufort 3 or below) in August 2019 are shown in *Tables 2.12 & 2.13*.

One (1) Limit Level exceedance was observed for the quarterly dolphin monitoring data between June to August 2019, whilst no unacceptable impact from the construction activities of the TM-CLKL Southern Connection Viaduct Section on Indo-Pacific humpback dolphin *Sousa chinensis* (i.e. Chinese White Dolphin) was noticeable from general observations. Due to monthly variation in dolphin occurrence within the Study Area, it would be more appropriate to draw conclusion on whether any impacts on dolphins have been detected related to the construction activities of the TM-CLKL Southern Connection Viaduct Section in the quarterly EM&A reports, in which comparison on distribution, group size and encounter rates of dolphins between the quarterly impact monitoring period and baseline monitoring period will be made.

2.4.8 Marine Mammal Exclusion Zone Monitoring

No marine works were undertaken during the reporting period, therefore, daily 250 m marine mammal exclusion zone monitoring was not undertaken during the reporting period.

Passive Acoustic Monitoring (PAM) had been decommissioned as no marine piling works was carried out outside the daylight hours since September 2015.

2.5 EM&A SITE INSPECTION

Site inspections were carried out on a weekly basis to monitor the implementation of proper environmental pollution control and mitigation measures under the Contract. In the reporting month, four (4) site inspections were carried out on 7, 15, 22 and 29 August 2019.

Key observations during the site inspections are summarized in *Table 2.14*.

2.6 WASTE MANAGEMENT STATUS

The Contractor has submitted application form for registration as chemical waste producer under the Contract. Sufficient numbers of receptacles were available for general refuse collection and sorting.

Wastes generated during this reporting period include mainly construction wastes (inert and non-inert) and recyclable materials. Reference has been made to the waste flow table prepared by the Contractor (*Appendix L*). The quantities of different types of wastes are summarized in *Table 2.15*.

For chemical waste containers, the Contractor was reminded to treat properly and store temporarily in designated chemical waste storage area on site in accordance with the *Code of Practice on the Packaging, Labelling and Storage of Chemical Wastes*.

2.8 IMPLEMENTATION STATUS OF ENVIRONMENTAL MITIGATION MEASURES

In response to the site audit findings, the Contractors carried out corrective actions.

A summary of the Implementation Schedule of Environmental Mitigation Measures (EMIS) is presented in *Appendix C*. The necessary mitigation measures were implemented properly for this Contract.

The landscape and visual (L&V) mitigation measures were also monitored on weekly basis in the reporting period. The monitoring status is summarized in *Appendix C*.

2.9 SUMMARY OF EXCEEDANCES OF THE ENVIRONMENTAL QUALITY PERFORMANCE LIMIT

A total of twenty-three (23) Action Level exceedances and one (1) Limit Level exceedances of surface and middle-depth DO or bottom-depth DO were recorded for water quality impact monitoring in the reporting month. This includes twelve (12) Action Level exceedances of surface and middle-depth DO and eleven (11) Action Level exceedances bottom-depth DO and one (1) Limit level exceedance of bottom DO.

Results for air quality and impact noise monitoring complied with the Action/Limit levels in the reporting period.

Cumulative statistics on exceedances is provided in *Appendix M*.


2.10 SUMMARY OF COMPLAINTS, NOTIFICATION OF SUMMONS AND SUCCESSFUL PROSECUTIONS

3 FUTURE KEY ISSUES

3.1 CONSTRUCTION PROGRAMME FOR THE COMING MONTH

As informed by the Contractor, there are no major works to be undertaken in the next monitoring period of September 2019.

3.2 KEY ISSUES FOR THE COMING MONTH

Potential environmental impacts arising from the above upcoming construction activities in the next reporting month of September 2019 is mainly associated with waste management issues.

3.3 MONITORING SCHEDULE FOR THE COMING MONTH

The tentative schedules for environmental monitoring in September 2019 are provided in *Appendix F*.

4 CONCLUSIONS AND RECOMMENDATIONS

4.1 CONCLUSIONS

This Seventieth Monthly EM&A Report presents the findings of the EM&A activities undertaken during the period from 1 to 31 August 2019 in accordance with the Updated EM&A Manual and the requirements of the Environmental Permits (*EP-354/2009/D* and *EP-353/2009/K*).

Air quality (1-hour TSP and 24-hour TSP) noise, water quality monitoring (DO, turbidity and SS) and dolphin monitoring were carried out in the reporting month. A total of twenty-three (23) Action Level exceedances and one (1) Limit Level exceedances of surface and middle-depth DO or bottom-depth DO were recorded for water quality impact monitoring in the reporting month. This includes twelve (12) Action Level exceedances of surface and middle-depth DO and eleven (11) Action Level exceedances bottom-depth DO and one (1) Limit level exceedance of bottom DO. Results of air quality monitoring and impact noise monitoring complied with the Action and Limit levels in the reporting period.

No Chinese White Dolphins was sighted during the two sets of monitoring surveys in August 2019. One (1) Limit Level exceedance was observed for the quarterly dolphin monitoring data between June to August 2019, whilst no unacceptable impact from the construction activities of the TM-CLKL Southern Connection Viaduct Section on Indo-Pacific humpback dolphin *Sousa chinensis* (i.e. Chinese White Dolphin) was noticeable from general observations.


Environmental site inspection was carried out four (4) times in August 2019. Recommendations on remedial actions were given to the Contractor for the deficiencies identified during the site audits.

There was no complaint, notification of summons or successful prosecution recorded in the reporting period.

The ET will keep track on the construction works to confirm compliance of environmental requirements and the proper implementation of all necessary mitigation measures.






Figure 1. Transect Line Layout in Northwest and Northeast Lantau Survey Areas




Figure 2. Survey Route on August 13th, 2019 (from HKLR03 project)




Figure 3. Survey Route on August 14th, 2019 (from HKLR03 project)




Figure 4. Survey Route on August 20th, 2019 (from HKLR03 project)




Figure 5. Survey Route on August 26th, 2019 (from HKLR03 project)




Figure 6. Survey Route on August 29th, 2019 (from HKLR03 project)







The stratification of seawater in the water column is likely a contributing factor to the results of lower levels of DO at the bottom level. 
