## **1 INTRODUCTION**

### **1.1 Project Background**

1.1.1 Pursuant to the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (DEP) granted an environmental permit (No. EP-441/2012) to the Castle Peak Power Company Limited (CAPCO) on 23 July 2012 to construct and operate the designated project for Enhanced Ash Utilisation and Water Management Facilities at Castle Peak Power Station (hereinafter referred to as “the Project”). An application for variation of environmental permit (VEP) was subsequently made and the revised EP (No: EP-441/2012/A) was issued by DEP on 29 June 2018.

1.1.2 CAPCO appointed AECOM Asia Company Limited (AECOM) as the Independent Checker (IC) to undertake environmental audit work for the Project. Yee Hop Engineering Company Limited is the Contractor for construction of Ash Silo, while Guangxi Electric Power Design Institute Company Limited is the Contractor for the enhancement works of Water Management Facilities.

### **1.2 Purpose of the Report**

1.2.1 Under the EP Condition 2.3, the audit for the implementation of all mitigation measures recommended in the Project Profile (Register No. PP-468/2012) commenced in November 2019. This is the Nineteenth Monthly Audit Report which summarises the audit findings for the Project during the reporting period from 1 to 31 May 2021.

## 2 PROJECT INFORMATION

### 2.1 Site Description

2.1.1 The Project site is located within the boundary of the existing Castle Peak Power Station (CPPS). The locations of the key project components are shown in **Appendix A**.

### 2.2 Construction Programme and Activities

2.2.1 The major construction activities of the Project undertaken in the reporting month includes:

#### Ash Silo Construction Works

- Installation of Silo superstructure;
- Scaffold erection; and
- Installation of Silo cone and body.

#### Water Management facilities Enhancement Works

- (i) Plant House of Process Water Recycling Facility
  - Erect scaffolding, formwork, rebar fixing of wall & column for Water Tank Area;
  - Pour concrete of cantilever slab & wall of water tank; and
  - Erect scaffold of Plant Room.
- (ii) Process Water Tank and the associated works
  - Setting and welding of shell plates;
  - Setting and welding of bound angle steel; and
  - Setting and welding work of centre support ring.
- (iii) Water Management Facilities
  - Pipeline and support design work; and
  - Pipe support fabrication (off-site).
- (iv) Partial De-commissioning of West Coal Stockyard / West Coal Store
  - Pouring concrete of blinding layer for retaining wall foundation;
  - Excavation to formation level of retaining wall; and
  - Erect formwork for retaining wall.
- (v) Drainage modification works
  - Excavate trench for drainage work;
  - Break up cable duct concrete-surround at manhole;
  - Pouring concrete and erect formwork for manhole.
- (vi) All related works
  - Installation of rotary disc.

2.2.2 The major construction activities for the coming month includes:

#### Ash Silo Construction Works

- Installation of superstructure;
- Scaffold erection;
- Cladding works; and
- Staircase installation.

Water Management Facilities Enhancement Works

- (i) Plant House of Process Water Recycling Facility
  - Pour concrete for wall and top slab (upper);
  - Pour concrete for mass concrete fill at G/F; and
  - Equipment delivery for process water equipment.
- (ii) Process Water Tank and the associated works
  - Installation of Truss.
- (iii) Water Management Facilities
  - Civil works (concrete support, excavation); and
  - Pipeline work.
- (iv) Partial De-commissioning of West Coal Stockyard / West Coal Store
  - Excavation to formation level of retaining wall;
  - Blinding;
  - Concreting of base slab; and
  - Concreting of wall.
- (v) Drainage modification works
  - Installation of pipe piles.
- (vi) All related works
  - Complete Installation of rotary disc.

2.2.3 The construction programmes for the above-mentioned construction / enhancement works are presented in **Appendix B**.

### 3 ENVIRONMENTAL SITE INSPECTION

#### 3.1 Environmental Site Inspection

- 3.1.1 Site inspections were carried out by the IC on a bi-weekly basis to monitor the implementation of mitigation measures for the Project.
- 3.1.2 In the reporting month, the site inspections were carried out jointly with the Contractor on 14 and 25 May 2021, respectively. No non-compliance was recorded during the site inspections. Findings and recommendations for the site inspections are summarised below. Details of observations recorded during the site inspections are presented in **Appendix C**.

##### Ash Silo Construction Works

- 14 May 2021
  - Blockage of drainage system observed. The Contractor was advised to remove the blockage for preventing stagnant water.
- 25 May 2021
  - No specific observation was identified in this inspection.

##### Water Management facilities Enhancement Works

- 14 May 2021
  - No specific observation was identified in this inspection.
- 25 May 2021
  - Improper (size and colour) NRMM label affixed on the crane was observed. The Contractor was advised to replace a proper NRMM label for the cane used onsite.
  - Excavator emitted dark smoke continuously was observed. The Contractor was advised to provide maintenance to the smoking excavator.

- 3.1.3 All follow-up actions requested by the IC during the site inspections were taken as reported by the Contractor and confirmed by the IC in the subsequent site inspections. There was no follow-up action outstanding at the time of preparing this report.



#### **4 IMPLEMENTATION STATUS OF ENVIRONMENTAL MITIGATION MEASURES**

- 4.1.1 The Contractor has implemented all the relevant environmental mitigation measures as recommended in the Project Profile. The implementation status of the environmental mitigation measures during the reporting period is summarised in **Appendix D**.

#### **5 CONCLUSION**

- 5.1.1 Two environmental site inspections were carried out for the Project in the reporting month of May 2021. No non-compliance was recorded during the site inspections. Based on the observations during the site inspections, the Contractor has implemented all the relevant environmental mitigation measures as recommended in the Project Profile (Register No. PP-468/2012).
- 5.1.1 Referring to the information provided by the Contractor, no complaint, notification of summons and successful prosecution was received in the reporting month.

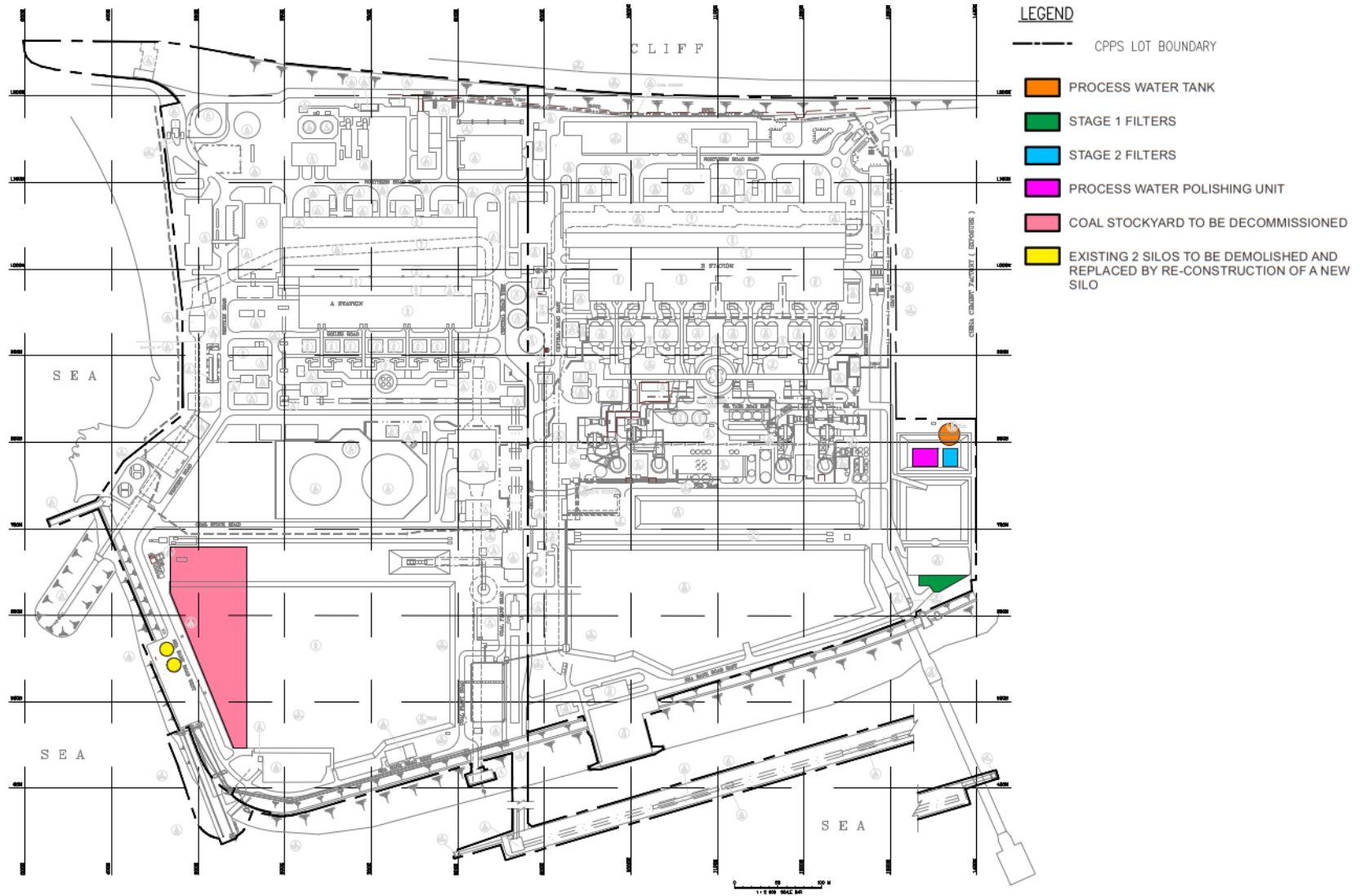

# Appendix A Layout Plan of 2017 Scheme



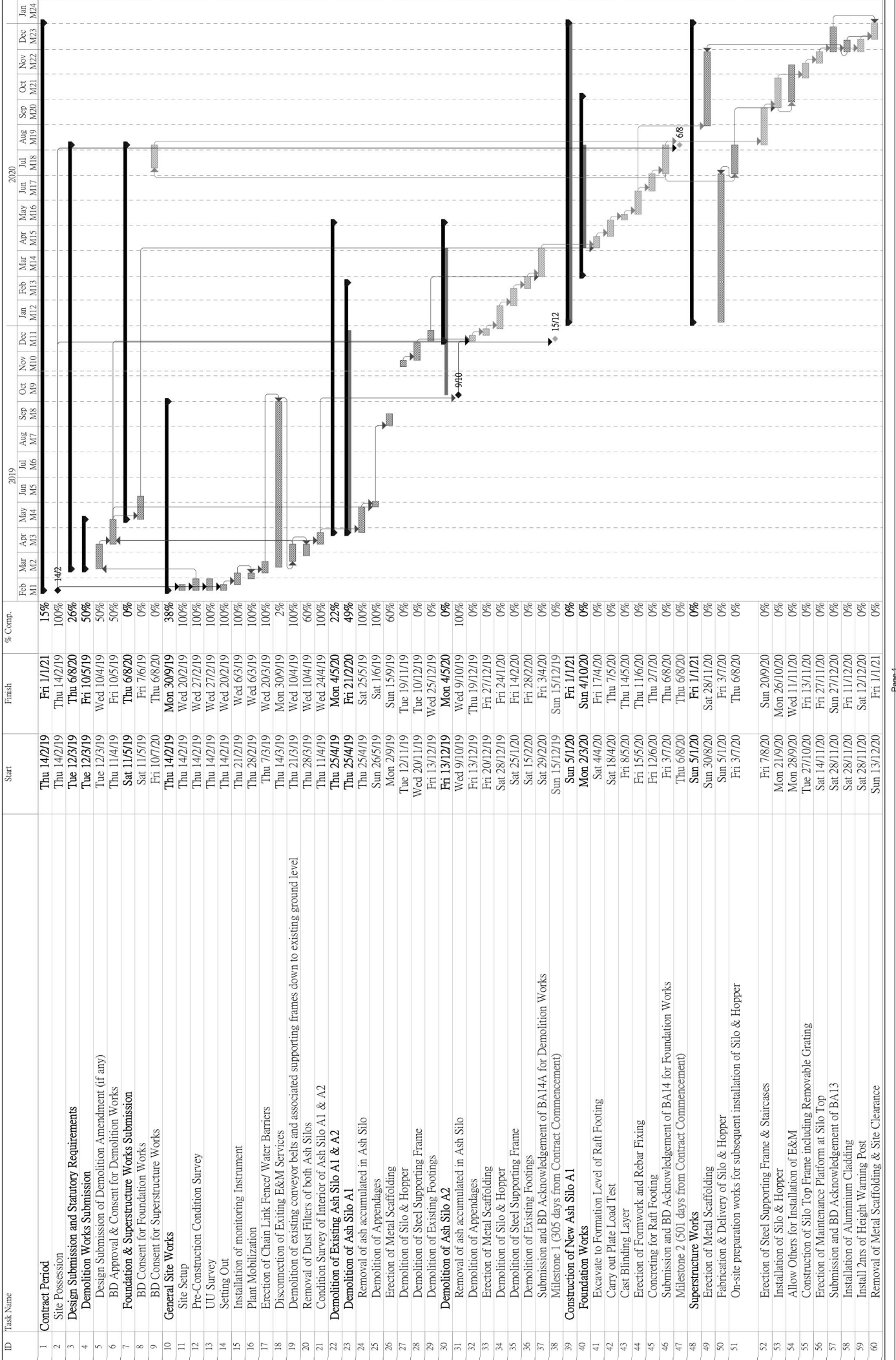
