1 INTRODUCTION

1.1 Project Background

- 1.1.1 Pursuant to the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (DEP) granted an environmental permit (No. EP-441/2012) to the Castle Peak Power Company Limited (CAPCO) on 23 July 2012 to construct and operate the designated project for Enhanced Ash Utilisation and Water Management Facilities at Castle Peak Power Station (hereinafter referred to as "the Project"). An application for variation of environmental permit (VEP) was subsequently made and the revised EP (No: EP-441/2012/A) was issued by DEP on 29 June 2018.
- 1.1.2 CAPCO appointed AECOM Asia Company Limited (AECOM) as the Independent Checker (IC) to undertake environmental audit work for the Project. Yee Hop Engineering Company Limited is the Contractor for construction of Ash Silo, while Guangxi Electric Power Design Institute Company Limited is the Contractor for the enhancement works of Water Management Facilities. The civil construction works of Ash Silo were completed by Yee Hop in December 2021. The construction of Ash Silo was handed over to Kum Shing E&M Limited for the E&M works in January 2022.

1.2 Purpose of the Report

1.2.1 Under the EP Condition 2.3, the audit for the implementation of all mitigation measures recommended in the Project Profile (Register No. PP-468/2012) commenced in November 2019. This is the Twenty-eighth Monthly Audit Report which summarises the audit findings for the Project during the reporting period from 1 to 28 February 2022.

2 **PROJECT INFORMATION**

2.1 Site Description

2.1.1 The Project site is located within the boundary of the existing Castle Peak Power Station (CPPS). The locations of the key project components are shown in **Appendix A**.

2.2 Construction Programme and Activities

2.2.1 The major construction activities of the Project undertaken in the reporting month includes:

Ash Silo – E&M Works

- Electrical board installation and cable pulling;
- Pipe hanger supporting installation;
- Filter house installation at Silo Roof;
- Transition modification at Silo Roof; and
- Scaffolding work.

Water Management Facilities Enhancement Works

 - Steel stairs installation work;
 - DG store steel frame work;
 - Equipment installation;
 - Stainless steel pipe welding work;
 - Cable and electrical work; and
 - Water tank component installation.
- (ii) Process Water Tank
 - Internal and external coating work.
- (iii) Water Management Facilities
 - Pipeline works;
 - Pipeline support foundation work;
 - Pump foundation and pump Installation work; and
 - Cable work.
- (iv) West Coal Store
 - Perimeter Drain
 - Concrete for Bay Wall and Bay Layer
- (v) Drainage Modification Works
 - Sump Pits construct work; and
 - Transformation foundation.
- (vi) Others
 - Lagoon cleaning;
 - MVR insulation repair work; and
 - Existing pipe unblock work.

3 ENVIRONMENTAL SITE INSPECTION

3.1 Environmental Site Inspection

- 3.1.1 Site inspections were carried out by the IC on a bi-weekly basis to monitor the implementation of mitigation measures for the Project.
- 3.1.2 In the reporting month, the site inspections were carried out jointly with the Contractor on 10 and 22 February 2022, respectively. No non-compliance was recorded during the site inspections. Findings and recommendations for the site inspections are summarised below. Details of observations recorded during the site inspections are presented in **Appendix C**.

Ash Silo E&M Works

- 10 February 2022
 - No specific observation was identified in this inspection.
- 22 February 2022
 - No specific observation was identified in this inspection.

Water Management facilities Enhancement Works

- 10 February 2022
 - No specific observation was identified in this inspection.
- 22 February 2022
 - Silt was observed at the works area near to the site entrance. The Contractor was advised to provide cleaning after construction works conducted on site so as to prevent any silt from leaking from the construction site.
- 3.1.3 All follow-up actions requested by the IC during the site inspections were taken as reported by the Contractor and confirmed by the IC in the subsequent site inspections. There was no follow-up action outstanding at the time of preparing this report.

4 IMPLEMENTATION STATUS OF ENVIRONMENTAL MITIGATION MEASURES

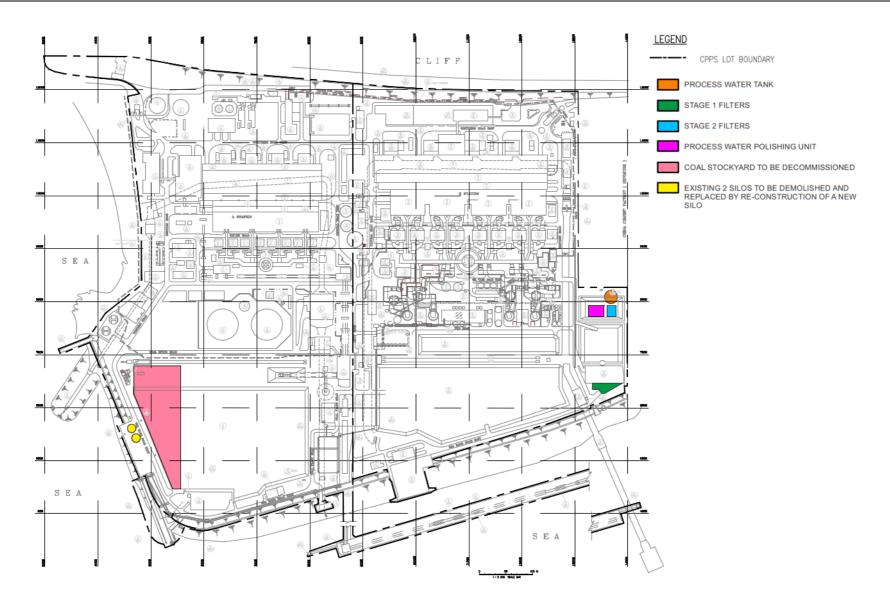

- 5.1.1 Referring to the information provided by the Contractor, no complaint, notification of summons and successful prosecution was received in the reporting month.
