**PFC Paper No. 3/2016**

**Construction and Demolition Material Management Plan (C&DMMP) for  
Hung Shui Kiu New Development Area**


I refer to your submission of the proposed C&DMMP for Hung Shui Kiu New Development Area (NDA).

2. Subsequent to the circulation of the C&DMMP via PFC Paper No. 3/2016 on 27 June 2016, comments were received from PFC Members. Your response to the comments and the revised pages of the C&DMMP were circulated to PFC Members via PFC Paper No. 3/2016 (Rev. A) on 19 July 2016. PFC Members have no further comments and endorsed PFC paper No. 3/2016 (Rev. A), except AD(WM) of EPD has further comments but endorsed the C&DMMP subject to conditions.

3. I am pleased to advise you that, in accordance with the Project Administration Handbook (PAH) Chapter 4 Section 4.1.3, the C&DMMP for Hung Shui Kiu New Development Area as detailed in PFC Paper No. 3/2016 and the revised pages attached to PFC Paper No. 3/2016 (Rev. A) have been endorsed in principle by PFC subject to the following conditions:

- (a) The Project Proponent should resolve the uncertainties and requirements identified in the assessment section of PFC Paper No. 3/2016 (Rev. A).
- (b) The Project Proponent should enhance local matching with both public and private construction projects with a view to minimizing double handling of the public fill via the fill banks.
- (c) The Project Proponent shall set up effective control procedures to ensure the traceability of disposal and reuse of the C&D materials.

- (d) The Project Proponent should strive to implement the measures detailed in the proposed C&DMMP to reuse the non-inert materials as far as possible for minimizing burden on the landfills and explore other enhancement measures where practicably feasible at later design stages. The Project Proponent may wish to refer to DEVB's "Guidelines on Yard Waste Reduction and Treatment" and consider implementing measures on vegetation waste reduction and treatment in various stages of the project.
- (e) The Project Proponent should adopt re-usable non-timber formwork and precast concrete construction as far as practicable.
- (f) The Project Proponent shall report the progress of the above works in the form of quarterly situation reports to be submitted to the Secretary of PFC.
