 - (a) where the said person is a firm, company or other body of persons, whether corporate or unincorporate:
 - (i) the applicant is a shareholder of the said person, or vice versa;
 - (ii) the applicant is an owner of the said person, or vice versa;
 - (iii) the applicant is a partner of the said person;
 - (iv) the applicant is a director or principal officer of the said person;
 - (v) the applicant is an employee of the said person; or
 - (vi) the applicant is an associated corporation of the said person (that is, the applicant is a corporation over which the said person has control; or a corporation which has control over the said person; or a corporation which is under the control of the same person as is the said person), or vice versa;
 - (b) where the said person is a natural person:
 - (i) the said person is an employee of the applicant, or vice versa;
 - (ii) the said person is a director or principal officer of the applicant;
 - (iii) the said person is a partner of the applicant;
 - (iv) the said person is a shareholder of the applicant; or
 - (v) the said person is an owner of the applicant.
