WASTE DISPOSAL ORDINANCE (AMENDMENT OF FOURTH
SCHEDULES) NOTICE 1994

(Made by the Governor in Council under section 37 of the Waste
Disposal Ordinance (Cap. 354))

1. Exempt Persons

The Fourth Schedule to the Waste Disposal Ordinance (Cap. 354)
is amended -

(a) in item 7 -

(i) by adding "or livestock waste restriction
area" after "prohibition area";

(ii) by repealing "10" and substituting "20";

(b) in item 8, by repealing "10" and substituting "20";

(c) by adding -

"9. The Director of Agriculture and Fisheries.

10. The Director of Urban Services.

11. The Director of Regional Services.

12. Any person who holds a valid licence or
permit granted under the Public Health
(Animals and Birds) Ordinance (Cap. 139) in
respect of holding of exhibition of animals
or birds.

13. Any person who owns or manages a park for public access in which livestock is kept solely for the purpose of exhibition to which the public are admitted, whether on payment or not.

14. Any person who owns or manages a school or other educational institution providing kindergarten, primary, secondary, post-secondary or tertiary education in which livestock is kept for the purpose of education."

2. Livestock Waste Restriction Areas

The Fifth Schedule is repealed and the following substituted -

3. Those parts of Tsuen Wan and Kwai Chung districts delineated on 2 maps dated [] numbered LW/50/1 (Edition 3) and LW/50/2 (Edition 3) described as "PART OF TSUEN WAN AREA" and identified by the number 13R thereon. 1 July 1994

4. That part of Tuen Mun district delineated on 1 map dated [] numbered LW/50/2 (Edition 3) described as "PART OF TUEN MUN AREA" and identified by the number 14R thereon. 1 July 1994

5. That part of Yuen Long district delineated on a map dated [] numbered LW/50/2 (Edition 3) described as "PART OF YUEN LONG AREA" and identified by the number 16R thereon. 1 July 1994

Explanatory Note

Section 1 of this Notice amends the Fourth Schedules of the Waste Disposal Ordinance (Cap. 354) to include more persons in the list of exempt persons for the purpose of keeping livestock in a prohibition, restriction or control area.

2. Section 2 further delineates the areas which are included in the livestock waste restriction areas.
