## Hong Kong Biodiversity Strategy and Action Plan 2016-2021 Progress of Implementation

### **Background Note**

### **PURPOSE**

This paper provides background information to the "Hong Kong Biodiversity Strategy and Action Plan (BSAP) 2016-2021 - Progress of Implementation" (*ACE Paper 4/2020*) prepared by the Environment Bureau (ENB) and Agricultural, Fisheries and Conservation Department (AFCD) for discussion at the Advisory Council on the Environment (ACE) meeting on 11 May 2020.

### **BACKGROUND**

- 2. In December 2016, the Government launched the first city-level Biodiversity Strategy and Action Plan (BSAP) for Hong Kong that outlined the strategy and actions to be taken in the next five years for conserving local biodiversity and supporting sustainable development. Members were briefed at the ACE meeting held on 13 March 2017 on the key components of the BSAP and the role that the Nature Conservation Sub-committee (NCSC) of the ACE could play in the implementation of BSAP. As agreed at the ACE meeting, an information paper (ACE Paper 16/2017) was issued by ENB and AFCD in June 2017 to provide supplementary information on the roles and involvement of the ACE and NCSC on the implementation of the BSAP. It was also agreed that AFCD would report the progress of BSAP implementation to the ACE on an annual basis, and consult ACE on strategic issues related to the BSAP implementation with wider implication when necessary.
- 3. The last progress report on the implementation of BSAP was presented to the ACE on 4 March 2019. Members were in general satisfied with the progress and provided their suggestions with regard to the presentation of data, measurement of effectiveness, promotion of public awareness and community involvement, engagement of stakeholders, etc.
