Enhancement of the Plastic Shopping Bag Charging Scheme and the Plan on the Control of Single-use Plastics

Background Note

PURPOSE

This paper provides background information on the "Enhancement of the Plastic Shopping Bag Charging Scheme and the Plan on the Control of Single-use Plastics" (*ACE Paper 4/2022*) prepared by the Environmental Protection Department for discussion at the Advisory Council on the Environment (ACE) meeting on 16 May 2022.

BACKGROUND

2. The Council for Sustainable Development (SDC) conducted a public engagement from September to December 2021 on the control of single-use plastics to gauge the views of the public on the possible ways to gradually control nonessential and hard-to-recycle single-use plastic items. In April 2022, the SDC submitted a report with 24 recommendations in five key areas to the Government for consideration. The Government has put forward a work plan to follow up on the SDC's recommendations, which included the enhancement of the Plastic Shopping Bag Charging Scheme and various control measures on hard-to-recycle and non-essential single-use plastic products.

3. The ACE had been consulted on the control of various single-use plastic products in the past and Members had provided valuable comments and suggestions at meetings. The relevant papers and minutes of the meetings are appended below for reference -
