Communication, Education, Participation and Awareness (CEPA) Programme of Hong Kong Wetland Park

Purpose

This paper informs Members the communication, education, participation and awareness (CEPA) programmes organised by the Hong Kong Wetland Park (HKWP). Members' comments on the CEPA programme of HKWP for the year 2010-11 are also sought.

Background

- 2. CEPA programme has been widely adopted by Contracting Parties of the Ramsar Convention as one of the key components for conservation and wise use of wetlands. It also provides means to develop networks, partnership and support knowledge sharing and capacity building.
- 3. The first Ramsar Resolution on CEPA was adopted at the 7th Meeting of the Conference of the Contracting Parties (COP7) to the Ramsar Convention in 1999. The Resolution called for a concerted programme of education and public awareness to increase the knowledge and understanding of wetland values and benefits and to develop action plans towards the conservation and sustainable management of wetland resources.
- 4. At COP10 to the Convention in 2008, CEPA programme was further improved and elaborated as 'communication, education, participation and awareness' programme with a view to including community participation and education in the programme. The COP10 Resolution on CEPA urged all contracting parties to develop a CEPA action plan as integrated components of their broader environment, biodiversity and education at decentralized level to ensure that CEPA is widely recognized by the community. The Government of HKSAR delivers its obligations with regard to CEPA under the Ramsar Convention primarily through implementation of CEPA programme in HKWP.

CEPA Programme of HKWP

Objectives

- 5. One of the objectives of HKWP is to provide opportunities for education and public awareness on wetland conservation. Since its opening in May 2006, HKWP has implemented a series of CEPA programmes to achieve the objective. The CEPA programme of HKWP aims:
 - (a) to promote understanding of the wise use of wetlands and wetland biodiversity in Hong Kong;
 - (b) to organise education programmes on wetland conservation for schools and the general public;
 - (c) to build up public support and develop capacity of the general public for wetland conservation; and
 - (d) to support the Wetland Link International-Asia network for better implementation of CEPA programmes across Asia.
- 6. The CEPA programme of HKWP is in line with the key result areas of CEPA programme under the Ramsar Convention, in particular to help people understand the values of wetlands so that they are motivated to support conservation of wetlands. Details of the operation objectives of HKWP CEPA programme corresponding to the key result areas of Ramsar's CEPA programme are at **Annex 1**.

Education Programme

- 7. HKWP produced a wide range of education materials which provided easy-to-use practical tools for teachers to organise school curricula, and serve as references to students in their project studies. The education materials included teaching kits, fact sheets, pamphlets, posters, field guides, exhibition panels, newsletters, e-newsletters and thematic websites. These materials are available for download from the website of HKWP.
- 8. HKWP organised school and public education programmes on wetland conservation for students and the general public. School education programmes of HKWP included thematic lectures and guided tours in the Park, as well as outreach programme to secondary schools, primary schools and kindergartens. The programmes aimed to increase the scope of school curricula to cover issues related to wetland and biodiversity conservation. In 2009-10, over 950 school

education activities were organised for 48,500 students and teachers.

- 9. In order to raise public awareness about wetland conservation and promote long-term changes in attitudes and behaviour of the general public, HKWP organised over 6,800 public education activities (e.g. guided interpretation, workshops and public lectures) for 102,500 participants from the general public in 2009-10.
- 10. Apart from the above programmes, HKWP also organised other public events to foster public awareness on conservation of wetlands and its associated plants and animals. Schools, tertiary education institutes, green groups and local communities were involved in organising the events. In 2009-10, a series of public events attracting 57,000 participants were organised. Details of the education programmes and public events organised by HKWP are at **Annex 2**.

Volunteer Programme

11. Since its opening in May 2006, HKWP has recruited over 5,800 individuals and 129 groups as HKWP volunteers. The volunteers received training on identification of wetland plants and animals, skills of interpretation and habitat management. In return, the volunteers provided services in HKWP by leading guided interpretation and conducting habitat management work such as tree planting and weeding in the outdoor reserve area. In 2009-10, HKWP volunteers provided over 6,500 service man-days in the Park.

Partnership Programme

- 12. HKWP developed collaborative partnerships with schools, tertiary education institutes, NGOs and corporations to promote long-term involvement of local communities in wetland conservation.
- 13. Services provided by the partners included leading guided interpretation and workshops, supporting visitor services and crowd control, and conducting ecological monitoring and habitat management work in HKWP. Some corporations also sponsored visits of the disadvantaged groups to HKWP and provided staff to guide the visits. In 2009-10, a total of 147 tours were organised for 4,864 people in need. Details of the partnership programme in 2009/10 are at **Annex 3**.

Wetland Link International (WLI)-Asia Network

14. The CEPA programme under the Ramsar Convention encourages the establishment of "Wetland Education Centres" as the key places of learning and

training about wetlands and wetland-related CEPA, and it has identified the Wetland Link International (WLI) programme of the Wildfowl and Wetlands Trust (WWT), UK as the key organisation to develop this area of CEPA programme.

- 15. Wetland Link International—Asia (WLI-Asia) was launched in 2005 in HKWP. At present, WLI-Asia has 37 members of wetland centres from 15 countries / places in the Asian region. HKWP has been a core member of WLI-Asia. In January 2007, HKWP supported coordination of the first WLI-Asia Symposium in HKWP. In the same year, HKWP launched the WLI-Asia website at www.wli-asia.org to facilitate communication on CEPA activities and resource development among wetland centres in the region. In April 2008, 12 wetland centres from 9 countries / places attended the "WLI-Asia Inter-school Education Programme" organised by HKWP to share the results of their project studies on conservation and wise use of wetlands.
- 16. In 2008-09, HKWP developed twin centres relationship with the Sungei Buloh Wetland Reserve in Singapore to facilitate exchange of experience and information. A student exchange programme was organised to support exchange visits between secondary schools in Hong Kong and Singapore.
- 17. The third WLI-Asia Symposium will be organised at the Paya Indah Wetlands in Malaysia between 22 and 25 November 2010. In the Symposium, HKWP will share with other Asian wetland centres its experience of organising CEPA programmes in Hong Kong.

CEPA Programme of HKWP for the Year 2010-11

Education Programme

- 18. A new education programme "Learning at Wetlands" has been developed for the New Senior Secondary (NSS) Curriculum. It aims to facilitate students to achieve "Independent Enquiries Study (IES)" and "Other Learning Experience (OLE)" of the Curriculum. In the programme, students can apply skills of "community services" in the real environment, and acquire "career-related experiences" through job shadowing such as conducting water quality tests and habitat management work.
- 19. In addition to the existing education kit covering 54 topics on wetland conservation and ecology targeting at teachers and students of the upper primary and lower secondary schools, HKWP is developing a new education kit on liberal

studies for senior secondary school students taking the NSS Curriculum. The new kit will cover topics on rivers and streams, wetlands and tourism, use of wetlands, wetlands and climate change, etc.

Public Events

Bird Watching Festival 2010

- 20. Mai Po and Inner Deep Bay area is an important over-wintering site and refueling station for waterbirds, including the globally threatened species Black-faced Spoonbill, Eurasian Curlew and Baikal Teal. To celebrate the 15th anniversary of its designation as a Ramsar Site on 4 September 1995, HKWP will organise a public seminar on conservation of birds and wetlands in Hong Kong on 6 November 2010. There will also be a kick-off ceremony of the Bird Watching Festival on the same day, and a "Birds and Wetlands" Funfair will be organised on 6 and 7 November 2010 to raise public awareness.
- 21. A series of CEPA activities will be organised upon the inauguration of Bird Watching Festival. The activities will include training classes on bird watching for the general public, the 11th Inter-school Bird Race for secondary schools, and collection of snapshots and paper tole artwork on birds.
- 22. With the support of HSBC Corporation Limited, HKWP will organise an overseas study tour in early 2011 for the winning teams of the 11th Inter-school Bird Race. The students will visit wetland reserves in Singapore and will have the opportunity to work with staff, students and volunteers in the Sungei Buloh Wetland Reserve.

World Wetlands Day 2011

- 23. Among the CEPA activities organized worldwide, the World Wetlands Day (WWD) is one of the most important as it commemorates the signing of the Ramsar Convention in Ramsar, Iran on 2 February 1971. On every 2 February, Contracting Parties from all over the world would celebrate this meaningful day with a view to raising public awareness of wetland values and inviting public participation in wetland conservation.
- 24. Each WWD promotes the conservation of wetlands under a specific theme promulgated by the Ramsar Secretariat, and "Wetlands and Forests" will be the theme for WWD 2011. To celebrate the 40th anniversary of the Ramsar Convention, HKWP will adopt the theme "Wetlands and Forests" for production of a thematic exhibition for display in HKWP in January and February 2011. The 5th Storytelling Competition for kindergartens and primary schools to be

organised in January 2011 and a musical drama to be produced and shown in HKWP in early February 2011 will also adopt "Wetlands and Forests" as the theme. To conclude the celebration, a ceremony cum prize presentation will be organised on 29 January 2011.
