Submission of tenders : (For paper-based tendering) Each Tender and all accompanying documents must be completed, signed in EIGHT identical copies (one original and seven copies) and enclosed in a sealed plain envelope marked “Tender for Contract EP/SP/308/24 - Provision of Services for Setting up and Operation of Recycling Stores in Public Rental Housing Estates in Tung Chung – Yat Tung (2) Estate and Ying Tung Estate (Tender Ref. WRR24001)” or “Tender for Contract EP/SP/309/24 - Provision of Services for Setting up and Operation of Recycling Stores in Public Rental Housing Estates in Kwun Tong – Choi Tak Estate, Upper Ngau Tau Kok Estate and Choi Ying Estate (Tender Ref. WRR24001)” (without bearing any indication which may relate the tender to the tenderer), addressed to the Chairman, Tender Opening Committee, Government Logistics Department and deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12:00 noon (Hong Kong Time) on 24 May 2024 (“tender closing time”). Tenders must be deposited in the tender box as specified in this tender notice (“Specified Tender Box”) before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

(For electronic tendering) Each Tender shall be submitted in accordance with the requirements specified in the tender documents, the terms and conditions of use and participation of the ETB (<https://pcms2.gld.gov.hk>)

In the event that tropical cyclone signal No. 8 or above or a black rainstorm warning signal is in effect or “extreme conditions after super typhoons” announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on 24 May 2024, the tender closing time will be postponed to 12:00 noon on the first working day after the tropical cyclone signal No. 8 is lowered or the black rainstorm signal or “extreme conditions after super typhoons” announced by the Government has ceased to be in effect. In case of blockage of the public access to the location of the Government Logistics Department Tender Box at any time between 9:00 a.m. and 12:00 noon on 24 May 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Remarks : 1. Open tendering is adopted. The qualifications/conditions for participation and other tender requirements are stipulated in the Terms of Tender in the Tender Documents.

2. This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or, as the assessment of the tenders is based on a marking scheme, the tender has the highest combined score of price offer and technical proposal.

4. The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any tenderer about the terms of the offer.
