Guidance Notes for Completing Notification Form (EPD 311N) for Regulated Architectural Paints

- The notification form (EPD 311N) is developed by the Authority to facilitate importers and local
 manufacturers of the regulated architectural paints to notify the Authority about the information of an
 architectural paint as stipulated in section 7 of the Air Pollution Control (Volatile Organic Compounds)
 Regulation (hereafter as "VOC Regulation"). This guidance note aims at assisting the party making a
 notification to the Authority in completing the form and submitting it.
- For details of the VOC Regulation, please visit http://www.elegislation.gov.hk and input 'Chapter 311W,
 Air Pollution Control Ordinance'. A summary of the regulated architectural paints is provided in Appendix
 A of this guidance note.
- 3. Notification to the Authority is required for regulated architectural paints imported or locally manufactured on or after 1 April 2007. Every importer or local manufacturer (excluding the party solely involved in adding colourant to the tint base of a regulated architectural paint) who imports or manufactures a regulated architectural paint as defined in Schedule 1 of the VOC Regulation on or after 1 April 2007 should fill in this notification form for submission to the Environmental Protection Department (EPD) at the following address:-

Environmental Protection Department Territorial Control Office, 28/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong. (Attn: VOC Control)

- 4. Notification shall be made prior to the sale or use of the regulated architectural paints in Hong Kong. An importer or local manufacturer is only required to notify the Authority once for each product he imports into/manufactures in Hong Kong. The products may be sold or used once the notification is made without waiting for the Authority's confirmation of the receipt of the notification. Under normal circumstances, the Authority will not confirm the receipt of a notification. The Authority may contact the party making a notification if clarification is required. The party submitting a notification is recommended to keep all records of the notification for future inspection by the Authority. Under section 22 of the VOC Regulation, records of notifications and other relevant information shall be kept for not less than three years
- 5. The following should be noted when completing the notification form:
 - (a) Importers or local manufacturers of regulated architectural paints need to notify the Authority. You may refer to the Personal Information Collection Statement at <u>Appendix B</u> about the handling of personal data collected through the submission.

- (b) Please complete the form by typing or writing in black or blue ink.
- (c) If there is insufficient space in any column to fill in all the information required in the form EPD_311N, please use separate sheet(s) of paper. The cross referenced columns should be clearly marked on the sheet. Photocopies of the blank Annex to form EPD_311N should be used if additional sheets are required. All the additional sheet(s) of information should be numbered.
- (d) The VOC content of the product filled in the notification form should be accurate and supported with testing report issued by a competent laboratory after conducting testing according to the methods stated in the VOC Regulation.
- (e) Change of packaging or reformulation without altering the VOC content does not require a fresh notification.
- 6. The information to be filled in the form EPD_311N is required to be provided under the VOC Regulation. When completing the form, please note the following:

(a) Item number, brand and full name of the product

Assign one number to each product and number the products consecutively. List the brand and full name of each product exactly as they appear on the principal display panel of the product. Products containing different levels of VOC content will be reported separately. Include trade samples unless exempted by the Authority.

(b) Regulated product code

Fill in the appropriate regulated product code as shown in Appendix A.

(c) Unit size of product when it is sold

Give the volume (litre) or weight (kg), excluding container and packaging, in which the regulated architectural paints are supplied or sold. If the imported product needs to be reprocessed by another local manufacturer, please put "TBR" after the unit size.

(d) Brand, full name and specific gravity of the recommended diluent, if any, to be used

Specify if thinning with organic solvent is required before the product is applied and, if positive, provide the brand name and full name and specific gravity of the recommended diluent and the dilution ratio.

(e) VOC content of colourant added to the tint base of the product

Give the colourant's VOC in grams per litre of the regulated architectural paint in a "ready-to-use" condition, in a format similar to that specified in Part 5 of Schedule 1 to the VOC Regulation. No deduction of colourant's VOC shall be made in determining the VOC content of product if input to this column is not provided.

(f) VOC content of product in "ready-to-use" condition

VOC content of the regulated architectural paint in a 'ready-to-use' condition shall be expressed in a format as specified in Part 5 of Schedule 1 to the VOC Regulation. Indicate whether colourant's VOC has already been subtracted from this VOC content of product. Subtraction is accepted only when the colourant VOC has been provided in this form.

The VOC content in "ready-to-use" condition should be supported with testing report issued by a competent laboratory after conducting testing according to the methods stated in the VOC Regulation.

- 7. Importers and local manufacturers are encouraged to provide supplementary information as shown in Annex B to the form EPD 311N to the Authority for compiling statistical information about regulated architectural paints in Hong Kong and monitoring the implementation progress of the VOC Regulation.
