Requirements of VETC

- i. To be qualified for inclusion in the list of designated VETCs, each applicant shall have proven experience in motor vehicle servicing / maintenance.
- ii. The staff at supervisory level (The Responsible Person of the Centre) and the Approved Vehicle Emission Testers must have the required experience in the respective trade. Paragraph 3 of the Guidance Notes describes the relevant requirements. (Proof should be available for inspection when required).
- iii. Each applicant must have the necessary equipment and facilities for carrying out the relevant vehicle emissions tests as prescribed in the Code of Practice for Designated Vehicle Emission Testing Centres issued by the Commissioner for Transport. Paragraph 4 of the Guidance Notes describes the relevant requirements.

Guidance Notes for the Completion of Application Form for Designation as Vehicle Emission Testing Centre (VETC)

1. <u>Introduction</u>

- 1.1 The completed application form should be returned to the Mobile Source Group of the Environmental Protection Department, 34/F, Revenue Tower, 5 Gloucester Road, Wanchai, Hong Kong and copied to the Vehicle Examination Division of the Transport Department, 34/F, Immigration Tower, 7 Gloucester Road, Wanchai, Hong Kong.
- 1.2 Applicants for inclusion in the list of Designated Vehicle Emission Testing Centres are required to make available, at the time of application, evidence of their financial status and evidence of their permanent administration, office, workshop and labour resources for their sole use which would be available for them to carry out the number of vehicle inspections stated by them in Section D of the application form.
- 1.3 It is advised that the applicants must fill in all the information required and that any omission or incomplete information may delay the processing of their application.

2. Registered Name of Company (Section A of the Application Form)

- 2.1 This name of the applicant will appear in the list of Designated Vehicle Emission Testing Centres if the application is successful.
- 2.2 The Business Registration Certificate refers to Form 2 issued by the Commissioner of Inland Revenue under Regulation 5 of the Business Regulations (Cap. 310, Section 14). A photocopy must be attached to the returned application form. A certified true copy as defined by Regulations 5 & 7 is NOT necessary at the stage of submission. We reserve the right to call for a certified true copy if necessary.

- 2.3 In the case of an incorporated company, a copy of the Certificate of Incorporation and a copy of the Memorandum and Articles of Association must be attached to the returned application form.
- 2.4 A photocopy of the appropriate application form for obtaining a certified copy of the registration as a business under the Business Registration Ordinance (Cap. 310, Section 5) lodged with the Commissioner of Inland Revenue must be attached to the returned application form as follows:
 - (a) in the case of a sole proprietorship Form 1(a);
 - (b) in the case of a partnership Form 1 (c) (as amended by Change of Partnership Form IRDR 64).

Financial Status

- 2.5 Companies on the list of Designated Vehicle Emission Testing Centres will be required to have adequate finance for carrying out the emission testing obligations as specified in Section D of the application form. The Environmental Protection Department at any time may make enquiries into the financial status. It is probable that such an enquiry would be made during the processing of the application for admission to the list of Designated Vehicle Emission Testing Centres as a matter of course.
- 2.6 Evidence of financial status, in the form of Bankers' References or Auditors' Reports, should be submitted together with the completed application form. Inadequate finances could be the cause for rejection of an application, or removal of a company's name from the list of Designated Vehicle Emission Testing Centres.

3. Organisation of Testing Centre (Section B of the Application Form)

3.1 The relevant organisation chart of the applicant for inclusion in the list of Designated VETCs is to be listed, with special reference to the qualification, past experience and length of service of all staff that would be engaged in the inspection of vehicles.

4. Workshop Facilities and Equipment (Section C of the Application Form)

- 4.1 Full information of the equipment and facilities that would be employed for the testing of vehicle emissions must be given. Such information should be supported by relevant manufacturer's test data sheets, certificates or manuals. It can be provided as separate attachment as an appendix to the returned application form, if necessary.
- 4.2 It is essential that sufficient accessories and spare parts for the emission testing facilities, such as smokemeter, engine tachometer and other essential testing instruments are available to minimise the downtime of testing service.
- 4.3 A general layout plan showing the area designated exclusively for the testing vehicle emissions (with entry and exit points indicated), installation of the testing equipment and workshop facilities, and the waiting area for clients must be attached as an appendix to the application form.
