**Environmental Impact Assessment (EIA) Ordinance, Cap.499**  
**Application for Permission to Apply Directly for Environmental Permit**

**Project Title: Proposed Upgrading of Kwun Tong Preliminary Treatment Works**  
**(Application No. DIR-245/2016)**

**Conditions Imposed under Section 5(12) of the EIA Ordinance**  
**for Permission to Apply Directly for Environmental Permit**

1. All mitigation measures and monitoring requirements described in the Project Profile (No. PP-534/2016) submitted with the Application (No. DIR-245/2016) by the Applicant on 14 April 2016 shall be fully implemented.
2. An independent environmental checker shall be employed to audit the implementation of all mitigation measures and monitoring requirements recommended in the Project Profile.
3. Any excess treated effluent during peak flow shall be temporarily detained in the balancing tank for discharge to the drop shaft of the Kwun Tong Preliminary Treatment Works as soon as the off-peak flow allows as described in Section 4.3.7 of the Project Profile.
4. All odour emission sources shall be enclosed. The odorous gas shall be actively extracted and diverted to deodorizing units for treatment before discharge to the atmosphere. The deodorizing units shall be designed for odour removal efficiencies according to the requirements specified in Section 5.2.2 of the Project Profile or otherwise agreed by the Director of Environmental Protection.
5. At least three months before the commencement of the Project, the applicant shall submit an Environmental Monitoring and Audit (EM&A) Manual to the Director of Environmental Protection for approval. The EM&A Manual shall provide details of the marine water quality monitoring for emergency discharge during operation of the Project as described in Sections 5.2.7 to 5.2.12 of the Project Profile. All recommendations in the approved EM&A Manual shall be fully implemented.
