**Conditions Imposed under Section 5(12) of the EIA Ordinance
for Permission to Apply Directly for Environmental Permit**

1. All mitigation measures described in the Project Profile (No. PP-646/2022) submitted with the Application (No. DIR-293/2022) by the Applicant on 1 June 2022 shall be fully implemented.
2. An independent environmental checker (IEC) shall be employed to audit the implementation of all measures recommended in the Project Profile (No. PP-646/2022) during construction phase. The IEC shall submit an Audit Report to the Director, no later than one month before operation of the grease trap waste treatment facility, to verify that all the design measures stipulated in the Project Profile have been fully implemented.
