<p>Surrounding Environment:</p> <p>The house was originally built near the coastline, but due to reclamations it is somewhat inland. The house is surrounded by other village houses many of squatter style.</p>		
<p>Historical Appraisal:</p> <p>It was built by the Law Clan who were one of the two original clans who settled in the village.</p>		
Associated Historical/ Cultural Events or Individual: None		
Inscriptions: None		
<p>Architectural Appraisal:</p> <p>The building is a Qing vernacular style two storey building square in shape. It is constructed of granite blocks and the roof is of pitched Chinese style. The granite walling and horizontal security barred timber door are interesting features.</p>		
Interior: The interior of the building was once used as an ancestral hall.		
Existing Condition: Fair		
<p>Past and Present Uses:</p> <p>Residential and after WWII the house was converted into a plastics factory and storeroom. This use was eventually stopped and the house was subdivided to let for residential use once again.</p>		
<p>Notes on modifications:</p> <p>Modern windows, aircon units, cables, junction boxes, corrugated metal sheets and metal security screen have all been added to the building. During the subdivision of the building, it has been divided into three sections, each with its own entrance.</p>
