ENVIRONMENTAL PERMIT TO CONSTRUCT AND OPERATE A DESIGNATED PROJECT

PART A (MAIN PERMIT) A 部 (許可證主要部分)

Pursuant to Section 10 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) granted the Environmental Permit (No. EP-608/2022) to the **Drainage Services Department** (hereinafter referred to as the "Permit Holder") on 19 October 2022. Pursuant to Section 13 of the EIAO, the Director amends the Environmental Permit (No. EP-608/2022) based on the Application No. VEP-647/2025. The amendments, described below, are incorporated into this Environmental Permit (No. EP-608/2022/A). This Environmental Permit as amended is for the construction and operation of the designated project described in Part B subject to the conditions specified in Part C. The issue of this environmental permit is based on the documents, approvals or permissions described below:

PART C (PERMIT CONDITIONS) C部 (許可證條件)

1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.
 - 許可證持有人及任何建造或營辦工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(環評條例)(第 499 章)的規定,而當局可根據環評條例採取適當行動。
- The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). - The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of this Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. - The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in this Permit. The site(s) refers to site(s) of construction and operation of the Project and shall mean the same hereafter. 許可證持有人須把本許可證的一份複本交予有關工地的負責人,並確保這些人士完全明白本許可證的所有條件與規定。工地是指建造及營辦工程項目的工地,下文所提及的工地亦屬同一意思。
- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the

original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

- The Permit Holder and any person constructing or operating the Project shall construct and operate the Project in accordance with the project description in <u>Part B</u> of this Permit.

- 1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No.: AEIAR-240/2022); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

- All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director. 所有按本許可證規定提交的文件,須在接獲署長的意見(如有者)後 1 個月內或署長另行指定的期限內,根據署長的意見加以修正及重新提交。
- All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 to 2.6 below before submitting to the Director under this Permit

- The Permit Holder shall release all finalised submissions as required under this Permit to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places, or any internet websites as specified by the Director, or by any means as specified by the Director, for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). - 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 1 month prior to the commencement of construction of the Project. - 1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation, or other works as agreed by the Director.

- 1.14 The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than 3 month prior to the commencement of

2. <u>Specific Conditions</u> 特定條件

Employment or Submissions before Construction of the Project 工程項目施工前須聘用的人員或提交的文件

Employment of Environmental Team (ET) 聘用環境小組

2.1 An ET shall be established by the Permit Holder no later than 3 months before the commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader and supported by relevant specialists including Terrestrial Ecologist and Landscape Architect or related professional. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management.

2.2 The ET and the ET Leader shall be responsible for duties defined in the EM&A Manual and this Permit, including implementation of the EM&A programme in accordance with the EM&A requirements as contained in the EM&A Manual of the Project; and site inspections to audit the Contractor's site practice and work methodologies with respect to environmental mitigation measures contained in the EM&A Manual of the Project and/or as required under this Permit and to take pro-active actions to pre-empt environmental problems. The ET Leader shall be responsible for:

- (ii) notifying the IEC within one working day of the occurrence of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the approved EIA Report (Register No. AEIAR-240/2022) and/or this Permit. - (iii) keeping a contemporaneous log-book of any such instance or circumstance or change of circumstances, which may affect the compliance with the EIA Report (Register No. AEIAR-240/2022) and/or this Permit. The format of the log-book shall be certified and approved by the IEC. The log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the approved EIA Report (Register No. AEIAR-240/2022) and this Permit or by the Director or his authorized officers. 保存一本記錄冊,即時記載可能會影響核准環評報告(登記冊編號: AEIAR-240/2022)的建議及/或本許可證的合規情況的每宗事件、每種 情況或每次情況變化。記錄冊的格式須得到獨立環境查核人的核證和 批准。記錄冊須加以保存,以供協助督導執行核准環評報告(登記冊編 號: AEIAR-240/2022)及本許可證的建議的所有人士、署長或獲授權 人員隨時杳閱。
- Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the EM&A Manual or failure to comply with Condition 2.2 above would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Failure by the Permit Holder to make replacement or further failure to keep contemporaneous records in the log-book despite the employment of a new ET Leader may render this Permit liable to suspension, cancellation or variation.

2.4 An IEC shall be employed by the Permit Holder no later than 3 months before the commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management.

Permit, including the following:

- (iv) notifying the Director by fax or email, within one working day of receipt of notification from the ET Leader, or identification by the IEC and his team, of each and every change of circumstances or suspected and/ or potential non-compliance with the recommendations (such as construction methods, mitigation measures, and environmental standards) of the approved EIA Report (Register No. AEIAR-240/2022), the EM&A Manual and this Permit, which might affect the monitoring or control of adverse environmental impacts arising from the Project. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition;

2.6 If the Director considers the IEC fails to discharge the duties of the IEC as defined in the EM&A Manual or in this Permit, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render this Permit liable to suspension, cancellation or variation. 如署長認為獨立環境查核人未能執行環監手冊或本許可證所列明的獨立環境查核人職務,署長可藉書面通知要求許可證持有人撤換獨立環境查核人。如未能按指示撤換獨立環境查核人,或在聘用新獨立環境查核人後仍未能通知

2.7 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, submit an EP Submission Schedule to set out a timeline for EP submissions in this Permit and shall report the progress in fulfilling the submission requirements in the monthly Environmental Monitoring and Audit (EM&A) reports submitted under Condition 3.4 of this Permit. The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule. The EP Submission Schedule or any subsequent change(s) to the submitted Schedule shall be certified by the ET Leader and verified by the IEC before submitting to the Director under this Permit.

Submission of Management Organisation 提交管理架構

2.8 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, inform the Director in writing the management organisation of the main construction companies and / or any form of joint ventures appointed for the Project. The submitted information shall include at least an organisation chart, names of responsible persons and their contact details. 許可證持有人須在展開工程項目的建造工程前最少 1 個月以書面通知署長主要建造公司及/或以任何形式的合營企業的管理架構。提交的資料須至少包括一份組織圖、負責人的姓名及聯絡資料。

Submission of Compensatory Tree Planting Implementation Plan 提交樹木補償種植實施計劃

2.9 The Permit Holder shall, no later than 6 weeks before commencement of construction of the Project, submit to the Director for approval 3 hard copies and 1 electronic copy of Compensatory Tree Planting Implementation Plan, with details of the planting objectives, planting numbers and locations, list of tree species to be used and implementation schedule, with the aim to enhance ecological values and urban biodiversity. Native tree species shall be deployed as far as possible, unless the deployment of exotic species would bring ecological enhancements. The implementation schedule shall be in table form to clearly list out the implementation party, location, timing and environmental performance required for implementation of the compensatory tree planting. The Compensatory Tree Planting Implementation Plan shall be prepared with engagement of the Terrestrial Ecologist(s) referred to in Condition 2.1, and certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-240/2022). Prior to submission to the Director for approval, the Permit Holder shall consult the relevant authorities and seek advice from Director of Agriculture, Fisheries and Conservation Department (AFCD) on Compensatory Tree Planting Implementation Plan.

Submission of Landscape and Visual Mitigation Plan 提交景觀及視覺緩解計劃

2.10 The Permit Holder shall, no later than 1 month before the commencement of the construction of the corresponding parts of landscape and visual mitigation,

measures of the Project, deposit with the Director 3 hard copies and 1 electronic copy of Landscape and Visual Mitigation Plan (LVMP). The LVMP shall demonstrate the conceptual planting layout, as well as the proposed structures and landscape with design details, colour, form and material, implementation schedule, maintenance and management schedules and drawings in the scale of 1:1000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures of the Project. The implementation schedule shall be in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The LVMP shall be certified by the ET Leader and the Landscape Architect or related professional referred to in Condition 2.1 and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-240/2022). All mitigation measures recommended and requirements specified in the LVMP or any updated LVMP shall be fully implemented and maintained for the Project.

The Permit Holder shall, no later than 3 months before the commencement of site investigation (SI) at the concerned facilities/ areas, submit supplementary Contamination Assessment Plan(s) [CAP(s)] to the Director for approval. The Permit Holder shall conduct the SI in accordance with the approved supplementary CAP(s) and submit Contamination Assessment Report(s) [CAR(s)] to document the findings of the SI (with Remediation Action Plan(s) [RAP(s)] if contamination is confirmed and remediation is deemed necessary) for approval by the Director. If remediation is required, the Permit Holder shall conduct the remediation in accordance with the approved RAP(s) and submit Remediation Report(s) to document the remediation programme for approval by the Director. An implementation schedule in table form shall be included in the RAP(s), and the implementation schedule shall clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. No construction works at the concerned facilities/areas shall be commenced before the approval of respective CAR(s) by the Director and the satisfactory completion of necessary remediation works.

Submissions or Measures to be Implemented before or during Operation of the Project

Submission of Operation Phase Contingency and Response Plan 提交營辦階段緊急應變計劃

2.12 The Permit Holder shall, no later than 6 months before the commencement of operation of the Project, submit to the Director for approval 3 hard copies and 1 electronic copy of Operation Phase Contingency and Response Plan (C&RP). Prior to submission to the Director for approval, the Permit Holder shall consult the relevant authorities and seek advice from Director of AFCD on the C&RP. The C&RP shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-240/2022). The C&RP shall include, but not limited to, the following:

- (vii) Reporting procedures; and 通報程序;以及
- (viii) Investigation arrangement of incidents that affect nearby water body/sensitive receivers, including water sampling and monitoring, assessing the impact, investigating the cause of incidents, determining necessary remedial measures, and relevant departments to be consulted.

The C&RP shall include an implementation schedule in table form to clearly list out the measures to be implemented, and the implementation party, location, timing and environmental performance required for implementation of the measures. All measure(s) recommended and requirements specified in the approved C&RP shall be fully implemented.

Measures to Mitigate Odour Impacts 氣味影響緩解措施

- 2.13 The Permit Holder shall implement the following mitigation measures to minimize odour impact during operation of the Project: 許可證持有人必須採取以下的緩解措施以盡量減低工程項目營辦期間的氣味
 - (i) All facilities and areas with potential odour emission (including the organic waste reception areas) shall be fully enclosed and the exhaust air shall be conveyed to deodourization (DO) units for

treatment before discharge to the environment; 所有可能散發氣味的設施及地方(包括有機廢物接收區)須完全 密封,而廢氣在排放到環境之前須先行傳送到除味裝置進行處 理;

(ii) All DO units shall have at least 95% odour removal efficiency. All DO units shall be properly operated and maintained for treatment of exhaust air before discharge; and 所有除味裝置須具備至少 95%的除味效能。所有除味裝置須予以妥善操作及保養維修,以處理廢氣後再排出;及

(iii) Sludge shall be stored in sealed containers during transportation. 污泥於運送途中須貯存於密封式容器內。

3 Environmental Monitoring and Audit (EM&A) Requirements 環境監察及審核規定

3.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme_shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

 - (i) conducting baseline environmental monitoring; 進行環境基線監測;
 - (ii) conducting impact monitoring; 進行影響監測;
 - (iii) carrying out remedial actions described in the Event/Action Plans of the EM&A Manual in accordance with the time frame set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the EM&A Manual are exceeded; and 如超逾環監手冊內指定的標準,則按照環監手冊內的事件/行動計劃所訂明的時限或署長所同意的時限,執行事件/行動計劃所說明的補救行動;以及
 - (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on site. 在收集數據或完成補救行動 3 個工作天內,須記錄及備存上文(i)至(iii)段所有參數的詳情,用作擬備及提交每月環監報告,並備妥有關資料以供在工地查閱。
- 3.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director.

許可證持有人須在展開工程項目的建造工程前最少 2 個星期向署長提交基線監測報告的 1 份硬複本及 1 份電子版本。提交文件須由環境小組組長核證及獨立

環境查核人核實,證明其符合環監手冊所載的規定,然後才提交署長。如署長要求,則須提交基線監測報告的額外複本。

3.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days after the end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided upon request by the Director.

- 3.5 All environmental monitoring and audit data submitted under this Permit shall be true, valid and correct.

- To ensure a high degree of transparency regarding the monitoring data and results in view of the public concern about the Project, all environmental monitoring and audit data and results and all submissions and all performance test data and results required by this Permit shall be made available by the Permit Holder to the public through a dedicated website to be set up by the Permit Holder under Condition 4.2 below, in the shortest practicable time and in no event later than 10 working days after such information is available.

4.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 3.3 and 3.4 above. For the HTML version, a content page capable of providing hyperlink to each section and subsection of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by

the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

4.2 The Permit Holder shall, within 6 weeks after the commencement of construction of the Project, set up a dedicated Internet website and notify the Director in writing the Internet address where the environmental monitoring data and project information is to be placed. All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and during the first 3-year period of operation of the Project, or otherwise as agreed by the Director.

4.3 The Internet website as described in Condition 4.2 above shall enable user-friendly public access to the environmental monitoring data and project information including the Project Profile, EIA Report and Environmental Permit(s). The Internet website shall have features capable of:

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit. 承擔工程項目整項或部分工程的責任的人,在承擔責任之前,可根據環評條例第12條的規定向署長申請新的環境許可證。
- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. - 6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to

construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.



 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and —經循簡易程序第二次或其後每次定罪,可處罰款 100 萬元及監禁 1年;以及
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued. 在任何情况下如該罪行屬持續性質,法院或裁判官可就其信納該罪行持續的每天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證 的任何條件提出上訴。
