Pursuant to Section 10 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) grants the Environmental Permit No. EP-630/2023 to the **Airport Authority Hong Kong** (hereinafter referred to as the "Permit Holder") on 26 October 2023. Pursuant to Section 13 of the EIAO, the Director amends the Environmental Permit No. EP-630/2023 based on the Application No. VEP-650/2025. The amendments, described below, are incorporated into this Environmental Permit No. EP-630/2023/A. This Environmental Permit as amended is for the construction and operation of the designated project described in Part B subject to the conditions specified in Part C. The issue of this Environmental Permit is based on the documents, approvals or permissions described below:

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

If the Permit Holder surrenders a part or the whole of this Permit, the

notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

- 1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No.: AEIAR-254/2023); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the application documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Environmental Team (ET)

Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 and 2.4 below before submitting to the Director under this Permit.

The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date.

If there is any change to the construction noise mitigation measures and/or plant inventory recommended in the submitted CNMP, the Permit Holder shall, no later than 1 month before the implementation of any such change, deposit with the Director 3 hard copies and 1 electronic copy of an updated CNMP. The CNMP and updated CNMP shall identify the noise source inventory and assess the effectiveness of construction noise mitigation measures, including the use of quieter powered mechanical equipment, quieter construction methods, noise barriers, enclosures and insulation fabric as recommended in the approved EIA Report (Register No. AEIAR-254/2023) for mitigating the construction noise impact of the Project. The CNMP and updated CNMP shall include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The CNMP and updated CNMP shall be prepared and checked by a Certified Noise Modelling Professional as recognised by the Hong Kong Institute of Qualified Environmental Professionals Limited or other professional as agreed by the Director, certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations of the approved EIA Report (Register No. AEIAR-254/2023). All mitigation measures recommended and requirements specified in the CNMP and the updated CNMP shall be fully implemented.

The Plan shall include the construction programme of marine works and details on the design, location, operation and maintenance of silt curtain(s) to be deployed during the marine works. If there are any change(s) to the landscape and visual mitigation measures in the deposited LVMP, the Permit Holder shall, no later than 1 month before the implementation of such change(s), deposit with the Director 3 hard copies and 1 electronic copy of the updated LVMP(s) with clear indication of the proposed change(s). The LVMP and the updated LVMP(s) shall include design details, implementation schedule, maintenance and management schedules and drawings in the scale of 1:1000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures of the Project. The implementation schedule shall be in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The LVMP and updated LVMP(s) shall be prepared by the Registered Landscape Architect appointed under Condition 2.7, and shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations contained in the approved EIA Report (Register No. AEIAR-254/2023), and provide adequate and relevant justifications to support the change(s). All recommended measures and requirements specified in the LVMP or any updated LVMP(s) shall be fully implemented.

Measures to Minimize Marine Ecological Impacts 盡量減低海洋生態影響的措施

2.15 The Permit Holder shall not conduct any underwater percussive piling in this Project. 許可證持有人不可在工程項目中進行任何水底撞擊式打樁。

Waste Management Measures 廢物管理措施

2.16 All dump trucks for construction and demolition (C&D) materials transportation and disposal shall be equipped with Global Positioning System (GPS) or equivalent automatic identification system (AIS) for real time tracking and monitoring of their travel routings and parking locations in order to avoid illegal dumping or landfilling of C&D materials. The data collected by GPS or equivalent AIS relating to travel routings and parking locations of all dump trucks shall be recorded properly for checking and auditing by ET and IEC respectively. The audit findings shall be reported in the Monthly EM&A Report(s).

At least 2 months before commencement of operation of the Project, the Permit Holder shall carry out noise performance test and deposit with the Director 3 hard copies and 1 electronic copy of a noise performance test report to confirm the compliance of noise level of the zero emission vehicles in accordance with the approved EIA Report (Register No. AEIAR-254/2023) and all relevant documents in the Register. The noise performance test report shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations of the approved EIA Report (Register No. AEIAR-254/2023) and all relevant documents in the Register. Any necessary measure(s) as recommended in the noise performance test report shall be fully and properly implemented and maintained for the Project.

The maintenance dredging plan shall include but not limited to information relating to the scope of dredging works, works programme, dredging rate and the number of dredgers deployed for carrying out the dredging works.

- 3.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

- (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on site. 在收集數據或完成補救行動 3 個工作天內,須記錄及備存上文(i)至(iii)段所有參數的詳情,用作擬備及提交每月環監報告,並備妥有關資料以供在工地查閱。
- 3.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks beforethe commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director. 許可證持有人須在展開工程項目的建造工程前最少 2 個星期向署長提交基線監測報告的 1 份硬複本及 1 份電子版本。提交文件須由環境小組組長核證及獨立環境查核人核實,證明其符合環監手冊所載的規定,然後才提交署長。如署長要求,則須提交基線監測報告的額外複本。
- 3.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days afterthe end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided upon request by the Director.

4.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 3.3 and 3.4 above. For the HTML version, a content page capable of providing hyperlink to each section and subsection of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and during the first 3-year period of operation of the Project, or otherwise as agreed by the Director.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.


