Pursuant to Sections 10 and 12 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) granted the Further Environmental Permit (No. FEP-02/247/2006/B) to **China Harbour Engineering Company Limited** (hereinafter referred to as the “Permit Holder”) on 17 May 2023. Pursuant to Section 13 of the EIAO, the Director amends the Further Environmental Permit (No. FEP-02/247/2006/B) based on Application No. VEP-658/2026. The amendments, described below, are incorporated into this Further Environmental Permit (No. FEP-02/247/2006/C). This Further Environmental Permit as amended is for the construction and operation of the designated project described in Part B subject to the conditions specified in Part C. The issue of this Further Environmental Permit is based on the documents, approvals or permissions described below:

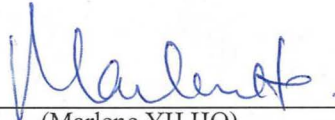

**PART C (PERMIT CONDITIONS)****C 部 (許可證條件)****1. General Conditions****一般條件**

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap.499) and may become the subject of appropriate action being taken under the Ordinance.

許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況，可能違反《環境影響評估條例》(環評條例) (第 499 章) 的規定，而當局可根據條例採取適當行動。

- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including without limitation to the Noise Control Ordinance (Cap.400), Air Pollution Control Ordinance (Cap.311), Water Pollution Control Ordinance (Cap.358), Dumping at Sea Ordinance (Cap.466) and Waste Disposal Ordinance (Cap.354). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit or the documents referred to in Part A of the Permit readily available at all times for inspection by the Director or his authorized officers at all sites/offices covered by this Permit. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated by the Permit. The site(s) refers to site(s) of construction and operation of the Project and shall mean the same hereafter.

- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).

- 1.6 The Permit Holder and any person constructing or operating the Project shall construct and operate the Project in accordance with the project descriptions in Part B of this Permit.

- 1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the Project Profile (Register No.: PP-271/2005), the application documents for environmental permits, other relevant documents in the Register, the information or mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the application documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

許可證持有人及任何建造或營辦工程項目的人士須確保工程項目的設計、建造及營辦，按照下述資料及措施辦理：工程項目簡介（登記冊編號：PP-271/2005）所說明的資料及建議；環境許可證的申請文件；登記冊內的其他相關文件；本許可證所說明的資料或緩解措施；根據本許可證內載的條件給予署長存放或提交署長而獲批准的文件所建議的緩解措施；以及在工程項目各階段進行的持續監察及監測工作所建議的緩解措施。登記冊內的申請文件所述建議如沒有在本許可證明確表示，則仍須實施這些建議，除非獲本許可證明確豁除或另獲署長同意。

- 1.8 All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director.

- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, and all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO.

- 1.10 The Permit Holder shall release all finalised submissions as required under this Permit to the public by depositing copies in the EIAO Register Office, or in any other places, or any internet websites as specified by the Director, or by any means as specified by the Director, for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

- 1.11 The Permit Holder shall submit and / or deposit all submissions within the time as specified in the Conditions of this Permit. All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the EIAO Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

許可證持有人須在本許可證條件所列明的時間內，提交/存放所有文件。本許可證規定向署長提交的所有文件，須親身送交或以掛號方式郵寄至環評條例登記冊辦事處（現址為：香港灣仔軒尼詩道130號修頓中心27樓）。所有按本許可證規定提交的文件定稿的電子版本，均須以便攜式文件格式(PDF)(第1.3或較後版本)製作，除非另獲署長同意，並須與硬複本同時提交。

- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction and operation of the Project no later than one week prior to the commencement of construction and one month prior to the operation of the Project respectively. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction and operation.

許可證持有人須在工程項目建造工程展開前至少 1 個星期及工程項目開始營辦前至少 1 個月，以書面方式分別把建造工程展開及開始營辦的日期通知署長。建造工程展開及開始營辦的日期如有任何更改，許可證持有人必須立即以書面方式通知署長。



- 1.13 For the purpose of this Permit, “commencement of construction” does not include works related to site clearance and preparation or other works as agreed by the Director.

為執行本許可證，「建造工程展開」不包括有關工地清理及預備的工程，或署長同意的其他工程。

## 2. Specific Condition 特定條件

- 2.1 The Permit Holder shall employ a qualified odour panelist to patrol and monitor the odour level at the site boundary of the West Kowloon Transfer Station (WKTS) three times per day to ensure compliance with the odour limit of 2 Odour Units within the site boundary of the WKTS. In the event of exceedance of the odour limit, the Permit Holder shall improve the existing air scrubbing system to contain the odour level at the site boundary of the WKTS to within 2 Odour Units.

許可證持有人須聘用一名合資格氣味檢查人員，每天進行三次巡查及監測西九龍廢物轉運站工地邊界的氣味水平，以確保氣味符合 2 個氣味單位的規限。如氣味超越規限，許可證持有人須改善現有的淨氣系統，以保持西九龍廢物轉運站工地邊界的氣味水平限於 2 個氣味單位內。

- 2.2 To minimize odour impact during operation of the Project, an air scrubbing system with a forced ventilation system and an odour removal efficiency of at least 99.9% for hydrogen sulphide and at least 90% for ammonia shall be implemented and properly maintained.

為盡量減低工程項目營辦期間的氣味影響，須具備附有壓力通風系統及除臭效能達到消除至少 99.9% 硫化氫及 90% 氨的淨氣系統，並予以妥善保養維修。

- 2.3 Before the completion of the upgraded grease trap waste treatment facility, all measures as recommended in the operation plan which includes implementation schedule as deposited with the Director under Condition 2.3 of the environmental permit (Permit No.: FEP-01/247/2006/B) shall be fully implemented. The Permit Holder shall deposit three hard copies and one electronic copy of an updated operation plan one month before the operation of the upgraded grease trap waste treatment facility to the Director, unless otherwise agreed by the Director. The updated operation plan shall include:

在隔油池廢物處理設施完成升級前，根據環境許可證(編號：FEP-01/247/2006/B)條件 2.3 向署長存放的操作計劃書(包括計劃執行的時間表)內建議的所有措施均須全面執行。除非另獲署長同意，許可證持有人須在開始營運經提升後的隔油池廢物處理設施前至少 1 個月，把新的操作計劃書的 3 份硬複本及 1 份電子複本送交署長存放。新的操作計劃書須包括下列資料：

- (i) the operation processes of the facility;  
設施的操作程序；
- (ii) the updated layout plan of the facility;  
設施的更新平面圖；
- (iii) the updated design parameters of the facility; and



設施的更新設計參數；以及

- (iv) the updated environmental mitigation measures for the facility with an implementation schedule in table form.

設施的更新環境緩解措施，連同以列表形式列出的計劃執行的時間表。

After the upgrade of grease trap waste treatment facility, all measures as recommended in the updated operation plan shall be fully implemented.

在隔油池廢物處理設施升級後，新的操作計劃書內建議的所有措施均須全面予以執行。

註：

1. This Permit consists of three parts, namely, Part A (Main Permit), Part B (Description of Designated Project) and Part C (Permit Conditions). Any person relying on this permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.  
本許可證共有 3 部，即 A 部 (許可證主要部分)；B 部 (指定工程項目的說明) 及 C 部 (許可證條件)。任何援引本許可證的人士須就環評條例的法律含意徵詢獨立法律意見，下述註解只供一般參考用。
2. If there is a breach of any conditions of this Permit, the Director or his authorized officer may, with the consent of the Secretary for Environment and Ecology, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.  
如違反本許可證的任何條件，署長或獲授權人員可在環境及生態局局長的同意下勒令停止相關工程，直至許可證持有人為所造成的環境損害採取補救行動為止。在此情況下，許可證持有人未經署長或獲授權人員同意，不得進行任何相關工程。
3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit.  
許可證持有人可根據環評條例第 13 條的規定向署長申請更改本許可證的條件。許可證持有人須以經修訂的許可證替換在工程項目的工地內展示的原有許可證。
4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit.  
承擔工程項目整項或部分工程的責任的人，在承擔責任之前，可根據環評條例第 12 條的規定向署長申請新的環境許可證。
5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site.  
根據環評條例第 14 條的規定，署長可在環境及生態局局長的同意下暫時吊銷、更改或取消本許可證。遭暫時吊銷、更改或取消的許可證必須從工程項目的工地除下，不再展示。



6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Schedule 2 of the EIAO without a valid environmental permit.  
如本許可證在工程項目建造或營辦期間取消或交回，則在繼續進行工程項目之前，必須先根據環評條例規定取得另一份環境許可證。根據環評條例第 26(1)條的規定，任何人在沒有有效環境許可證的情況下建造或營辦環評條例附表 2 所列明的指定工程項目，即屬犯罪。
7. Any person who constructs or operates the Project contrary to the conditions in the Permit, and is convicted of an offence under the EIAO, is liable: -  
如任何人在違反本許可證的條件下建造或營辦工程項目，根據環評條例，即屬犯罪：
- (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;  
一經循公訴程序首次定罪，可處罰款 200 萬元及監禁 6 個月；
  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;  
一經循公訴程序第二次或其後每次定罪，可處罰款 500 萬元及監禁 2 年；
  - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;  
一經循簡易程序首次定罪，可處第 6 級罰款及監禁 6 個月；
  - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and  
一經循簡易程序第二次或其後每次定罪，可處罰款 100 萬元及監禁 1 年；及
  - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.  
在任何情況下如該罪行屬連續性質，法院或裁判官可就其信納該罪行連續的每一天另處罰款 10,000 元。
8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit.  
許可證持有人可在接獲本許可證後 30 天內，根據條例第 17 條就本許可證的任何條件提出上訴。
9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.
