### PART C (PERMIT CONDITIONS) C 部 (許可證條件)

# 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

- The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation. 許可證持有人及任何建造或營辦工程項目的人士須確保完全符合現行法例的規定,包括但不限於《噪音管制條例》(第 400 章)、《空氣污染管制條例》(第 311 章)、《水污染管制條例》(第 358 章)、《海上傾倒物料條例》(第 466 章)及《廢物處置條例》(第 354 章)。本許可證本身不會就根據任何法例提出的法律程序構成任何抗辯理由,或根據任何法例默示任何批准。
- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of this Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. - 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in this Permit. - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the

original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the Project Profile (Register No.: PP-679/2025); the application documents for environmental permits; other relevant documents in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the application documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be verified by the Independent Environmental Checker (IEC) referred to in Condition 2.1 below before submitting to the Director under this Permit

For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

1.11 The Permit Holder shall submit and / or deposit all submissions within the time as specified in the Conditions of this Permit. All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 2 weeks prior to the commencement of construction of the Project. - 1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation, or other works as agreed by the Director.

1.14 The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than 2 months prior to the commencement of operation of the Project. # 2. <u>Specific Conditions</u> 特定條件

Employment of Independent Environmental Checker (IEC) 聘用獨立環境查核人

2.1 An IEC shall be employed by the Permit Holder no later than 2 weeks prior to the commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor for the Project. The IEC shall be a person who has at least 7 years of experience in environmental monitoring and audit or environmental management. The IEC shall audit the implementation of the mitigation measures recommended in the Project Profile (Register No.: PP-679/2025) and required under this Permit and confirm full compliance of the mitigation measures through an audit report. The Permit Holder shall, within 1 month upon completion of the construction works, deposit with the Director 2 hard copies and 1 electronic copy of the audit report prepared by the IEC.

Submission of Noise Commissioning Test Report before Operation 營辦前提交試行運作噪音測試報告書

2.3 The Permit Holder shall, no later than 1 month prior to the commencement of operation of the Project, appoint a qualified person possessing at least 7 years of noise control experience and a corporate membership of the Hong Kong Institute of

Acoustics or another professional as agreed by the Director, to carry out noise commissioning test in accordance with the requirements set out in the Project Profile (Register No.: PP-679/2025) at Temporary Structure near 1A Cheung Hang Village and 1 Cheung Hang Village cum Cheung Hang Village Residents Welfare Association or otherwise agreed by the Director, and deposit with the Director 2 hard copies and 1 electronic copy of the Noise Commissioning Test Report (NCTR) to confirm that the operational noise level complies with the criteria set out in the Project Profile (Register No.: PP-679/2025). The NCTR shall be prepared by the qualified person as described above, and verified by the IEC as conforming to the relevant information and recommendations of the Project Profile (Register No.: PP-679/2025) before submission to the Director. All mitigation measures recommended and requirements specified in the NCTR shall be fully implemented. 許可證持有人須在工程項目開始營辦前最少 1 個月,聘用一名至少有 7 年噪音 控制經驗的香港聲學學會會員或由署長同意的其它專業人員,按照工程項目簡 介(登記冊編號: PP-679/2025)所訂明的規定,在長坑村 1A號附近臨時構築物 及長坑村 1 號暨近長坑村居民福利會或另獲署長同意的位置進行試行運作噪音 測試,並把試行運作噪音測試報告書的 2 份硬複本及 1 份電子複本送交署長存 放,以確認工程營辦期間的噪音水平符合工程項目簡介(登記冊編號:PP-679/2025) 所訂定的標準。試行運作噪音測試報告書須由上文所述的專業人員擬 備,並須由獨立環境查核人核實,確定符合工程項目簡介(登記冊編號:PP-679/2025) 的相關資料及建議,然後才向署長提交。試行運作噪音測試報告書中 建議的所有緩解措施及指明的規定均須全面予以實施。

### Measures to be Implemented during Operation 營辦期間須採取的措施

- 2.4 To avoid or minimise potential environmental impacts during operation of the Project, the following waste management measures shall be implemented: 為避免或減少工程項目營辦期間所產生的潛在環境影響,須實施以下廢物管理措施:
  - (a) No skeet shooting or use of clay targets shall be permitted; 嚴禁於工程項目營辦期間進行飛靶射擊或使用飛碟;
  - (b) Bullet catchers made of soft rubber materials and backstops shall be erected behind the target plates of the outdoor shooting ranges to stop and collect the bullet heads; and 室外射擊場的靶板後方須設置由軟橡膠材料製成的子彈收集器及防彈板,以攔截和收集子彈頭;及
  - (c) All shooting waste including bullet heads and cartridge casings left on the firing range shall be collected daily with metal detectors.

- 2.5 Chemical toilets shall be provided during operation of the Project to minimise water quality impacts. No discharge of wastewater into nearby stream shall be allowed. 在工程項目營辦期間,須提供使用化學劑清理的廁所,以減低水質影響。不得將廢水排放到附近的溪流。
- 2.6 No outdoor shooting shall be permitted in the firing range from 18:30 hour to 09:30 hour the next day to minimise noise impacts during operation of the Project. 嚴禁於下午 6 時 30 分至翌日上午 9 時 30 分在射擊場內進行室外射擊,以減低



工程項目營辦期間所產生的噪音影響。

### Submission of Fixed Noise Performance Review during Operation 營辦期間提交固定噪音表現審查報告書

2.7 If there are any change(s) to the shooting operation scenarios set out in the Project Profile (Register No.: PP-679/2025) during operation of the Project, the Permit Holder shall, no later than 1 month prior to the implementation of such change(s), notify the Director and submit 2 hard copies and 1 electronic copy of a Fixed Noise Performance Review Report (FNPRR) to the Director for approval. The FNPRR shall review the noise mitigation measures recommended in the Project Profile (Register No.: PP-679/2025) to confirm that the operational noise level under such change(s) complies with the criteria set out in the Project Profile (Register No.: PP-679/2025). The FNPRR shall be prepared by a Certified Noise Modelling Professional recognized by the Hong Kong Institute of Qualified Environmental Professionals or another professional as agreed by the Director, and verified by the IEC as conforming to the relevant information and recommendations of the Project Profile (Register No.: PP-679/2025) before submission to the Director. All mitigation measures recommended and requirements specified in the FNPRR shall be fully implemented.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit. 許可證持有人可根據環評條例第 13 條的規定向署長申請更改本環境許可證的條件。許可證持有人須以經修改的許可證替換在工程項目工地內展示的原有許可證。
- 4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit. 承擔工程項目整項或部分工程的責任的人,在承擔責任之前,可根據環評條例第12條的規定向署長申請新的環境許可證。
- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. - 6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit. 如果本許可證在工程項目建造或營辦期間取消或交回,則在繼續進行工程項目之前,必須先根據環評條例規定取得另一份環境許可證。根據環評條例第 26(1)條的規定,任何人在沒有有效環境許可證的情況下建造或營辦環評條例附表 2 第 1 部所列明的指定工程項目,即屬犯罪。
- 7. Any person who constructs or operates the Project contrary to the conditions in this Permit, and is convicted of an offence under the EIAO, is liable:
  - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;
  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
  - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
  - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
  - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

- (i) 一經循公訴程序首次定罪,可處罰款 200 萬元及監禁 6 個月;
- (ii) 一經循公訴程序第二次或其後每次定罪,可處罰款 500 萬元及監禁 2 年;
- (iii) 一經循簡易程序首次定罪,可處第6級罰款及監禁6個月




- (iv) 一經循簡易程序第二次或其後每次定罪,可處罰款 100 萬元及監禁 1 年;以及
- (v) 在任何情況下如該罪行屬持續性質,法院或裁判官可就其信納該罪行持續的每天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證的任何條件提出上訴。
