#### PART C (PERMIT CONDITIONS) C 部 (許可證條件)

# 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何建造工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(環評條例) (第 499 章) 的規定,而當局可根據環評條例採取適當行動。
- 1.2 The Permit Holder and any person constructing the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). - 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of this Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. - 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in this Permit. - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the

original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

- 1.7 The Permit Holder and any person constructing the Project shall ensure that the Project is designed and constructed in accordance with the information and recommendations described in the Project Profile (Register No.: PP-688/2025); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the application documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

- All submissions approved by the Director, all submissions deposited without comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 below before submitting to the Director under this Permit

For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies. 許可證持有人須在本許可證條件所列明的時間內,提交及/或存放所有文件。 本許可證規定向署長提交的所有文件,須親身送交或以掛號方式郵寄至環境 影響評估條例登記冊辦事處 (現址為:香港灣仔軒尼詩道 130 號修頓中心 27 樓)。所有按本許可證規定提交的文件定稿的電子複本,均須以超文本標示 語言(HTML)(第 4.0 或較後版本)和便攜式文件格式(PDF)(第 1.3 或較後版本)製 作,除非另獲署長同意,電子複本須與硬複本同時提交。
- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 1 month prior to the commencement of construction of the Project. # 2. Specific Conditions 特定條件

# Employment of Independent Environmental Checker (IEC) 聘用獨立環境查核人

An Independent Environmental Checker (IEC) shall be employed by the Permit Holder before commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor for the Project. The IEC shall be a person who has at least 7 years of experience in Environmental Monitoring and Audit or environmental management. The IEC shall audit the implementation of the environmental mitigation measures recommended in the Project Profile (Register No. PP-688/2025) and required under this Permit, and to confirm full compliance of the mitigation measures through an audit report. The Permit Holder shall, within 1 month upon completion of the construction works, submit to the Director 2 hard copies and 1 electronic copy of the audit report prepared by the IEC. 許可證持有人須在工程項目的建造工程展開前聘用一名獨立環境查核人。獨立環境查核人。獨立

許可證持有人須在工程項目的建造工程展開 即時用一名獨立環境查核人。獨立環境查核人不得與工程項目的承辦商有任何聯繫。獨立環境查核人須在環境監察及審核或環境管理方面最少有7年經驗。獨立環境查核人須審核工程項目簡介(登記冊編號:PP-688/2025)內及本許可證條件中建議的環境保護措施的實施工作,並在審核報告書確認所有措施的實施完全符合工程項目簡介以及各許可證條件的規定。許可證持有人須在建造工程完成後1個月內,向署長提交由獨立環境查核人擬備的審核報告書的2份硬複本及1份電子複本。

# Employment of Ecologist 聘用生態學家

An ecologist shall be employed by the Permit Holder before commencement of 2.2 construction of the Project. The ecologist shall conduct the pre-construction survey and certify the submission under Condition 2.3 of this Permit. The ecologist shall also monitor the implementation of ecological mitigation measures recommended in the Project Profile (Register No. PP-688/2025) and the submission under Condition 2.3 of this Permit, including but not limited to those related to the protection of flora and amphibian species of conservation importance before and during construction. The ecologist shall be a person who has at least 3 years of relevant experience. The qualification and experience of the ecologist shall be verified by the IEC. 許可證持有人須在工程項目的建造工程展開前聘用一名生態學家。生態學家須 進行施工前調查及根據本許可證條件第 2.3 項核證提交的文件。生態學家亦須 在建造工程前及期間監察工程項目簡介(登記冊編號:PP-688/2025)以及根據本 許可證條件第 2.3 項提交的文件建議的生態緩解措施的實施情況,包括但不限 於與保護具保育價值的植物和兩棲動物物種有關的措施。生態學家須具備至少 3年相關經驗,其資格及經驗須由獨立環境查核人核實。

#### Submission of Updated Ecological Survey Report(s) 提交更新的生態調查報告

2.3 The Permit Holder shall conduct pre-construction survey(s) at and near the locations of the access ladder and the working area(s)/platform(s), to identify suitable locations for building the access ladders and working platforms to avoid or minimize disturbance to habitats or species of conservation importance within and in the vicinity of the concerned area(s). The Permit Holder shall, no later than 2 weeks prior to the commencement of the corresponding parts of the ground investigation works or

otherwise approved by the Director, deposit with the Director 4 hard copies and 1 electronic copy of Updated Ecological Survey Report(s) (UESR(s)) certified by the qualified ecologist appointed under Condition 2.2 above, and verified by the IEC. The UESR(s) shall provide details and findings of the pre-construction survey(s), and details of the mitigation measures required. The UESR(s) shall also include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, the implementation party, location and timing. The mitigation measures recommended and requirements specified in the UESR(s) shall be fully implemented. 許可證持有人須在通道豎梯及施工區域/工作平台的位置及附近範圍進行施工前 調查,以找出適合搭建通道豎梯及工作平台的位置以避免或盡量減少干擾有關 區域內及附近的生境或具保育價值的物種。許可證持有人須在相關部分的土地 勘測工程前最少 2 個星期,或在署長另行批准的限期前,把由根據上文條件第 2.2 項聘用的合資格生態學家核證並由獨立環境查核人核實的更新的生態調查報 告的 4 份硬複本及 1 份電子複本送交署長存放。更新的生態調查報告須提供施 工前調查的細節和結果,及所需的緩解措施的細節。更新的生態調查報告亦須 以列表形式列出實施時間表,清楚列明將會實施的緩解措施、實施者、地點及 時間。更新的生態調查報告中建議的所有緩解措施均須全面予以實施。

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit. 許可證持有人可根據環評條例第 13 條的規定向署長申請更改本環境許可證的條件。許可證持有人須以經修改的許可證替換在工程項目工地內展示的原有許可證。
- 4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit.

- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site. 根據環評條例第 14 條的規定,署長可在取得環境及生態局局長的同意下暫時吊銷、更改或取消本許可證。遭暫時吊銷、更改或取消的許可證必須從工程項目工地除下,不再展示。
- 6. If this Permit is cancelled or surrendered during construction of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

  - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;
  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
  - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
  - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
  - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

- 9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice
