## **Proposed Monitoring Station for Air Quality and Noise**

In accordance with Clause 3.1 of Environmental Permit No. EP-331/2009 (EP), an Environmental Monitoring and Audit (EM&A) programme shall be implemented as set out in the EM&A Manual of the Environmental Impact Assessment Report for the "Planning and Development Study of Potential Housing Site in Area 54, Tuen Mun" (EIA Report, Register No.: AEIAR-015/1999) which was approved by the Director of Environmental Protection (DEP) on 3 September 1999 and subsequently confirmed as still valid by a EIA review completed in March 2008.

While the EM&A Manual covers all site works for Area 54, section 2 and 3 of the EM&A Manual requires that 9 noise monitoring stations and 4 air quality monitoring stations should be set up for EM&A programme for the Area 54 of Tuen Mun.


The EP-331/2009 covers the widening of Tsing Lun Road and the entire work area has been shown in Figure 1 – Site Location Plan of the EP-331/2009. For this particular Contract, the project site boundary covers only a small portion of the work area in Figure 1 of EP-331/2009, as illustrated in the attached **Figure A**, and the following air quality and noise monitoring stations are proposed for baseline monitoring and future impact monitoring, for the agreement of Environmental Protection Department (EPD):



The locations of these monitoring stations are presented in Figure B as attached.

The rationale of selecting above monitoring locations for this Contract is consistent with the recommendation in Sections 2.1.3 and 3.4 of the EM&A Manual which the locations are close to major site activities and likely to have dust and noise impacts, direct line of sight is observed from the above selecting locations to the major site activities, and permission and access have been obtained to set up the monitoring equipment in these receivers. Thus, the above selecting monitoring locations are considered to be the most representative for the EM&A programme under the EP-331/2009.

All the monitoring parameters, equipments and monitoring procedures in accordance with the EM&A Manual would be followed during the baseline and impact monitoring.
