#### EXECUTIVE SUMMARY

This is the Quarterly Environmental Monitoring and Audit (EM&A) Report – May 2016 to July 2016 specific for Environmental Permit no. EP-376/2009 and Further Environmental Permit no. FEP-01/376/2009. The EM&A report is prepared by the Environmental Team (ET) employed under Contract No. HK/2015/01 – Wan Chai Development Phase II and Central Wanchai Bypass – Sampling, Field Measurement and Testing Works (Stage 3). This report presents the environmental monitoring and audit findings and information during the period from 27 April 2016 to 26 July 2016. The cut-off date of reporting is at 26<sup>th</sup> of each reporting period

#### Noise Monitoring

- iii. Noise monitoring was conducted at M1a Harbour Road Sports Centre.
- iv. With respect to the shift in major construction site portions at Wan Chai North, the noise monitoring station M1a – Harbour Road Sports Centre was finely adjusted from East of Harbour Road Sports Centre to West of Harbour Road Sports Centre on 21 June 2016.
- v. Two limit level exceedances were recorded at M1a Harbour Road Sports Centre on 4 and 24 May 2016 in May reporting month. After the investigation, the exceedances were concluded as non-project related.
- vi. Three limit level exceedances were recorded at M1a Harbour Road Sports Centre on 7, 13 and 21 June 2016 in June reporting month. After the investigation, the exceedances were concluded as non-project related.
- vii. One limit level exceedances were recorded at M1a Harbour Road Sports Centre on 28 June 2016 in July reporting month. After the investigation, the exceedances were concluded as non-project related.



#### Air Quality Monitoring

- viii. 1-hour and 24-hour Total Suspended Particulates (TSP) monitoring were conducted on every six days basis at CMA5b and CMA6a Contractor HK/2012/08 Site Office.
- ix. Due to electricity interruption, the 24hr TSP monitoring at station CMA6a and CMA5b were rescheduled as below:

24hr TSP monitoring at CMA5b was rescheduled from 20 May 2016 to 21 May 2016 24hr TSP monitoring at CMA6a was rescheduled from 7 June 2016 to 8 June 2016 24hr TSP monitoring at CMA5b was rescheduled from 11 July 2016 to 12 July 2016

- x. Due to closure of major road and pedestrian access to monitoring station, 1hr TSP monitoring at CMA5b monitoring station was rescheduled from 17 May 2016 to 20 May 2016 in May reporting month.
- xi. No exceedances were recorded in this reporting quarter.

#### 1.1 Scope of the Report

1.1.1. Lam Geotechnics Limited (LGL) has been appointed take up the role as the Environmental Team (ET) under Environmental Permit no. EP-376/2009 and Further Environmental Permit no. FEP-01/376/2009 to implement the Environmental Monitoring and Audit (EM&A) programme as stipulated in the EM&A Manual of the approved Environmental Impact Assessment (EIA) Report for Wan Chai Development Phase II and Central-Wan Chai Bypass (Register No.: AEIAR-458/2008).

This report documents the finding of EM&A works for Environmental Permit (EP) no. EP-376/2009 and Further Environmental Permit no. FEP-01/376/2009, during the period 27 April 2016 to 26 July 2016. The cut-off date of reporting is the 27<sup>th</sup> of each reporting period.

#### 2. PROJECT BACKGROUND

#### 2.1 Background

2.1.1 Wan Chai Development phase II and Central-Wan Chai Bypass (hereafter called "the Project") are Designated Project (DP) under the Environmental Impact Assessment Ordinance (Cap. 499) (EIAO). The Environmental Impact Assessment (EIA) Report for Wan Chai Development phase II and Central-Wan Chai Bypass (Register No.: AEIAR-125/2008) has been approved on 11 December 2008.

#### 2.2 Scope of the Project and Site Description

- 2.2.1. The design and construction of Wan Chai Development Phase II and Central Wanchai Bypass involves the construction and operation of primary and district distributor roads that is shown at *Figure 2.1*.
- 2.2.2. The key purpose of the study area encompasses the Wan Chai harbourfront area. The area starts at the boundary of Central Reclamation Phase III (CRIII) at the west and connects to the existing Hung Hing Road at the east. The scope of the project includes:
  - A dual 2-lane primary distributor road, Road P2, approximately 0.6km in length; and
  - Other new primary and district distributor roads connecting to the slip roads of the Central-Wan Chai Bypass with a total length of approximately 0.7km.
- 2.2.3. The project also contains various Schedule 2 DP that, under the EIAO, require Environmental Permits (EPs) to be granted by the DEP before they may be either constructed or operated. *Table 2.1* summarises the DP under this Project. *Figure 2.1* shows the locations of these Schedule 2 DP.

2.2.4. The designated project work II (DP2) was awarded to China State-Leader Joint Venture HK/2012/08 – Wan Chai Development Phase II Central – Wan Chai Bypass at Wan Chai West as part of the Project works by the Civil Engineering and Development Department (CEDD). The construction work under EP-376/2009 by Contract no. HK/2012/08 was commenced on 13 May 2015.



## 2.3 Project Organization and Contact Personnel

- 2.3.1 Civil Engineering and Development Department and Highway Department are the overall project controllers for the Wan Chai Development Phase II and Central-Wan Chai Bypass respectively. For the construction phase of the Project, Project Engineer, Contractor(s), Environmental Team and Independent Environmental Checker are appointed to manage and control environmental issues.

#### 3. MONITORING REQUIREMENTS

#### 3.1. Noise Monitoring

#### NOISE MONITORING STATION

3.1.1. The noise monitoring station for the Project is listed and shown in *Table 3.1* and *Figure 3.1*. *Appendix 3.1* shows the established Action/Limit Levels for the monitoring works.

#### NOISE MONITORING PARAMETERS, FREQUENCY AND DURATION

- 3.1.2. The construction noise level shall be measured in terms of the A-weighted equivalent continuous sound pressure level (L<sub>eq</sub>). L<sub>eq (30 minutes)</sub> shall be used as the monitoring parameter for the time period between 0700 and 1900 hours on normal weekdays. For all other time periods, L<sub>eq (5 minutes)</sub> shall be employed for comparison with the Noise Control Ordinance (NCO) criteria. Supplementary information for data auditing, statistical results such as L10 and L90 shall also be obtained for reference.
- 3.1.3. Noise monitoring shall be carried out at all the designated monitoring stations. The monitoring frequency shall depend on the scale of the construction activities. The following is an initial guide on the regular monitoring frequency for each station on a weekly basis when noise generating activities are underway:
  - One set of measurements between 0700 and 1900 hours on normal weekdays.

MONITORING EQUIPMENT

- 3.1.4. As referred to in the Technical Memorandum <sup>™</sup> issued under the NCO, sound level meters in compliance with the International Electrotechnical Commission Publications 651: 1979 (Type 1) and 804: 1985 (Type 1) specifications shall be used for carrying out the noise monitoring. Immediately prior to and following each noise measurement the accuracy of the sound level meter shall be checked using an acoustic calibrator generating a known sound pressure level at a known frequency. Measurements may be accepted as valid only if the calibration level from before and after the noise measurement agrees to within 1.0 dB.
- 3.1.5. Noise measurements shall not be made in fog, rain, wind with a steady speed exceeding 5 m/s or wind with gusts exceeding 10 m/s. The wind speed shall be checked with a portable wind speed meter capable of measuring the wind speed in m/s.



## 3.2. Air Quality Monitoring

#### AIR QUALITY MONITORING STATIONS

3.2.1. The air monitoring stations for the Project are listed and shown in *Table 3.2* and *Figure 3.1*. *Appendix 3.1* shows the established Action/Limit Levels for the monitoring works.

#### AIR MONITORING PARAMETERS, FREQUENCY AND DURATION

- 3.2.2. One-hour and 24-hour TSP levels should be measured to indicate the impacts of construction dust on air quality. The 24-hour TSP levels shall be measured by following the standard high volume sampling method as set out in the Title 40 of the Code of Federal Regulations, Chapter 1 (Part 50), Appendix B.
- 3.2.3. All relevant data including temperature, pressure, weather conditions, elapsed-time meter reading for the start and stop of the sampler, identification and weight of the filter paper, and any other local atmospheric factors affecting or affected by site conditions, etc., shall be recorded down in detail.
- 3.2.4. For regular impact monitoring, the sampling frequency of at least once in every six-days, shall be strictly observed at all the monitoring stations for 24-hour TSP monitoring. For 1-hour TSP monitoring, the sampling frequency of at least three times in every six-days should be undertaken when the highest dust impact occurs.

#### SAMPLING PROCEDURE AND MONITORING EQUIPMENT

- 3.2.5. High volume samplers (HVSs) in compliance with the following specifications shall be used for carrying out the 1-hour and 24-hour TSP monitoring:
  - 0.6 1.7 m<sup>3</sup> per minute adjustable flow range;
  - Equipped with a timing / control device with +/- 5 minutes accuracy for 24 hours operation;
  - Installed with elapsed-time meter with +/- 2 minutes accuracy for 24 hours operation;
  - Capable of providing a minimum exposed area of 406 cm2;
  - Flow control accuracy: +/- 2.5% deviation over 24-hour sampling period;
  - Equipped with a shelter to protect the filter and sampler;
  - Incorporated with an electronic mass flow rate controller or other equivalent devices;



- Equipped with a flow recorder for continuous monitoring;
- Provided with a peaked roof inlet;
- Incorporated with a manometer;
- Able to hold and seal the filter paper to the sampler housing at horizontal position;
- Easily changeable filter; and
- Capable of operating continuously for a 24-hour period.
- 3.2.6. Initial calibration of dust monitoring equipment shall be conducted upon installation and thereafter at bi-monthly intervals. The transfer standard shall be traceable to the internationally recognized primary standard and be calibrated annually. The concern parties such as IEC shall properly document the calibration data for future reference. All the data should be converted into standard temperature and pressure condition.

#### LABORATORY MEASUREMENT / ANALYSIS

- 3.2.7. A clean laboratory with constant temperature and humidity control, and equipped with necessary measuring and conditioning instruments to handle the dust samples collected, shall be available for sample analysis, and equipment calibration and maintenance. The laboratory should be HOKLAS accredited.
- 3.2.8. Filter paper of size 8" x 10" shall be labelled before sampling. It shall be a clean filter paper with no pinholes, and shall be conditioned in a humidity-controlled chamber for over 24-hours and be pre-weighed before use for the sampling.
- 3.2.9. After sampling, the filter paper loaded with dust shall be kept in a clean and tightly sealed plastic bag. The filter paper shall then be returned to the laboratory for reconditioning in the humidity controlled chamber followed by accurate weighing by an electronic balance with readout down to 0.1 mg. The balance shall be regularly calibrated against a traceable standard.
- 3.2.10. All the collected samples shall be kept in a good condition for 6 months before disposal.



# 4. MONITORING RESULTS

- 4.0.1. The environmental monitoring will be implemented based on the division of works areas of the designed project managed under the contract with FEP applied by contractor. Overall layout showing work areas of various contracts, latest status of work commencement and monitoring stations is shown in <u>Figure 2.1</u> and <u>Figure 3.1</u>. The monitoring results are presented in according to the Individual Contract(s).
- 4.0.2. In the reporting period, the concurrent contract is:
  - Contract no. HK/2012/08 Wan Chai Development Phase II Central Wan Chai Bypass at Wan Chai West.

#### 4.1. Noise Monitoring Results

- 4.1.1 Noise monitoring for project works under EP-376/2009 was commenced on 19 May 2015.
- 4.1.2 The proposed division of noise monitoring station is summarized in *Table 4.1* below.

- 4.1.3 Two limit level exceedances were recorded at M1a- Harbour Road Sports Centre on 4 and 24 May 2016 in May reporting month.
- 4.1.4 No construction works for EP-376/2009 was conducted around the concerned location during the time of measurement while breaking works at Ex-Wan Chai Swimming Pool (adjacent to Habour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 4 May 2016. As such, the exceedance was considered as non-Project related.
- 4.1.5 No construction works for EP-376/2009 was conducted around the concerned location during the time of measurement while hydromill tench cutter in close proximity to the monitoring station at Ex-Wan Chai Swimming Pool (adjacent to Habour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 24 May 2016. As such, the exceedance was considered as non-Project related.
- 4.1.6 Three limit level exceedances were recorded at M1a- Harbour Road Sports Centre on 7, 13 and 21 June 2016 in June reporting month.



- 4.1.7 No construction works under EP-376/2009 was conducted around the concerned location during the time of measurement on 7 and 13 June 2016 while operation of Hydromill tench cutter in close proximity to the monitoring station at Ex-Wan Chai Swimming Pool (adjacent to Harbour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 7 and 13 June 2016. As such, the exceedances were observed as non-Project related.
- 4.1.8 No construction works under EP-376/2009 was conducted around the concerned location during the time of measurement on 21 June 2016 while operation of breaking works opposite to monitoring station under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 21 June 2016. As such, the exceedance was considered as non-Project related.
- 4.1.9 One limit level exceedance was recorded at M1a- Harbour Road Sports Centre on 28 June 2016 in July reporting month.
- 4.1.10 No construction work under EP-376/2009 was conducted by Contract HK/2012/08 around the concerned location during the time of measurement on 28 June 2016 while operation of drill rig opposite to monitoring station under non-WDII-CWB Contractor was observed as the major noise contribution during monitoring. As such, the exceedance was considered as non-Project related.
- 4.1.11 The noise monitoring results measured in this reporting period are reviewed and summarized. Details of continuous noise monitoring results and graphical presentation can be referred to <u>Appendix 4.1</u>

#### 4.2. Air Quality Monitoring Results

- 4.2.1 Air Quality monitoring for project works under EP-376/2009 was commenced on 16 May 2015.
- 4.2.2 The proposed division of air quality monitoring stations are summarized in *Table 4.2* below.

#### 5. COMPLIANCE AUDIT

5.0.1. The Event Action Plan for construction noise and air quality are presented in Appendix 5.1.

#### 5.1. Noise Monitoring

- 5.1.1 Two limit level exceedances were recorded at M1a- Harbour Road Sports Centre on 4 and 24 May 2016 in May reporting month.
- 5.1.2 No construction works for EP-376/2009 was conducted around the concerned location during the time of measurement while breaking works at Ex-Wan Chai Swimming Pool (adjacent to Habour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 4 May 2016. As such, the exceedance was considered as non-Project related.
- 5.1.3 No construction works for EP-376/2009 was conducted around the concerned location during the time of measurement while hydromill tench cutter in close proximity to the monitoring station at Ex-Wan Chai Swimming Pool (adjacent to Habour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 24 May 2016. As such, the exceedance was considered as non-Project related.
- 5.1.4 Three limit level exceedances were recorded at M1a- Harbour Road Sports Centre on 7, 13 and 21 June 2016 in June reporting month.
- 5.1.5 No construction works under EP-376/2009 was conducted around the concerned location during the time of measurement on 7 and 13 June 2016 while operation of Hydromill tench cutter in close proximity to the monitoring station at Ex-Wan Chai Swimming Pool (adjacent to Harbour Road Sports Centre immediately opposite to the monitoring station) under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 7 and 13 June 2016. As such, the exceedances were observed as non-Project related.
- 5.1.6 No construction works under EP-376/2009 was conducted around the concerned location during the time of measurement on 21 June 2016 while operation of breaking works opposite to monitoring station under non WDII-CWB Contractor was observed as the major noise contribution during monitoring on 21 June 2016. As such, the exceedance was considered as non-Project related.
- 5.1.7 One limit level exceedance was recorded at M1a- Harbour Road Sports Centre on 28 June 2016 in July reporting month.
- 5.1.8 No construction work under EP-376/2009 was conducted by Contract HK/2012/08 around the concerned location during the time of measurement on 28 June 2016 while operation of drill



rig opposite to monitoring station under non-WDII-CWB Contractor was observed as the major noise contribution during monitoring. As such, the exceedance was considered as non-Project related.

#### 5.2. Air Quality Monitoring

5.2.1 No action or limit level exceedance was recorded in this reporting quarter.

#### 5.3. Site Audit

5.3.1 There was no non-compliance from the site audits in the reporting period. During environmental site inspections conducted during the reporting period, minor deficiencies were noted.

#### 5.4. Review of the Reasons for and the Implications of Non-compliance

5.4.1 There was no non-compliance from the site audits in the reporting period.

#### 5.5. Summary of action taken in the event of and follow-up on non-compliance

5.5.1 There was no particular action taken since no project-related non-compliance was recorded from the site audits and environmental monitoring in the reporting period.



#### 6. COMPLAINTS, NOTIFICATION OF SUMMONS AND PROSECUTION

- 6.0.1. No environmental complaint received in this reporting quarter.
- 6.0.2. The details of cumulative complaint log and summary of complaints are presented in *Appendix* 6.1.
- 6.0.3. No notification of summons or prosecution was received in the reporting period. Cumulative statistic on complaints and successful prosecutions are summarized in *Table 6.1* and *Table 6.2* respectively.

#### 7. CUMULATIVE CONSTRUCTION IMPACT DUE TO THE CONCURRENT PROJECTS

- 7.0.1. According to the Condition 3.4 of the EP-376/2009, this section addresses the relevant cumulative construction impact due to the concurrent activities of the current projects including the Central Reclamation Phase III (CRIII), Wan Chai Development Phase II (WDII), Central-WanChai Bypass (CWB), Island Eastern Corridor Link projects (IECL) and Wan Chai Development Phase II Central Wan Chai Bypass at Wan Chai East (CWB Tunnel).
- 7.0.2. According to the Final EM&A report of Central Reclamation Phase III (CRIII) for Contract HK 12/02, the major construction activities were completed by end of January 2014 and no construction activities were undertaken thereafter and the water quality monitoring was completed in October 2011. As such, it is considered that there were no cumulative construction impact due to the concurrent activities of the current projects with the Central Reclamation Phase III (CRIII) undertaken by contractor HK12/02 in the reporting period.
- 7.0.3. According to the construction programme of Central-Wanchai Bypass at Wanchai West at the Central Reclamation Phase III area include structural works for tunnel construction, road works and drainage works, and seawall modification were performed in July 2016 reporting month. As no project related exceedance were recorded during the reporting period, cumulative construction impact due to the concurrent activities of the current projects with the Central Reclamation Phase III (CRIII) was considered as insignificant.
- 7.0.4. According to the construction programme of Wan Chai Development Phase II, Central-Wan Chai Bypass and Island Eastern Corridor Link projects, the major construction activities under Wan Chai Development Phase II were tunnel works at Wan Chai East and culvert construction, tunnel construction and ELS works at Wan Chai West. The major construction activities under Central-Wan Chai Bypass and Island Eastern Corridor Link Projects were road works and ventilation building construction at Central Interchange, temporary reclamation removal works at Ex-PCWAW, ELS works and retaining wall construction at Victoria Park, ELS works and tunnel works at TS3; bridge construction, piling and tunnel works at North Point area in the reporting month. In addition, other non-Wan Chai Development Phase II, Central-Wan Chai Bypass and Island Eastern Corridor Link projects was observed undertaken at Wan Chai North and North Point area.
- 7.0.5. No significant air quality impact from construction activities was anticipated in the reporting period. Besides, no project related exceedance was recorded during air quality and noise environmental monitoring events in the reporting period. Thus, it is evaluated that the cumulative construction impact from the concurrent projects including Central Reclamation Phase III (CRIII), Wan Chai Development Phase II (WDII), Central-WanChai Bypass (CWB), Island Eastern Corridor Link projects (IECL) was insignificant.



#### 8. CONCLUSION

- 8.0.1. The EM&A programme was carried out in accordance with the EM&A Manual requirements, minor alterations to the programme proposed were made in response to changing circumstances.
- 8.0.2. No non-compliance and no prosecutions were received during the reporting period.
- 8.0.3. Mitigation measures according to the environmental mitigation implementation schedule and the EIA were generally implemented by the Contractor in this reporting period. Environmental site audit was conducted by the Environmental Team and the Independent Environmental Checker and no cumulative environmental impact was identified in the reporting period. Hence, the EM&A programme was considered effective and shall be maintained.
- 8.0.4. The construction programmes of individual contracts are provided in *Appendix 8.1*.

Project Layout














## Graphic Presentation of Noise Monitoring Result Day Time (0700 - 1900hrs on normal weekdays)









Sampling, Field Measurement and Testing Work (Stage 3)




#### Graphic Presentation of 24 hour TSP Result for EP-376/2009




