 Ex-Government Logistics Department-Kowloon Bay Cargo Handling Area: It is currently vacant. The site is a vacant land with concrete paving and no suspicious land contamination hotspots were identified.

Zone (STT)KX2569: It is paved with concrete and most of the site is currently empty. Some of the
area is used for material storage, e.g. concrete blocks, guard houses, containers, pipes, etc and no
suspicious land contamination hotspots were identified.

As such, it is considered there would unlikely be any potential hotspots of land contamination and hence no Supplementary Contamination Assessment Plan (CAP)/Site Investigation (SI) would be carried out.



Year	Land Use	
~1963 to ~1966	Reclamation works in progress.	
~1983 to~2005	A cement work at the northeast boundary of the hard paved site and a sand depot at the rest of the site.	
Since 1991	The sand depot had been removed and the cargo working area being operated at the southeast boundary of the site.	
~ 2006	The cement work was demolished and the area being operated with site office and open storage area.	
~ 2012	The site office and open storage area were demolished. The ex-Public Cargo Working Area was still in operation.	
2013	The site is vacant.	

Based on our review of the historic aerial information and land use, it is considered there would unlikely be suspicious activities or potential hotspots of land contamination identified.
