1.0 Executive Summary

1.1 In July 2019, Telemax Environmental and Energy Management Limited (TEEM) was appointed to conduct an Environmental Monitoring and Audit (EM&A) program for operation phase for the proposed Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot, Yen Ming Road, West Kowloon Reclamation Area (FEHD). FEHD noticed EPD that the operation date of the project was 28 June 2019 and all EM&A works were undertaken in accordance with the EM&A Manual and the requirements under the Environmental Permit EP-454/2013. The notification letter was attached in *Appendix I*. This report is the ninth monthly EM&A report, which detailed the environmental monitoring and audit results recorded during the period from 1 March 2020 to 31 March 2020.

Reporting Change

1.2 There was no reporting change required in the reporting month.

Record of Complaints

1.3 No environmental complaint was recorded in the reporting month.

Record of Notification of Summons and Successful Prosecution

1.4 No notification of summons and successful prosecution was received in the reporting month.

Odor Monitoring Status

- 1.5 According to EM&A manual, a commissioning test for the deodorization equipment should be conducted in commissioning phase. The commissioning tests for three (3) scrubbers were conducted from 19 June 2019 to 5 July 2019. The odor removal efficiency of all scrubbers complied with the EIA requirement (i.e. more than 85% of odor removal efficiency). The test reports were attached in *Appendix C*.
- 1.6 According to the EM&A manual, a quarterly basis odor removal test should also be carried out during the first year of operation in order to ensure adequate maintenance and operation of the deodorization equipment. If all results fulfil the minimum

requirement, i.e. at least 85% of odor removal efficiency, the odor monitoring program can be ceased. Otherwise, the program shall be increased to monthly monitoring and extended until in consecutive 3 times fulfilling the minimum.

1.7 The first quarterly basis odor monitoring was carried out on 5 September 2019. The second quarterly basis odor monitoring has been carried out on 5 December 2019. Due to the COVID-19, the third quarterly basis odor monitoring was postponed. The updated odor monitoring and investigation plan was attached in *Appendix J*. The details of the monitoring date were shown in *Appendix D*. In the latest quarterly basis odor monitoring carried out in December, all three deodorization equipment showed more than 85% odor removal efficiency.





2.0 **Project Information**

Background

- 2.1 The project proponent is the reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot, Yen Ming Road, West Kowloon Reclamation Area (FEHD) and the Works Agent is the Architectural Services Department (ArchSD).
- 2.2 The proposed office-cum-vehicle depot building will be a five-story building comprising various facilities for vehicle washing and repair operation, parking of vehicles as well as offices. It will occupy a site area of about 8,278 m².
- 2.3 The Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot is categorized as a designated project under the Environmental Impact Assessment Ordinance (EIAO) and therefore a detailed Environmental Impact Assessment (EIA-216/2013) has been conducted in year 2013 and an Environmental Permit number EP-454/2013 was issued by Environmental Protection Department in November 2013.
- 2.4 The subject site is located at Yen Ming Road, West Kowloon Reclamation Area given in *Appendix F*. The subject site is bounded to the north by Nam Cheong Station, to the east by CLP Tak Kok Tsui Substation, to the south by Yuen Fat Building, and to the west by Cheung Sha Wan Wholesales Fish and Food Markets. Sir Ellis Kadoorie Secondary School (West Kowloon) and Fu Cheong Estate Fu Yun House, being the nearest educational and residential establishment, are located at around 100m and 270m from the site boundary respectively.
- 2.5 The operation date of the project was 28 June 2019. A notification letter of the operation date was sent to EPD on 28 May 2019. The notification letter was attached in *Appendix I*.

4.0 Summary of EM&A Requirement

4.1 According to the environmental findings detailed in the Environmental Impact Assessment (EIA) report and the EM&A Manual of the Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot at Yen Ming Road, West Kowloon Reclamation Area Project ("the Project"), the EM&A requirements of the noise, air quality, water quality, waste management, landscape and visual and environmental audit are summarized as follows:





Air

4.2 According to the EIA report, the EM&A works related to traffic air quality for the operational phase in not considered as necessary. However, the odor is expected to result in significant impact to the adjacent sensitive receivers during the operational phase. Therefore, a commissioning test and a quarterly basis odor monitoring program are required for this project.

Noise

4.3 According to the EIA report, noise monitoring during the operation phase are considered not necessary as the project would not be expected to result in significant noise impact to adjacent identified NSRs with the implementation of the recommended mitigation measures.

Water

4.4 According to EIA report, EM&A for water quality is considered not necessary.

Waste Management and Land Contamination

4.5 According to EIA report, the land contamination at the project is identified to be insignificant during operation phase, no EM&A for contaminated land is recommended.

Landscape and Visual

4.6 Since 15 trees within the project site was fell, compensatory trees were adopted as mitigation measures to compensate for the tress lost. The compensatory trees were planted in June 2019, and the as-built landscape drawings and photo records were approved by EPD.

Environmental Audit

4.7 According to Table 10-1 of the EIA report, no audit is required in operational phase while the odor monitoring is required.



Monitoring Methodology – Quarterly Basis Monitoring 5.0

Monitoring Parameter

- 5.1. Odor monitoring in a quarterly basis odor monitoring for the first year of operation is required for the project. The requirement is at least 85% of odor removal efficiency for each deodorization equipment.
- Passive sampling technique at the sampling locations will be applied. A Nalophan 5.2. sampling bag will be placed inside an air-tight sampler and then drawn to vacuum for sampling. Approximately 60 liters of gas sample is collected into the sampling bag for testing.
- 5.3. All samples will be collected during normal operation hour, and the collected samples shall be returned to laboratory for olfactometry analysis within 24 hours after sampling.

Olfactometry Analysis

- 5.4. Odor concentration of the sample is determined by Forced-choice Dynamic Olfactometer in accordance to European Standard Method: BS EN 13725.
- 5.5. Testing should be performed by five qualified panelists who have been trained and complied with the requirement of the European Standard Method: BS EN 13725 in the range of 20 to 80 ppv/v and a standard deviation of R < 2.3.
- 5.6. Testing shall be started immediately after sample receipt and all testing to be completed with 24 hours after sampling.
- 5.7. The odor concentration is measured by determining the dilution factor required to reach the detection threshold. The odor concentration at the detection threshold is by definition 1 OU_E/m^3 . The odor concentration is then expressed in terms of multiples of the detection threshold. The reporting limit for the olfactometry analysis is $11 \text{ OU}_{\text{F}}/\text{m}^3$.



Monitoring Locations

5.8. The designated locations for the odor monitoring were listed in *Table 4* and were shown in *Appendix E*.

6.0 Monitoring Results

- 6.1. Due to the COVID-19, the third Odor Monitoring, which is scheduled to be carried out in March 2020, will be postponed until either one of the following situations is met:
 - a. The date of resumption of classes (Secondary School) announced by the Education Bureau; or
 - b. No new cases of Novel Coronavirus in 28 consecutive days.
- 6.2. Due to the postponement of Odor Monitoring, the schedule will be changes and the amendment is as follows:
 - a. If the third Odor Monitoring can be carried out in April 2020, the fourth Odor Monitoring, which is the last Odor Monitoring, will be kept in June 2020;
 - b. If the third Odor Monitoring cannot carry out in April 2020, the fourth Odor Monitoring will be 3 months after the third Odor Monitoring.

The updated odor monitoring and investigation plan was attached in Appendix J.



7.0 Non-compliance, Complaints, Notifications of Summons and

Status of Prosecutions

Record on Environmental Complaints Received

7.1 No environmental complaint was received in this month. The cumulative statistics on complaints were provided in *Appendix G*.

Record on Notifications of Summons and Successful Prosecution

7.2 No notification of summons or successful prosecution was received this month. The cumulative statistics on notifications of summons and successful prosecutions were provided in *Appendix G*.

Review of Reasons for and Implications of Non-compliance, Complaints, Summons and Prosecutions

7.3 As no notification of summon or successful prosecution was received, the associated review was not required.

Follow-up Actions Taken

7.4 As no notification of summons or successful prosecution was received, the associated follow-up action was not required.

8.0 Commissioning Tests for the Deodorization Equipment

8.1 The commissioning tests were carried out during 19 June 2019 to 5 July 2019 for three
(3) scrubbers, namely WSF-UGF-1, WSF-UGF-2 and WSF-UGF-3. All scrubbers performed more than 85% odor removal efficiency. The latest results were listed in *Table 5* and the test reports were attached in *Appendix C*.


9.0 **Comments, Recommendations and Conclusions**

- 9.1 Environmental impact monitoring had been carried out for Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot, Yen Ming Road, West Kowloon Reclamation Area.
- 9.2 The operation date of the project was 28 June 2019, which a notification letter of the operation date was sent to EPD on 28 May 2019.
- 9.3 In the reporting period, no environmental complaint and no notification of summons or successful prosecution was received.
- 9.4 The commissioning tests were carried out during 19 June 2019 to 5 July 2019. All scrubbers complied with the requirement, which performed more than 85% odor removal efficiency.

Due to the COVID-19, the third quarterly basis odor monitoring was postponed. The updated odor monitoring and investigation plan was attached in Appendix J. The details of the monitoring date were shown in *Appendix D*. In the latest quarterly basis odor monitoring carried out in December, all three deodorization equipment showed more than 85% odor removal efficiency.

1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.
- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358) and Noise Control Ordinance (Cap. 400). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.
- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in <u>Part A</u> of the Permit readily available at all times for inspection by the Director or his authorised officers at all sites/offices covered by this Permit. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.
- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in the Permit. The site(s) refers to site(s) of construction of the Project and shall mean the same hereafter.
- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).
- 1.6 The Permit Holder shall construct and operate the Project in accordance with the project description in <u>Part B</u> of this Permit.
- 1.7 The Permit Holder shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No.: AEIAR-177/2013), the application document for environmental permit (Application No.: AEP-454/2013), other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or impliedly amended in this Permit.
- 1.8 All deposited submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director.
- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in <u>Part C</u> of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap. 499). All submissions or any variation of the submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent

36



Environmental Checker (IEC) referred to in Conditions 2.1 and 2.2 below, before submitting to the Director under this Permit.

- 1.10 The Permit Holder shall release all finalized submissions as required under this Permit, to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places, or any internet websites as specified by the Director, or by any other means as specified by the Director for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.
- All submissions to the Director required under this Permit shall be delivered either in person or by 1.11 registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.
- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than one month prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction.
- 1.13 For the purpose of this Permit, "commencement of construction works" does not include works related to site clearance and preparation, or other works as agreed by the Director.
- 1.14 The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than one month prior to the commencement of operation of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the operation.

2. Specific Conditions

Submissions and/or Measures before Commencement of Construction of the Project

Employment of Environmental Monitoring and Audit (EM&A) Personnel

- 2.1 An Environmental Team (ET) shall be established by the Permit Holder no later than one month before commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management. The ET and the ET Leader shall be responsible for the implementation of the EM&A programme in accordance with the EM&A requirements as contained in the EM&A Manual of the Project. The ET Leader shall keep a contemporaneous log-book of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the EIA Report and this Permit. The ET Leader shall notify the IEC within one working day of the occurrence of any such instance or circumstance or change of circumstances. The ET Leader's log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the EIA Report and this Permit or by the Director or his authorized officers. Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the EM&A Manual of the Project or failure to comply with this Condition would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Failure by the Permit Holder to make replacement, or further failure to keep contemporaneous records in the log-book despite the employment of a new ET Leader may render the Permit liable to suspension, cancellation or variation.
- 2.2 An IEC shall be employed by the Permit Holder no later than one month before commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or



environmental management. The IEC shall be responsible for duties defined in the EM&A Manual and shall audit the overall EM&A performance, including the implementation of all environmental mitigation measures, submissions required in the EM&A Manual, and any other submissions required under this Permit. In addition, the IEC shall be responsible for verifying the environmental acceptability of permanent and temporary works, relevant design plans and submissions under this Permit. The IEC shall verify the log-book(s) mentioned in Condition 2.1 of this Permit. The IEC shall notify the Director by fax, within one working day of receipt of notification from the ET Leader of each and every occurrence, change of circumstances or non-compliance with the EIA Report (Register No.: AEIAR-177/2013) and this Permit, which might affect the monitoring or control of adverse environmental impacts from the Project. In the case where the IEC fails to so notify the Director of the same, fails to discharge the duties of the IEC as defined in the EM&A Manual or fails to comply with this Condition, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render the Permit liable to suspension, cancellation or variation. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition.

Management Organization of Main Construction Company

2.3 The Permit Holder shall, no later than two weeks before the commencement of construction of the Project, inform the Director in writing the management organization of the main construction companies and/or any form of joint venture associated with the construction of the Project. The submitted information shall include at least an organization chart, names of responsible persons and their contact details.

Submission of Landscape and Visual Mitigation Plan of the Project

- 2.4 The Permit Holder shall, at least one month before the commencement of construction of the corresponding component(s) of the Project, submit four hard copies and one electronic copy of a Landscape and Visual Mitigation Plan(s) to the Director for approval. The Plan(s) shall include at least the following information:
 - one (1) existing tree to be retained in-situ at the location marked in Figure 2; (a)
 - a tree compensation proposal showing the locations, size, number and species of trees to be (b) planted, including the compensation of at least 27 trees of heavy standard size (100mm DBH), in accordance with the recommended tree species in Table 1 and Table 2; and
 - an updated landscape design for ground floor planting, vertical greening, roof gardens and hard (c) landscape features.

The Landscape and Visual Mitigation Plan(s) shall be certified by the ET leader and verified by the IEC as conforming to the information and recommendations of landscape and visual mitigation measures contained in the EIA Report (Register No.: AEIAR-177/2013).

Submissions and/or Measures before and During Operation of the Project

Measures and Submission for Mitigating Landscape and Visual Impact before Operation of the Project

- 2.5 The landscape and visual mitigation measures shall be fully and properly implemented in accordance with the recommendations of the Landscape and Visual Mitigation Plan(s) approved under condition 2.4 above.
- 2.6 The Permit Holder shall, at least one month before the commencement of the operation of the Project, deposit with the Director four hard copies and one electronic copy of the As-Built Drawing(s) of the Project, which shall be certified by the ET Leader and verified by the IEC as conforming to the recommendations of the Landscape and Visual Mitigation Plan(s) approved under condition 2.4 above. The landscape and visual mitigation measures shall be properly maintained during operation of the

Project.

Measures for Mitigating Odour Impact during Operation of the Project

- 2.7 All refuse collection vehicles shall be emptied of refuse prior to entering the Project.
- 2.8 To mitigate operational odour impact arising from the vehicle washing bays and the maintenance workshops of the Project:-
 - (a) the washing bays and maintenance workshops shall be enclosed in 3 sides and served with mechanical ventilations to maintain with proper negative air pressure at all times during the washing bays and maintenance workshops operation; and
 - (b) a deodorisation system, with an odour removal efficiency of at least 85%, shall be installed, operated and properly maintained at the ventilation system prior to discharging any vented air outside the Project.

Measures for Mitigating Noise Impact during Operation of the Project

- 2.9 To mitigate operational noise impact from the repair activities from the vehicles, the following measures shall be implemented:
 - (a) all vehicle repair activities shall be limited to 0700 to 1900 hours only; and
 - (b) all vehicle repair activities shall be carried out within the covered area of the transport workshop section on ground floor of the Project as shown in <u>Figure 2</u>.
- 2.10 To minimise off-site traffic noise impact arising from the operation of the Project, all vehicles coming in or out of the Project shall use the in-bound and out-bound traffic routing as shown in Figure 3.

3. Environmental Monitoring and Audit Requirements

- 3.1 The EM&A programme shall be implemented in accordance with the procedures and requirements as set out in the EM&A Manual. Any change to the EM&A requirements or programme shall be justified by the ET Leader and verified by the IEC as conforming to the relevant requirements set out in the EM&A Manual and shall seek the prior approval from the Director before implementation.
- 3.2 Samples, measurements and necessary remedial actions shall be taken in accordance with the requirements of the EM&A Manual by:
 - (a) conducting baseline environmental monitoring;
 - (b) conducting impact monitoring;
 - (c) carrying out remedial actions described in Event/Action Plans of the EM&A Manual in accordance with the time frames set out in Event/Action Plans, or as agreed by the Director, in case where specified criteria in the EM&A Manual are exceeded; and
 - (d) logging and keeping records of details of all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available for inspection on site.
- 3.3 Four hard copies and one electronic copy of the Baseline Monitoring Report shall be submitted to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the submission shall be





provided upon request by the Director.

- 3.4 Four hard copies and one electronic copy of monthly EM&A Report shall be submitted to the Director within 10 working days after the end of each reporting month throughout the entire construction period. The monthly EM&A Reports shall include a summary of all non-compliance. The submissions shall be certified by the ET Leader and verified by the IEC as complying with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of submission shall be provided upon request by the Director.
- 3.5 All EM&A data submitted under this Permit shall be true, valid and correct.

4. Electronic Reporting of EM&A Information

- 4.1To facilitate public inspection of EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hardcopies as described in Condition 3.3 and 3.4 of this Permit. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hardcopies.
- 4.2 The Permit Holder shall, within six weeks after the commencement of construction of the Project, set up a dedicated web site and notify the Director in writing the Internet address where the environmental monitoring and project data is to be placed. All environmental monitoring data described in Condition 4.1 above shall be made available to the public via a dedicated web site to be set up by the Permit Holder in the shortest practicable time and in no event later than two weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the construction period of the Project, or otherwise as agreed by the Director.
- 4.3 The Internet website as described in Condition 4.2 above shall enable user-friendly public access to the monitoring and project data including the Project Profile, the approved EIA Report, the Environmental Permit(s) and all finalised submissions required under this Permit. The Internet website shall have features capable of:
 - (a) providing access to all environmental monitoring data collected since the commencement of works;
 - (b) providing access to all finalized submissions as required under this Permit;
 - searching by date; (c)
 - (d) searching by types of monitoring data; and
 - hyperlinks to relevant monitoring data after searching; (e)

or otherwise as agreed by the Director.


Figure 1 Figure 2 Figure 3







Reporting in accordance with this Condition does not relieve the Licensee of any obligations imposed by this licence.

1.0 Project Information

Background

- 1.1 The project proponent is the Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cum-vehicle Depot, Yen Ming Road, West Kowloon Reclamation Area (FEHD) and the Works Agent is the Architectural Services Department (ArchSD).
- 1.2 The proposed office-cum-vehicle depot building will be a five-story building comprising various facilities for vehicle washing and repair operation, parking of vehicles as well as offices. It will occupy a site area of about 8,278 m².
- 1.3 The Reprovisioning of FEHD Sai Yee Street Environmental Hygiene Offices-cumvehicle Depot, Yen Ming Road, West Kowloon Reclamation Area is categorized as a designated project under the Environmental Impact Assessment Ordinance (EIAO) and therefore a detailed Environmental Impact Assessment (EIA-216/2013) has been conducted in year 2013 and an Environmental Permit number EP-454/2013 was issued by Environmental Protection Department in November 2013.
- 1.4 The subject site is located at Yen Ming Road, West Kowloon Reclamation Area given in Appendix B. The subject site is bounded to the north by Nam Cheong Station, to the east by CLP Tak Kok Tsui Substation, to the south by Yuen Fat Building, and to the west by Cheung Sha Wan Wholesales Fish and Food Markets. Sir Ellis Kadoorie Secondary School (West Kowloon) and residential buildings on Nam Cheong Station, being the nearest educational and residential establishment, are located at around 100m and 120m from the site boundary respectively.

- 1.6 The management structure is given in **Appendix A**. The project layout is shown in **Appendix B**.
- 1.7 The Certificate of Completion was issued on 22 November 2018. The Certificate of Completion is shown in Appendix C. The commencement date of full operation of the project was on 28 June 2019 as shown in the notification letter in Appendix D.
- 1.8 As stipulated in the EM&A Manual Clause 2.4.5, odor monitoring shall be carried out quarterly for the first year of operation. The monitoring and investigation procedures will be mentioned in this plan.





Odor Monitoring and Investigation 2.0

Odor Monitoring

- As stated in the EM&A Manual Clause 2.4.5, the odor removal efficiency if the 2.1 proposed odor removal unit shall be tested quarterly for the first year of operation. To cope with this, ALS Laboratory Group (Hong Kong) was appointed as Odor Team who is responsible for the odor testing and analysis. The requirement is at least 85% of odor removal efficiency for each deodorization equipment.
- 2.2 The methodology of odor monitoring is attached in Appendix E. In this Project, 3 odor removal units are used and samples will be taken at the inlet and outlet points. The inlet point, outlet point and the corresponding deodorization equipment are summarized in *Table 2.1*.

- 2.3 The commissioning test was completed in July 2019. The quarterly basis odor monitoring was carried in September 2019 and December 2019. The tentative schedule of the odor monitoring is shown in Appendix F. Based on the proposed schedule, the final quarterly basis odor monitoring will be carried out in June 2020 if no failure is found. Once the Project fails to meet the requirement, the monitoring schedule will be increased to monthly monitoring instead of quarterly monitoring, and extended until consecutive 3 times fulfilling the requirement.
- Due to the COVID-19, the 3rd Odor Monitoring, which is scheduled to be carried out in 2.4 March 2020, will be postponed until either one of the following situations is met:
 - The date of resumption of classes (Secondary School) announced by the a.





Education Bureau; or

- b. No new cases of Novel Coronavirus in 28 consecutive days.
- 2.5 Due to the postponement of Odor Monitoring, the schedule will be changed and the amendment is as follows:
 - a. If the 3rd Odor Monitoring can be carried out in April 2020, the 4th Odor Monitoring, which is the last Odor Monitoring, will be kept in June 2020;
 - b. If the 3rd Odor Monitoring cannot carry out in April 2020, the 4th Odor Monitoring will be 3 months after the 3rd Odor Monitoring.
- 2.6 The Odor Team will prepare a report after the monitoring and the report will be attached in the monthly EM&A report.


- 2.7 Once the result shows that the deodorization unit cannot achieve at least 85% odor removal efficiency, the Odor Team will inform Project Proponent, Independent Environmental Checker and Environmental Team to disable the unit and close the corresponding area to avoid any activities.
- 2.8 Project proponent will contact the contractor to check if deodorization unit malfunctions. After checking and repairing, a testing and commissioning shall be carried out for the deodorization unit to check if it can achieve the stipulated requirement.
- 2.9 The testing and commissioning record shall be certified by Environmental Team and verified by Independent Environmental Checker.





Odour Removal Efficiency Testing Methodology

A. ODOUR MONITORING

Odour Sampling

Ambient Air samples will be collected by passive sampling technique at the odour monitoring station. A Nalophan[™] sampling bag will be placed inside an air-tight sampler and then drawn to vacuum for sampling. Approximately 60 litre of gas sample is collected into the sampling bag for testing. A diagram of the passive sampling equipment that will be used for the sampling is shown below:






Fig 1a: Passive Sampler of Sampling Device

During sampling, following items will be recorded:

- ambient temperature;
- relative humidity;
- wind speed; and
- wind direction
- photo showing the sampling locations relative to existing land features.

All samples will be collected during normal operation hour, and the collected samples shall be returned to laboratory for olfactometry analysis within 24 hours after sampling.

Olfactometry Analysis

- a. Odour concentration of the sample is determined by Forced-choice Dynamic Olfactometer in accordance to European Standard Method: BS EN13725.
- b. Testing should be performed by five qualified panellists who have been trained and complied with the requirement of the European Standard Method: BS EN13725 in the range of 20 to 80 ppb/v and a standard deviation of R < 2.3.
- c. Testing shall be started immediately after sample receipt and all testing to be completed with 24 hours after sampling.

The odour concentration is measured by determining the dilution factor required to reach the detection threshold. The odour concentration at the detection threshold is by definition 1 OU_{ϵ}/m^3 . The odour concentration is then expressed in terms of multiples of the detection threshold.

The laboratory is HOKLAS accredited for the measurement of odour concentration for BS EN13725:2003 (by dynamic olfactometry). The Reporting Limit for the Olfactometry Analysis is $11 \text{ OU}_{\text{E}}/\text{m}^3$.



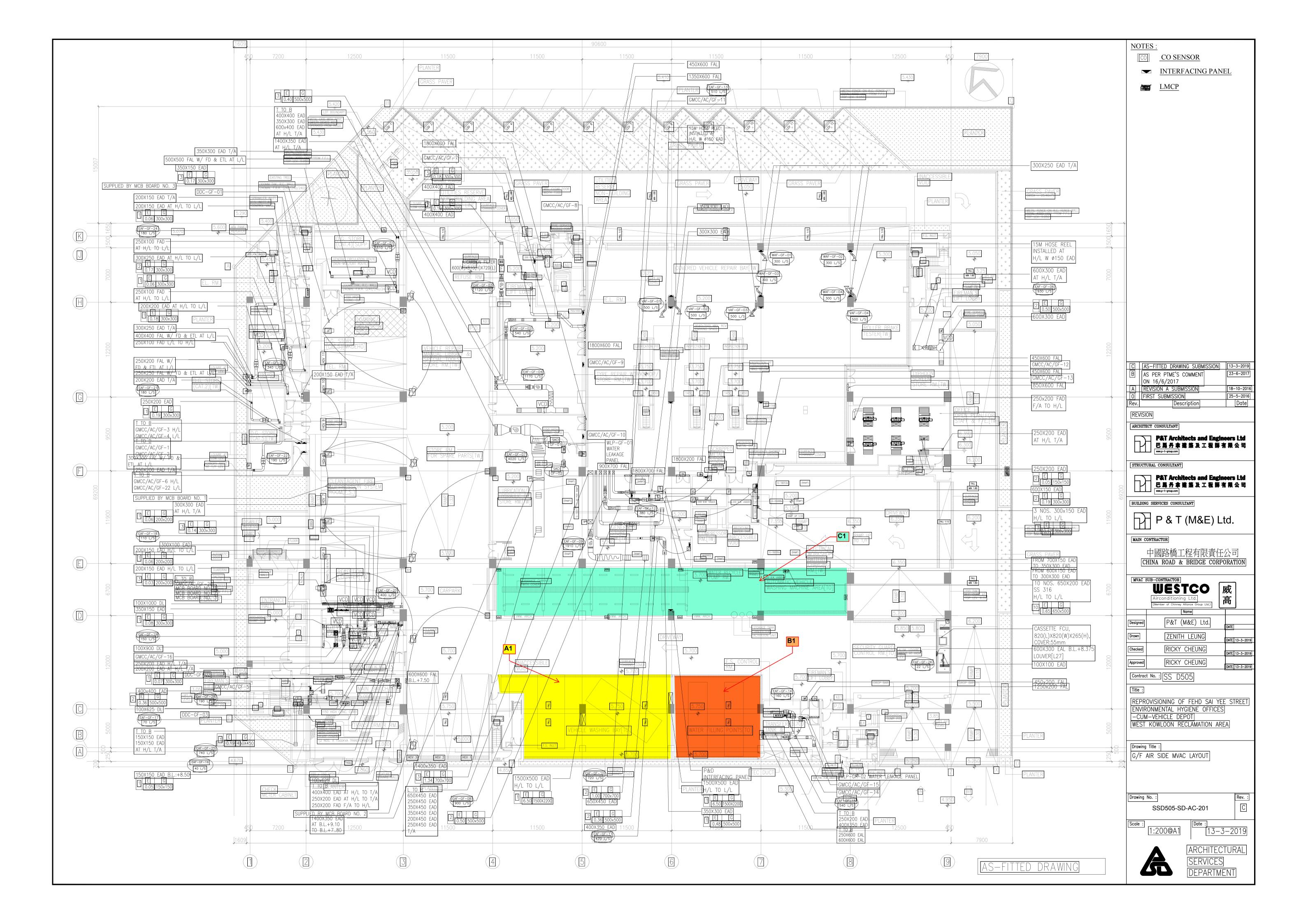
Fig 2: Scentroid[™] SS600 Olfactometer

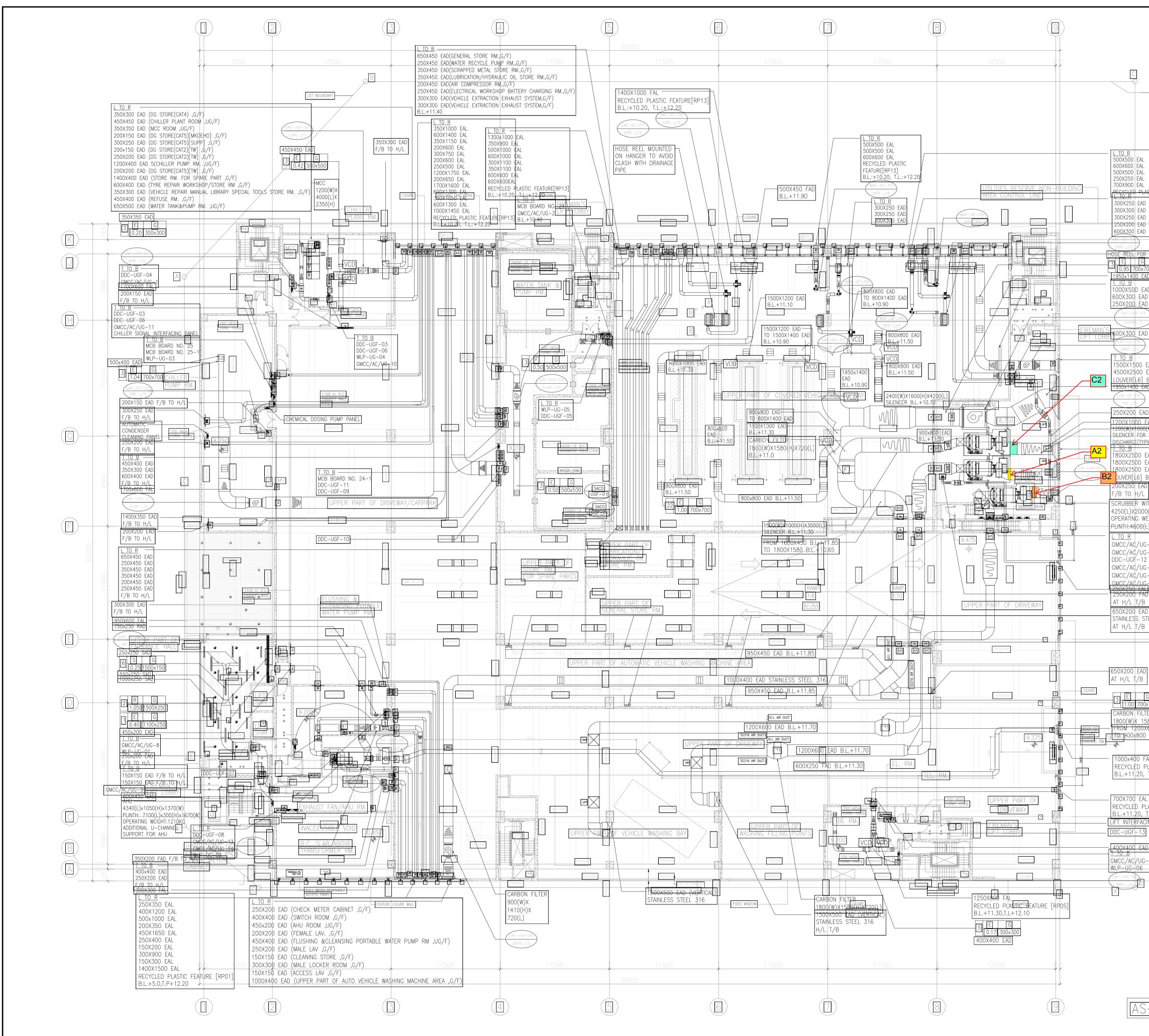

During each odour sampling day, one blank sample should be collected for quality control. The sample will be taken by purging pure nitrogen gas into the odour bag directly on site as a blank sample.

Calibration of Instrument

All equipment for odour measurement and analysis shall be calibrated in according to the requirement of the European Standard Method EN13725.
