Executive Summary

This is the 9th Quarterly Environmental Monitoring & Audit (EM&A) Report for the construction phase of the Kai Tak Sports Park (KTSP) Project which summaries findings of the EM&A programme during the reporting period from 1 April 2021 to 30 June 2021 (the "reporting period") under the Environmental Permit (No. EP-544/2017) requirement.

Environmental Monitoring and Audit Progress

2 Summary of EM&A Requirement

2.1 EM&A Requirement

In accordance with the EM&A Manual of the Project, the EM&A programme was established to assure compliance with the standards and predictions in the EIA study involving the construction and operation of the Project. The environmental performance was routinely monitored and audited for evaluating the effectiveness of the recommended mitigation measures or remedial action. Impact air quality and noise monitoring were required for the Project.

Air Quality

2.2 Air Quality Monitoring Parameters, Frequency and Duration

Table 2.1 summarises the monitoring parameters, frequency and duration of impact air quality monitoring.

2.3 Air Quality Monitoring Locations

According to the EM&A Manual, a total of five air quality monitoring stations are identified for impact monitoring. AMS1 and AMS2 were set up at the proposed locations for impact monitoring during the reporting period. AMS3, AMS4 and AMS5 are planned residential use and were currently not available for impact monitoring.

Table 2.2 describes the impact air quality monitoring stations and <u>Figure 2.1</u> shows their locations.

During the reporting period, monitoring locations AMS1 and AMS2 were set up at the proposed locations for impact monitoring.

Permission on setting up and carrying out impact monitoring works at AMS3, AMS4 and AMS5 will be sought once each respective development is completed and occupied.

2.5 Wind Data

Wind data at Kai Tak automatic weather station collected from the Hong Kong Observatory (HKO) were used for the air quality monitoring for recording wind speed and wind direction. It is considered that the wind data obtained at the existing Kai Tak wind station are representative of the Project area and could be used for undertaking the construction phase baseline and impact air quality monitoring programme for the Project.

The detail of the wind data is shown in **Appendix F**.

Noise

2.6 Noise Monitoring Parameters, Frequency and Duration

Table 2.4 summarises the monitoring parameters, frequency and duration of impact noise monitoring.

2.7 Noise Monitoring Locations

NMS1 and NMS2 were set up at the proposed locations for impact monitoring during the reporting period. NMS1A, NMS2A, NMS3, NMS4 and NMS5 are planned residential use and were currently not available for impact monitoring.

4 Comments, Recommendations and Conclusion

4.1 Comments

Mitigation measures in the EM&A Manual were implemented during the reporting period. The weekly environmental site inspections ensured that all the environmental mitigation measures recommended were effectively implemented. Based on observation from the site inspections, landscape audits, and the air quality and noise impact monitoring results recorded, it was considered that mitigation measures were effective and efficient in controlling the potential impacts due to construction of the project during the reporting period.

4.2 Recommendations

During the reporting period, the following recommendations were provided:

April 2021

KTSP

- The contractor was reminded to provide drip tray for the chemical containers.
- The contractor was reminded to maintain regular cleaning for the drainage channel.
- The contractor was reminded to provide covering for the stockpiles on site.
- The contractor was reminded to clear the oil stain as soon as possible.
- The contractor was reminded to clear the stagnant water.
- The contractor was reminded to provide covering for the cement bags.
- The contractor was reminded to provide regular water spraying to maintain wet surface.
- The contractor was reminded to clear the sewage regularly to prevent overflow.
- The contractor was reminded to clear the chemical container and ensure proper storage of chemical container.
- The contractor was reminded to replace the NRMM label.

H/O Development

- The contractor was reminded to provide water spraying for demolition work.
- The contractor was reminded to maintain good housekeeping near the site hoarding area to prevent potential leakage of site runoff.
- The contractor was reminded to provide shoes washing area for workers to avoid mud being carried out from site.

May 2021

- The contractor was reminded to provide covering for the stockpile.
- The contractor was reminded to store the chemical properly at designated area.
- The contractor was reminded to clear the drainage channel regularly.
- The contractor was reminded to clear the stagnant water.
- The contractor was reminded to provide drip tray for the chemical containers on site.

The contractor was reminded to replace a new NRMM label for the generator.

H/O Development

The contractor was reminded to display the NRMM label for the excavator on site.

June 2021

- The contractor was reminded to provide temporary pumping to clear the stagnant water.
- The contractor was reminded to dispose of the general refuse properly.
- The contractor was reminded to clear the stagnant water regularly.
- The contractor was reminded to provide drip tray for the chemical container.
- The contractor was reminded to provide covering for the cement bags.
- The contractor was reminded to provide new NRMM label for the generator.

H/O Development

There were no major observations during the site inspections in the reporting period.

Review of the effectiveness and efficiency of the EM&A programme will be continued, and recommendations will be provided to remediate any potential impacts due to the project and to improve the EM&A programme if deficiencies of the existing EM&A programme are identified.

4.3 Conclusions

General

The construction works for the Project commenced on 8 April 2019. This is the 9th Quarterly EM&A Report for the Project summarises findings of the EM&A works during the reporting period from 1 April 2021 to 30 June 2021. (the "reporting period").

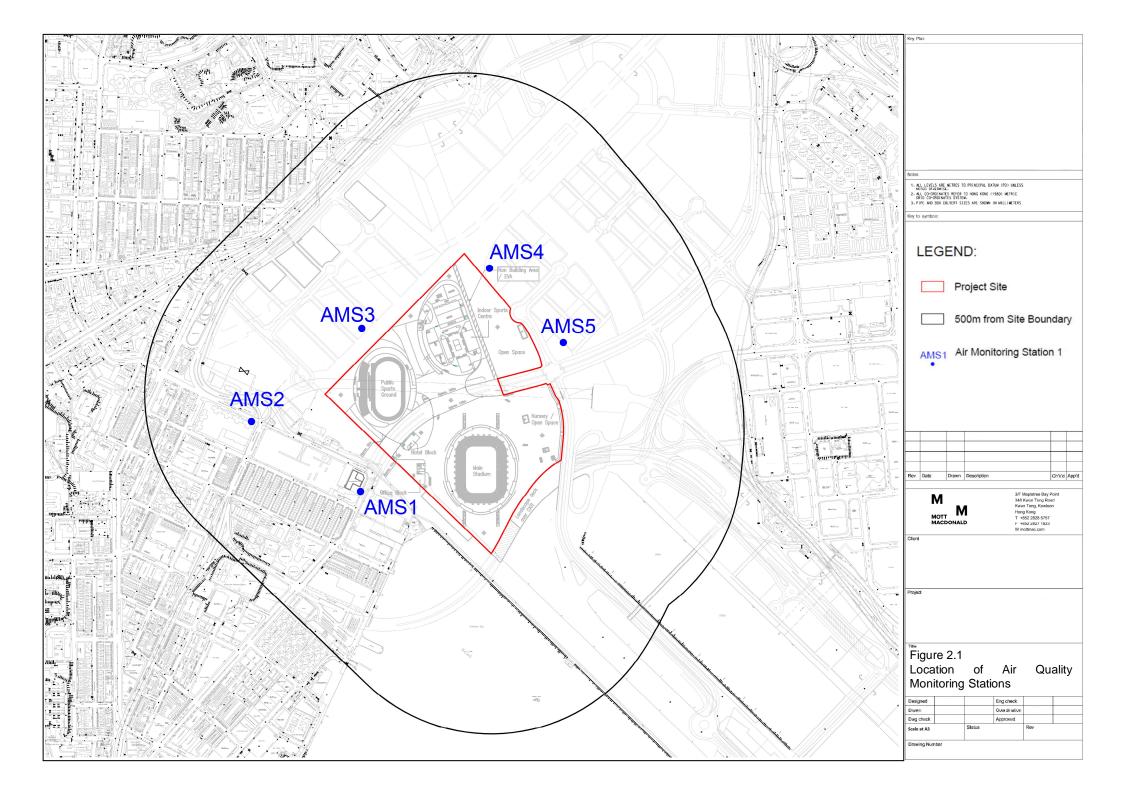

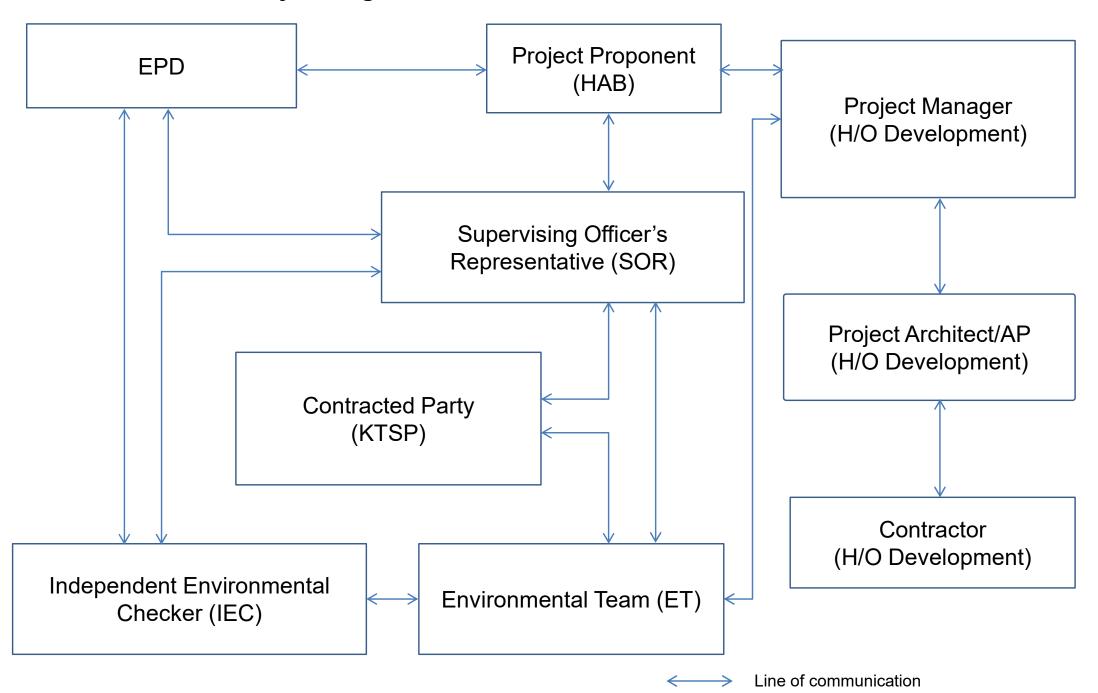

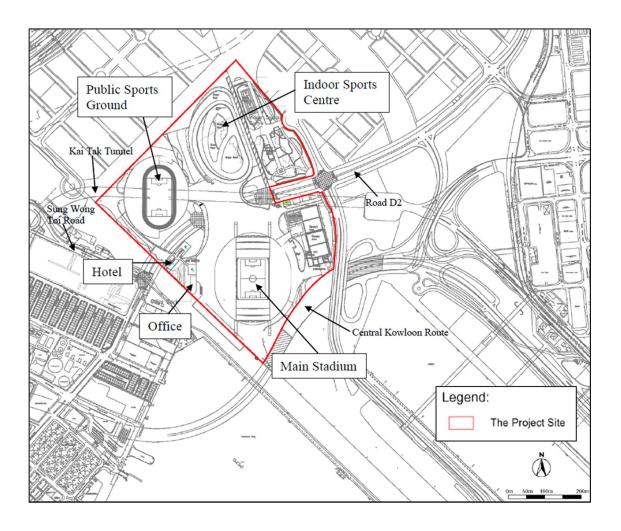


Appendix A. Project Organization for Environmental Works

Graphical Presentation for Noise Monitoring at NMS2





According to contractor information, existing mosquito control measures implemented on site included:

27 May 2021

- 1. Apply larvicides twice per week to potential breeding sources or breeding grounds (drainage channel, trenches, wastewater treatment plants, and other potential water-holding spots) to prevent the growth of mosquito. (photos 1a, 1b, 1c and 1d)
- 2. Conduct regular checking to clear stagnant water on site.
- 3. Conduct routine pest control work twice per week during summer season (April to October).
- 4. Maintain communication between workers on reporting identified potential areas of mosquito breeding ground on site and conduct follow-up action on the identified areas.
- 5. Maintain communication between workers on raising awareness of mosquito prevention on site.

As all mosquito control mitigation measures at the Kai Tak Sports Park have been well maintained and implemented, and the concern location (i.e. Yin On street) was located far away from project site, it was unlikely that potential source of mosquito nuisance was due to the project site. In conclusion, the relevant complaint was considered not valid for the Kai Tak Sports Park project.

RECOMMENDATIONS / MITIGATION MEASURES / ACTIONS

Environmental mitigation measures have been maintained as follow:

- 1. Maintain good site practices to keep the construction site dry and tidy.




