EXECUTIVE SUMMARY

Maeda Chun Wo Joint Venture (Viaducts) (MCWJV), the main Contractor for West Rail CC211 appointed Hyder as the Contractor's Environmental Team (CET) to undertake the Environmental Monitoring and Audit (EM&A) works in accordance with the contract specific EM&A Manual. This is the final monthly EM&A report for contract CC211 which summarises the auditing data for February 2003.

Construction Programme

Major construction activities undertaken in February 2003 during non-restricted hours were reinstatement works. No construction activity was carried out in February 2003 during restricted hours.

Environmental Impact Monitoring

Termination of air quality, noise and water quality monitoring under the EM&A Programme has been approved by EPD, with effect from 1 January 2003 (air quality & noise) and 1 September 2002 (water quality), and endorsed by the KCRC and the Engineer. The approval letters of termination of the aforesaid monitoring from EPD is included in Appendix A.

Waste Management

No waste disposal record was received since March 2002. The Contractor anticipated that there will not be any more excavated waste materials to be generated and disposed offsite from contract CC211 in the rest of construction period.

Environmental Auditing

Site inspection/audits were carried out by the CET on 6, 13, 19 and 27 of February 2003. All observations have been recorded on the audit checklist and passed to the Contractor together with the CET's recommendations. Site audit was undertaken by the IEC on 26 February 2003. No Non-Compliance (NC) was issued and no significant deficiency was observed. However, the Contractor will continually implement necessary measures to maintain the improved site condition.

Complaints

No complaints were received in the reporting month.

Notification of Summons, Successful Prosecutions and Corrective Actions

No Notification of Summons was received in the reporting month.

Future Key Issues

The minor reinstatement at Lam Tei along the walkway installation had been completed. The outstanding landscaping works will be completed immediately following the resumption of planting season. In addition, termination of contract CC211 construction EM&A programme has been approved by EPD, with effective from 1st March 2003. The approval letter of termination of the aforesaid construction EM&A programme is included in Appendix A.

1. BACKGROUND INFORMATION

1.1 PROJECT INFORMATION

West Rail Contract CC 211 (hereafter known as the Project) comprises of the construction works of approximately 4.5km of twin track railway viaduct from Tin Shui Wai to Siu Hong. This is part of the Western Section of West Rail. The Project alignment commences from Tin Shui Wai Station and extends westward and ends at Siu Hong Station. The Project comprises of viaduct construction only and does not include the construction of new stations. Figure 1.1 shows the Project alignment.

Maeda Chun Wo Joint Venture (Viaducts) is the main Contractor for the Project. Hyder Consulting has been employed as the Contractor's Environmental Team (CET) and undertaking the Environmental Monitoring and Audit (EM&A) programme in accordance with the EM&A Manual.

1.2 CONSTRUCTION PROGRAMME

It is anticipated that the overall project programme from the detail design to completion of all civil works will take approximately 64 months. The civil works contract is anticipated to take approximately 47 months. Figure 1.2 presents a summary of the construction programme.

1.3 PROJECT ORGANISATION AND MANAGEMENT

An Environmental Team is set up for the Project construction phase. The organisation and lines of communication with respect to environmental works are shown in Figure 1.3.

In general CET is responsible for regular on-site monitoring and audits/inspection on environmental issues and report to the Contractor of any potential environmental deficiencies. The Independent Environmental Checker (IEC) is responsible for carrying out the formal audit and verifies the overall environmental performance. Finally, the Environmental Manager of KCRC will manage the IEC who would review the deliverables prior to the submission to EPD.

Construction activities for this month during non-restricted hours were reinstatement works.

No construction activity was carried out during restricted hour in the reporting month.

3. NON-COMPLIANCE AND DEFICIENCY

3.1 SITE INSPECTION/AUDIT

3.1.1 Site Inspection/Audit by CET

Regular site inspection/audit were carried out by CET. In February 2003, site audit were carried out at the sites:

- Pier 42 to 59 6 February 2003;
- Pier 842 to 852 13 February 2003;
- Pier 2 to 13 19 February 2003; and
- Pier 41 to 65 27 February 2003.

All observations have been recorded in the audit checklist and passed to the Contractor together with the appropriate recommended mitigation measures where necessary. Significant deficiencies observed during site inspection/audits and recommendation, which have been made by the CET, are summarised in Table 3.1 below:
