<u>Conditions Imposed under Section 5(12) of the EIA Ordinance</u> <u>for Permission to Apply Directly for Environmental Permit</u>

- 1. All mitigation measures described in the Project Profile (No. PP-529/2015) submitted with the Application (No. DIR-242/2015) by the Applicant on 12 October 2015 shall be fully implemented.
- 2. The Applicant shall deposit five hard copies and one electronic copy of landscape plan at least one month before the commencement of the landscape treatment works of the Project. The landscape plan shall include a tree preservation proposal and exploration of alternative mitigation measures, such as native broadleaf trees and / or mixed with palm trees instead of single palm trees planting, to minimize the possible visual impact of the Project. The landscape plan shall show the design details, confirmation of the feasibility for proposed planting, locations, implementation programme, maintenance and management schedules, and drawings in the scale of 1:1,000 or other appropriate scale as agreed with the Director, of the landscape and visual mitigation measures of the Project. All landscape and visual mitigation measures shall be properly implemented and maintained for the Project in accordance with the deposited landscape plan. The Permit Holder shall make available additional copies of landscape plan to the Director upon request.
