**Conditions Imposed under Section 5(12) of the EIA Ordinance
for Permission to Apply Directly for Environmental Permit**

- (i) All mitigation measures and construction phase monitoring described in the Project Profile (No.PP-548/2017) submitted with the application (No. DIR-252/2017) by the applicant on 5.4.2017 shall be fully implemented.
- (ii) An independent environmental checker shall be employed to audit the implementation of all mitigation measures and monitoring requirements recommended in the Project Profile and confirm full compliance through monthly report to the Director during and upon completion of the construction work.
- (iii) A Liaison Officer shall be designated as a contact point to coordinate with the utility operators in the vicinity of the site to handle enquiries and complaints on environmental issues related to the Project during the construction of the Project. A designated hotline should also be set up and operated during the construction of the Project to address related concerns and enquiries.
