Project Title: Landslip Prevention and Mitigation Works at Ng Tung Chai Along Lam Kam Road, Tai Po (Application No.: DIR-300/2024)

Conditions Imposed under Section 5(12) of the EIA Ordinance for Permission to Apply Directly for Environmental Permit

- 1. All measures described in the Project Profile (No. PP-662/2024) submitted with the application on 20 February 2024 shall be fully implemented;
- 2. The applicant shall submit to the Director for approval, at least 4 weeks before commencement of construction, 3 sets of a Tree Management Plan showing the updated number, locations and conditions of all plant species of conservation importance and existing trees within the works site. The Plan shall also indicate the location and species of any plant species of conservation importance and individual trees that would be directly affected by the proposed works, recommending protective and mitigation measures including transplantation of *Cibotium barometz* and replanting of *Aquilaria sinensis* within the Project Site;
- 3. The applicant shall submit to the Director for approval, at least 6 weeks before commencement of construction, 3 sets of a Detailed Design Plan showing the design of reinstated surface channel with the adoption of blue-green elements, and the design of reinforced rigid barrier with the adoption of wildlife friendly design; and
- 4. The applicant shall employ an Independent Environmental Checker to audit the implementation of all measures recommended in the Project Profile (No. PP-662/2024)
