# 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(第 499 章)的規定,而當局可根
- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358) and Noise Control Ordinance (Cap. 400). - 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of the Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at all convenient locations for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. 1.7 The Permit Holder shall ensure that the Project is designed and constructed in accordance with the information and recommendations described in the Project Profile (Register No. PP-566/2018), the application document for environmental permit (Application No. AEP-561/2018), other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

- All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap. 499).

- 1.10 The Permit Holder shall release all finalized submissions as required under this Permit, to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places or any internet websites as specified by the Director, or by any other means as specified by the Director for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions. 許可證持有人須把所有按本許可證規定提交的文件定稿公開給公眾人士知道,方法是把有關文件複本存放於環境影響評估條例登記冊辦事處,或署長指定的任何其他地方,或署長指定的任何互聯網網站,或署長指定的任何方法,以供公眾查閱。因此,許可證持有人須提供足夠數量的複本。
- All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than two weeks prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction. 許可證持有人須在工程項目施工最少兩個星期前以書面通知署長施工日期。施工日期如有任何更改,許可證持有人必須立即以書面方式通知署長。

1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation or other works as agreed by the Director. 為執行本許可證,「建造工程的展開」不包括有關工地清理及預備的工程,或署長同意的其他工程。

#### 2. <u>Specific Conditions</u> 特定條件

- 2.1 The Permit Holder shall not carry out any work outside the boundary of works site as indicated in <u>Figure 2</u> of this Permit or otherwise agreed by the Director. 除非署長另行同意,否則許可證持有人不得在本許可證圖2所示的工地範圍以外進行任何工程。
- 2.2 The Permit Holder shall implement all measures described in the Project Profile (No. PP-566/2018). 許可證持有人須實施工程項目簡介 (登記冊編號: PP-566/2018) 內載述的所有措施。
- 2.3 The Permit Holder shall submit to the Director for approval, at least 4 weeks before commencement of construction, 3 sets of a Detailed Baseline Survey Report showing the updated number, locations and conditions of all plant species of conservation importance within the works site. 許可證持有人須在建造工程展開前最少4個星期,向署長提交詳細基線調查報告的3份複本,以供審批。該報告須顯示工地範圍內所有具保育價值的植物的最新數量、位置及生長情況。
- 2.4 The Permit Holder shall submit to the Director for approval, at least 4 weeks before commencement of construction, 3 sets of a Detailed Landscape Mitigation Plan showing the details of protective measures for existing plants, trees and root systems during construction. The Detailed Landscape Mitigation Plan shall also indicate with the aid of figures, re-vegetation by native shrubs, and locations of re-vegetation of the existing disturbed ground including other suitable areas within the works site. The Permit Holder shall implement all measures recommended in the approved Detailed Landscape Mitigation Plan during construction.

- 2.5 The Permit Holder shall submit to the Director for approval, at least 4 weeks before commencement of construction, 3 sets of a Detailed Surface Water Management Plan showing the detailed design of the site drainage system including cut-off channels, earth bunds or impervious water barriers for collecting site runoff to on-site wastewater treatment facilities for treatment and preventing site runoff from escaping off-site or entering the nearby natural stream. 許可證持有人須在建造工程展開前最少4個星期,向署長提交詳細地面水管理計劃書的3份複本,以供審批。該計劃書須顯示工地排水系統的詳細設計,包括截流渠、土堤或不透水防護屏

障,以收集工地徑流至工地內的污水處理設施,處理及防止工地徑流流出工地以外或流入附近

的天然河流。

- 2.6 The Permit Holder shall submit to the Director for deposit, 1 hard copy and 1 electronic copy of the monthly monitoring reports showing the updated conditions of the plant species of conservation importance within the works site and site audit information for implementation of the measures recommended in the Project Profile within 2 weeks after the relevant monitoring data are collected. 許可證持有人須在收集有關監測數據後的兩星期內,向署長存放每月監測報告的1份硬複本及1份電子版本。該每月監測報告須顯示工地範圍內具保育價值植物的最新狀況,及實施工程項目簡介內建議措施的實地審核資料。
- 2.7 The Permit Holder shall employ an ecologist to conduct a survey to verify any presence of Lesser Spiny Frog within the works site before commencement of construction and during its active period (April to October) at construction phase. The Permit Holder shall arrange translocation of any Lesser Spiny Frog found to a suitable habitat as agreed by Agriculture, Fisheries and Conservation Department (AFCD). The qualification and experience of the ecologist shall be agreed with AFCD. 許可證持有人須聘用一名生態學家,在建造工程展開前及施工期間小棘蛙活躍期內 (四月至十月) 進行調查,以確定工地範圍內是否有小棘蛙存在。如有發現,許可證持有人須在漁農自然護理署的同意下把小棘蛙遷徙到合適棲息地。生態學家的資格及經驗須經漁農自然護理署同意。
- 2.8 The Permit Holder shall employ an independent environmental checker (IEC) before commencement of construction. The IEC shall not be in any way an associated body of the Contractor for the Project. The IEC shall audit the implementation of all measures recommended in the Project Profile (Register No. PP-566/2018), and to certify in writing in the monthly monitoring reports for full implementation of the measures during and upon completion of the construction works. The final monitoring report should include a summary with photos to illustrate the condition of all the plant species of conservation importance before commencement and upon completion of the construction works.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for the Environment, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site.

  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;




