Pursuant to Section 10 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) grants this environmental permit to the Drainage Services Department (hereinafter referred to as the "Permit Holder") to construct and operate the designated project described in Part B subject to the conditions specified in Part C. PART C (PERMIT CONDITIONS)

C部 (許可證條件)

1. General Conditions

一般條件

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(環評條例)(第 499 章)的規定,而當局可根據環評條例採取適當行動。
- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358) and Noise Control Ordinance (Cap. 400). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation. 許可證持有人須經常確保完全符合現行法例的規定,包括但不限於《空氣污染管制條例》(第311章)、《廢物處置條例》(第354章)、《水污染管制條例》(第358章)及《噪音管制條例》(第400章)。本許可證本身不會就根據任何法例提起的法律程序構成任何抗辯理由,或根據任何法例默示任何批准。
- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of the Permit readily available at all times for inspection by the Director or his authorised officers at all sites/offices covered by this Permit. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in the Permit. The site(s) refers to site(s) of construction and operation of the Project and shall mean the same hereafter. 許可證持有人須把本許可證的一份複本交予有關工地的負責人,並確保這些人士完全明白本許可證的所有條件與規定。工地是指建造及營辦工程項目的工地,下文所提及的工地亦屬同一意思。
- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).

1.6 The Permit Holder shall construct and operate the Project in accordance with the project description in Part B of this Permit.

- 1.7 The Permit Holder shall ensure that the Project is designed, constructed and operated in accordance with the information and relevant recommendations described in the Project Profile (Register No.: PP-572/2018), the application document for Environmental Permit (Application No.: AEP-566/2019), other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under ongoing surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director. 許可證持有人須確保工程項目按照下述資料設計、建造及營辦:工程項目簡介(登記冊編號: PP-572/2018)所說明的資料及相關建議;環境許可證的申請文件(申請書編號: AEP-566/2019); 登記冊內的其他相關文件;本許可證所說明的資料及緩解措施;根據本許可證內載的條件須 向署長存放或獲署長批准的提交文件所建議的緩解措施;以及在工程項目各階段進行的持續 監察和監測工作所建議的緩解措施。登記冊文件所述建議如沒有在本許可證明確表示,則仍
- All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director.

1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO.

- 1.10 The Permit Holder shall release all finalized submissions as required under this Permit, to the public by depositing copies in the EIAO Register Office, or in any other places or any internet websites as specified by the Director, or by any other means as specified by the Director for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions. 許可證持有人須把所有按本許可證規定提交的文件定稿公開給公眾人士知道,方法是把有關文件複本存放於環評條例登記冊辦事處,或署長指定的任何其他地方,或署長指定的任何互聯網網站,或署長指定的任何方法,以供公眾查閱。因此,許可證持有人須提供足夠數量的複本。
- 1.11 All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the EIAO Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 2 weeks prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction.

1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation, or other works as agreed by the Director. 為執行本許可證,「建造工程的展開」不包括有關工地清理和預備工程,或署長同意的其他工程。

2. <u>Specific Conditions</u> 特定條件

Submissions and Measures before Construction of the Project 工程項目施工前須提交的文件及採取的措施

- 2.1 The Permit Holder shall employ an Independent Environmental Checker (IEC) before commencement of construction of the Project to audit the implementation of all measures recommended in the Project Profile (Register No.: PP-572/2018) and confirm full compliance through an Audit Report to the Director within one month upon completion of the construction works. The IEC shall not be in any way an associated body of the Contractor for the Project. 許可證持有人須在工程項目的建造工程展開前聘用一名獨立環境查核人,負責審核工程項目簡介(登記冊編號:PP-572/2018)內建議的所有措施的實施工作,以及在建造工程完成後 1個月內向署長存放審核報告書,以確定所有措施的實施完全符合規定。獨立環境查核人不得是工程項目的承辦商的相聯團體。
- 2.2 The Permit Holder shall deposit 3 hard copies and 1 electronic copy of Landscape and Visual Plan at least one month before the commencement of the landscape and visual mitigation works of the Project. The Landscape and Visual Plan shall include: 許可證持有人須在工程項目的景觀及視覺緩解工程展開前最少 1 個月向署長存放景觀及視覺緩解計劃的 3 份硬複本及 1 份電子版本。景觀及視覺緩解計劃須包括:
 - (i) tree protection plan for existing trees within the Project site; 工程項目工地內的保護樹木計劃;
 - (ii) compensatory planting proposal for the loss of tree within the Project site; 就工程項目工地內損失的樹木提出補償植樹建議;
 - (iii) the design details, confirmation of the feasibility for proposed planting, locations, implementation programme, maintenance and management schedules, and drawings in the scale of 1:1,000 or other appropriate scale as agreed with the Director, of the landscape and visual mitigation measures of the Project.

All landscape and visual mitigation measures shall be properly implemented and maintained for the Project in accordance with the deposited landscape plan. The Permit Holder shall make available additional copies of landscape plan to the Director upon request.

Submissions and Measures during Operation of the Project 工程項目營辦期間須提交的文件及採取的措施

2.3 The Permit Holder shall implement the following mitigation measures to minimize odour impact during operation of the Project:

許可證持有人必須採取以下的緩解措施,以盡量減低工程項目營辦期間的氣味影響:

(i) all facilities and areas with potential odour emission such as the inlet chamber, screen chambers, valve chamber and wet wells shall be fully enclosed and the exhaust air shall be conveyed to a deodourization (DO) unit for treatment before discharge to the environment; and

所有可能散發氣味的設施及範圍,例如入水室、隔篩室、閥門室及濕井,必須完全密封,而廢氣須先行傳送到除臭裝置,經處理後才可排放到外部環境;及

- the DO unit shall be designed to achieve at least 99.5% odour removal efficiency, and shall be properly operated and maintained, for treatment of exhaust air before discharge. The treated exhaust shall be oriented away from air sensitive receivers. 除臭裝置的設計須至少達到 99.5%的除臭效能,並予以妥善操作及保養,以處理廢氣後再排出。排放經處理後的廢氣必須避開易受空氣污染影響的地方。
- 2.4 The Permit Holder shall implement the following mitigation measures to minimize noise impact during operation of the Project:

許可證持有人必須採取以下的緩解措施,以盡量減低工程項目營辦期間的噪音影響:

- the screen and pump sets shall be housed inside reinforced concrete structure; and 隔篩及水泵組須安置在鋼筋混凝土構築物內;及
- (ii) the outlet of the exhaust fan shall be installed with acoustic louvers / silencers and facing away from noise sensitive receivers.抽氣扇排氣□必須設有隔音百葉簾 / 消音器,並避開易受噪音影響的地方。
- 2.5 The Permit Holder shall implement the following measures to minimize environmental impact arising from emergency sewage bypass during operation of the Project, or otherwise agreed by the Director:

許可證持有人必須採取以下措施,以盡量減少工程項目營辦期間因緊急繞流排放污水所引致 的環境影響,除非另獲署長同意:

(i) Precautionary measures including standby pump and screen, twin rising mains system, dual power supply, emergency storage with holding capacity for at least 3.5 hours peak flow, and a Supervisory Control and Data Acquisition system (SCADA) to transmit signals showing irregularity or any operational problem of the sewage pumping station to the nearest manned station / plant; and

採取預防措施,包括備用水泵和隔篩、雙管污水泵喉系統、雙重電力供應、緊急儲存的容量最少達 3.5 小時高峰流量,以及備有監控與數據收集系統,以便污水泵站出現 異常情況或操作問題時可把信號傳送至最近有人看管的污水站/廠;及



(ii) At least 1/3 of the incoming sewage under daily average flow shall be tankered away to reduce emergency discharge volume.

1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

本許可證共有 3 部,即 \underline{A} 部(許可證主要部分); \underline{B} 部(指定工程項目的說明)及 \underline{C} 部(許可證條件)。任何援引本許可證的人士須就環評條例的法律含意徵詢獨立法律意見,下述註解只供一般參考用。

2. If there is a breach of any condition of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated works until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit.

4. A person who assumes the responsibility for the whole or a part of the designated project(s) may, before he assumes responsibility of the designated project(s), apply under Section 12 of the EIAO to the Director for a further environmental permit.

5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for the Environment, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site.

6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.



- 7. Any person who constructs or operates the Project contrary to the conditions in the Permit, and is convicted of an offence under the EIAO, is liable: 如任何人在違反本許可證的條件下建造或營辦工程項目,根據環評條例,即屬犯罪-
 - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months; 一經循公訴程序首次定罪,可處罰款 200 萬元及監禁 6 個月;
 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 —經循公訴程序第二次或其後每次定罪,可處罰款 500 萬元及監禁 2 年;
 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months; 一經循簡易程序首次定罪,可處第 6級罰款及監禁 6 個月;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 —經循簡易程序第二次或其後每次定罪,可處罰款 100 萬元及監禁 1 年;及
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued. 在任何情況下如該罪行屬連續性質,法院或裁判官可就其信納該罪行持續的每天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證的任何條件提出上訴。
- 9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.
