Pursuant to Sections 10 and 12 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) granted this Further Environmental Permit (hereinafter referred to as this "Permit) to the **Highways Department** (thereinafter referred to as the "Permit Holder") to operate the designated project described in Part B of this Permit subject to the conditions specified in Part C of this Permit. The issue of this Permit is based on the documents, approval and permissions described below:

PART C (PERMIT CONDITIONS)

C部(許可證條件)

1. General Conditions

一般條件

- 1.1 The Permit Holder shall ensure full compliance with all conditions of this environmental permit. Any non-compliance may constitute a contravention of the EIAO (Cap.499) and may become subject of appropriate action to be taken under the Ordinance.

許可證持有人必須確保完全符合本環境許可證的全部條件。如有不符合本許可證的情況，可能構成違反《環境影響評估條例》(第499章)的規定，而當局可根據條例採取適當行動。

- 1.2 The Permit Holder shall ensure, from time to time, full compliance with all legislation in force including but without limitation to the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defense against any proceedings instituted under any legislation.

許可證持有人須經常確保完全符合現行法例的規定，包括(但不限於)噪音管制條例(第400章)；空氣污染管制條例(第311章)；水污染管制條例(第358章)；及廢物處置條例(第354章)。本許可證本身不會就根據任何法例提出的法律程序構成任何抗辯理由。

- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit or the documents referred to in Part A of this Permit readily available at all times for inspection by the Director at the Permit Holder's office. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

許可證持有人須印製本許可證的複本，連同本許可證所述的所有文件或本許可證A部所述文件，以供署長任何時間內在本許可證持有人的辦事處查閱。凡提述本許可證，須包括本許可證所述的所有文件和登記冊內的相關文件。

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the operation of the Project and ensure that such person(s) fully understands all conditions and all requirements incorporated by the Permit.

許可證持有人須將本許可證的一份複本交予負責營辦本工程項目的人士，並確保這些人士完全明白本許可證的所有條件與規定。

- 1.5 The Permit Holder shall operate the Project as described in Part B of this Permit.

許可證持有人須負責營辦本許可證B部所述工程項目的其中部分。



- 1.6 The Permit Holder shall ensure that the part of the Project is operated in accordance with relevant information and recommendations described in the EIA Report and Environmental Schedule (Register no. AEIAR-017/1999), mitigation measures described in this Permit, mitigation measures recommended in the submissions deposited with or approved by the Director in compliance with conditions contained in this Permit, and mitigation measures recommended during monitoring of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or amended in this Permit.

許可證持有人須確保該部分的工程項目的營辦遵照環評報告及環境計劃（登記冊編號：AEIAR-017/1999）內所載資料及建議；本許可證所載的緩解措施；遵守本許可證內載條件送交署長存放或獲署長批准的文件所建議的緩解措施；以及在監察工程項目期間所建議的緩解措施。即使登記冊文件所述建議沒有在本許可證明確提示，該些建議仍須實施，除非本許可證明確表示已被豁除或已作修訂。

2. Special Conditions 特別條件

- 2.1 The noise barriers and enclosures as shown in Figures 1 to 3 and Table 1 of this Permit shall be properly maintained to mitigate traffic noise during operation of the Project.

在工程項目營辦期間，須妥善維持本許可證圖1至3及表1所示的隔音屏障及隔音罩，以緩解交通噪音。

- 2.2 The landscape area as shown in Figure 4 of this Permit shall be properly managed and maintained in accordance with the detailed landscape plan deposited with the Director under Condition 2.5 of the environmental permit (Permit No.: EP-073/2000/D).

本許可證圖4所示的保養園景美化區，須按照環境許可證(EP-073/2000/D)條件2.5向署長存放的竣工景觀圖則妥善管理和維護。

Notes:

1. This Permit consists of three parts, namely, PART A (Main Permit), PART B (Description of Designated Project) and PART C (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the Ordinance, and that the following notes are for general information only.

本許可證共有3部，即：A部（許可證主要部分）；B部（指定工程項目的說明）；及 C部（許可證條件）。任何援引本許可證的人士須就條例的法律含意徵詢獨立法律意見，下述註解只供一般參考用。



2. If there is a breach of any conditions of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

如違反本許可證的任何條件，署長或獲授權人員徵得環境局局長的同意後可勒令停止相關工程，直至許可證持有人為所造成的環境損害採取補救行動為止。在此情況下，許可證持有人未經署長或獲授權人員同意，不得進行任何相關工程。

3. The Permit Holder may apply under Section 13 of the Ordinance to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original Permit by the amended Permit.

許可證持有人可根據條例第13條的規定向署長申請更改本許可證的條件。許可證持有人須將經修改的許可證，替換原有許可證。

4. A person who assumes the responsibility for the whole or a part of the designated project may, before he assumes responsibility of the designated project, apply under Section 12 of the Ordinance to the Director for a further environmental permit.

承擔指定工程項目的整項或部分工程的責任的人，在承擔指定工程項目責任之前，可根據條例第12條的規定向署長申請新的環境許可證。

5. Under Section 14 of the Ordinance, the Director may, with the consent of the Secretary for the Environment, suspend, vary or cancel this Permit.

根據條例第14條的規定，署長可在環境局局長的同意下暫時吊銷、更改或取消環境許可證。

6. If this Permit is cancelled or surrendered during the operation of the Project, another environmental permit must be obtained under the EIAO before the operation of the Project could be continued. It is an offence under Section 26(1) of the EIAO to operate a designated project without a valid environmental permit.

如果本許可證在工程項目營辦期間取消或交回，則在繼續進行工程項目之前，必須先根據環評條例規定取得環境許可證。根據條例第26(1)條的規定，任何人在沒有有效環境許可證的情況下營辦指定工程項目，即屬犯罪。

7. Any person who operates the Project contrary to the conditions in this Permit, and is convicted of an offence under the Ordinance, is liable –

如任何人在違反本許可證的條件下建造及營辦工程項目，根據環評條例，即屬犯罪 –

- (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;



一經循公訴程序首次定罪，可處罰款200萬元及監禁6個月；

(ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;

一經循公訴程序第二次或其後每次定罪，可處罰款500萬元及監禁2年；

(iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;

一經循簡易程序首次定罪，可處第6級罰款及監禁6個月；

(iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and

一經循簡易程序第二次或其後每次定罪，可處罰款100萬元及監禁1年；及

(v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

在任何情況下如該罪行屬持續性質，則法院或裁判官可就其信納該罪行持續的每天另處罰款10,000元。

8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the Ordinance within 30 days of receipt of this Permit.

許可證持有人可在接獲本許可證後30天內，根據條例第17條就本許可證的任何條件提出上訴。

9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.

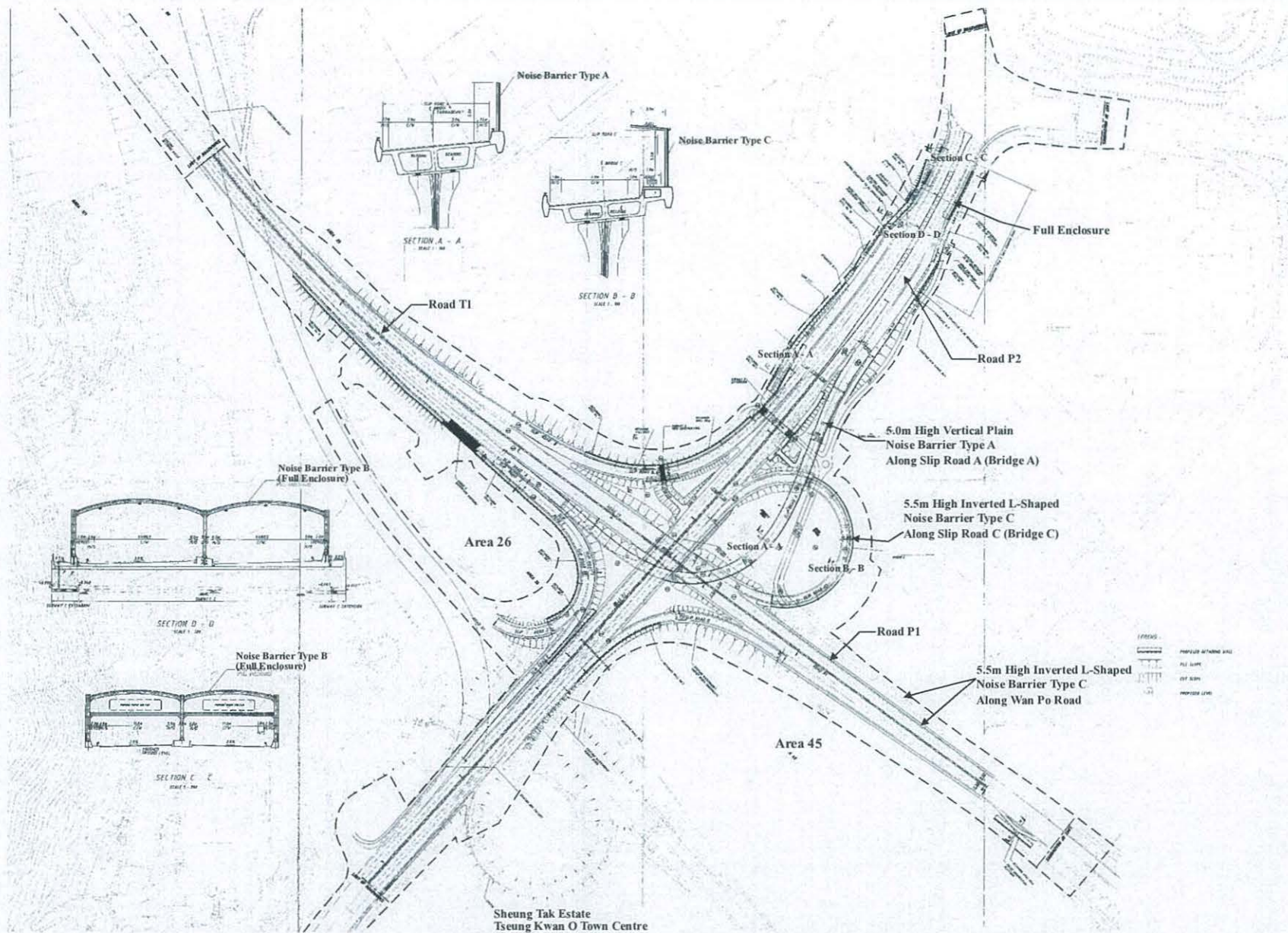

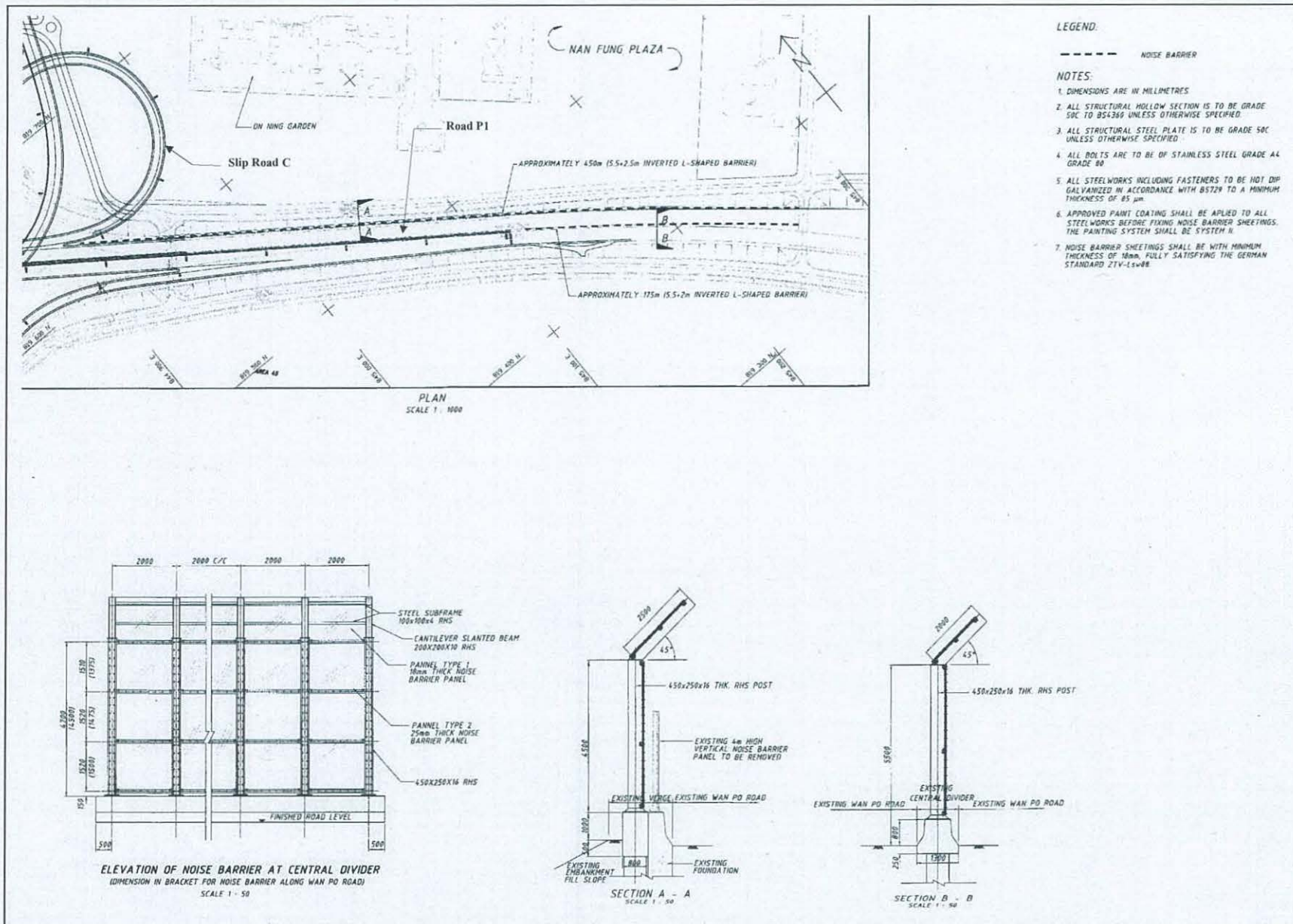

位於環保大道的噪音緩解佈局圖



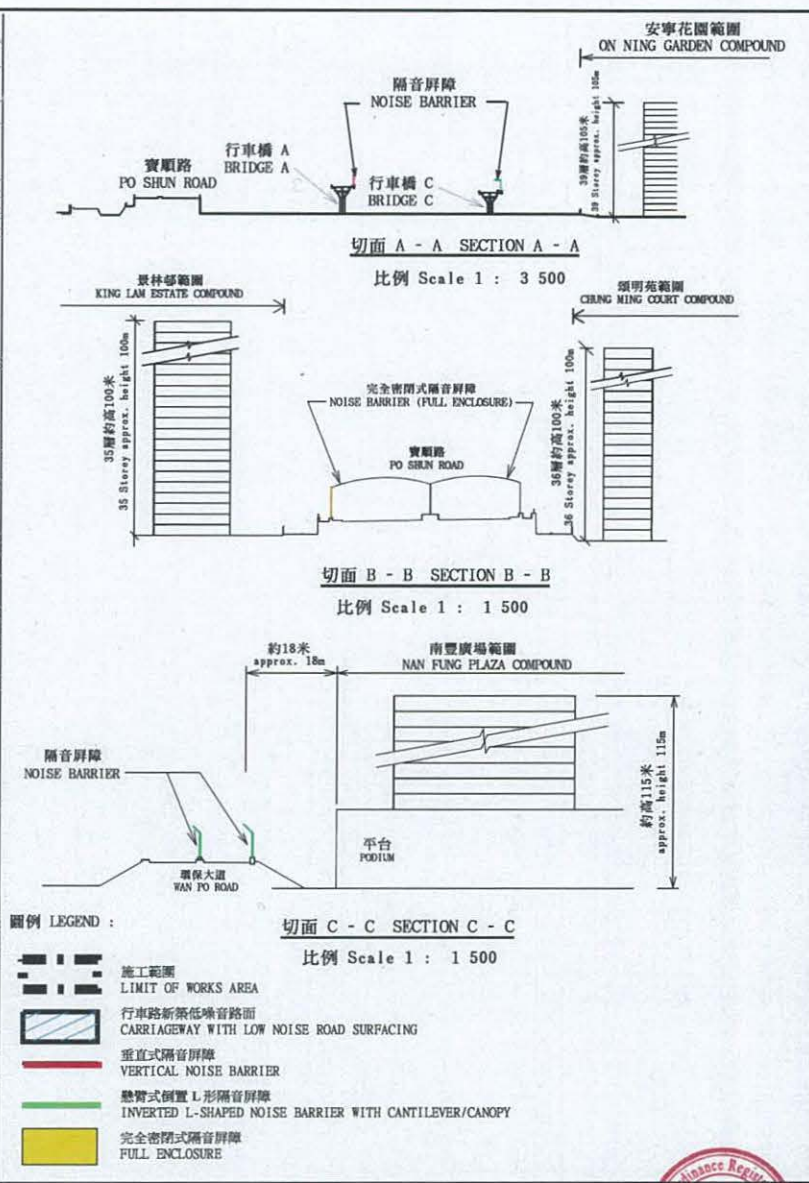
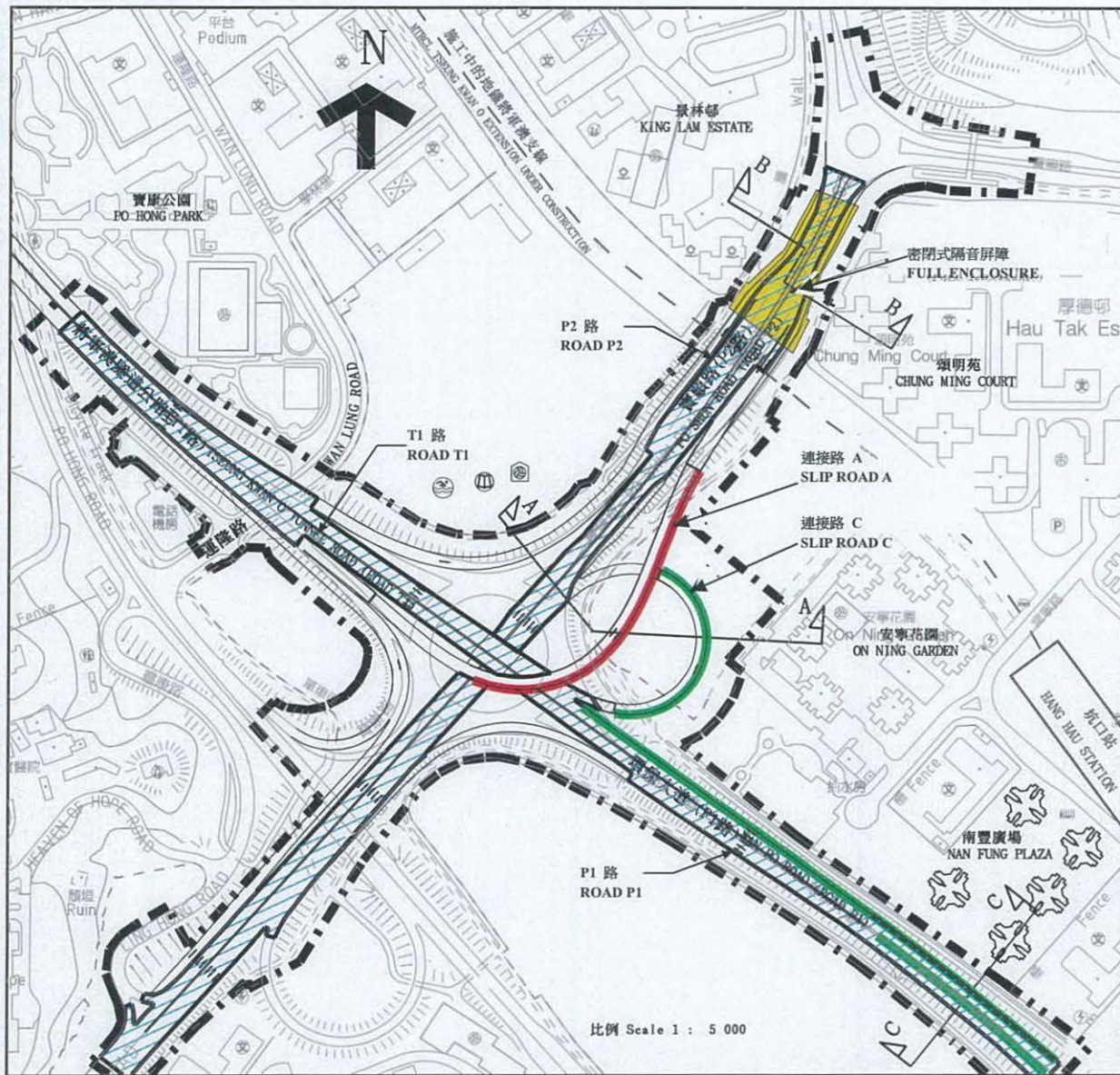

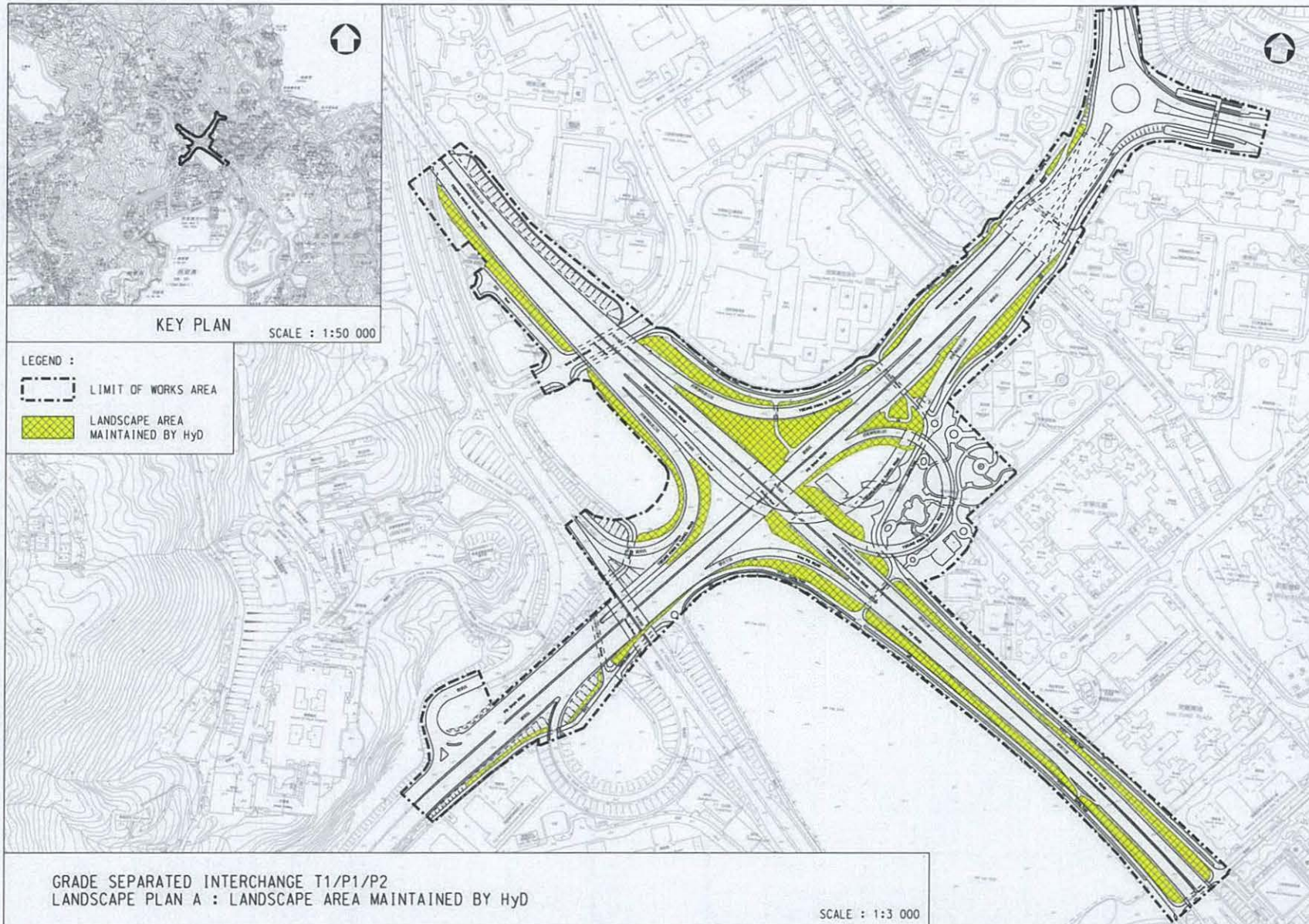
