#### PART C (PERMIT CONDITIONS) C部 (許可證條件)

#### 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person working on the part of the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap.499) and may become the subject of appropriate action being taken under the Ordinance. 許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(第 499 章)的規定,而當局可根據條例採取適當行動。
- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Noise Control Ordinance (Cap. 400), and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defense against any proceedings instituted under any legislation or imply any approval under any legislation.

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated by the Permit. The site(s) refers to site(s) of operation of the part of the Project and shall mean the same hereafter. 許可證持有人須把本許可證的一份複本交予工程項目工地的負責人,並確保這些人士完全明白本許可證的所有條件與規定。工地是指營辦工程項目其中部分的工地,下文所提及的工地亦屬同一意思。
- 1.5 The Permit Holder shall operate the part of the Project in accordance with the project description in <u>Part B</u> of this Permit. 許可證持有人須依據本許可證 <u>B部</u> 的說明,營辦本工程項目的其中部分。
- 1.6 The Permit Holder shall ensure that the part of the Project is operated in accordance with the relevant information and recommendations described in the approved WDII&CWB EIA Report (Register No. AEIAR-125/2008), the approved CRIII EIA Report (Register No. AEIAR-040/2001) and other relevant documents in the Register. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such

recommendations are nevertheless to be implemented unless expressly excluded or impliedly amended in this Permit.

#### 2. <u>Specific Conditions</u> 特定條件

- 2.1 The Permit Holder shall maintain the landscape area in accordance with the operation landscape plan(s) deposited under Condition 2.11 of Environmental Permit No.: EP-376/2009. Any major changes to the landscape planting shall be determined by the manager referred to in Condition 2.2 below as conforming to the relevant information and recommendations in the EIA Reports (Register nos. AEIAR-040/2001 and AEIAR-125/2008), in regard to comparable types and sizes of proposed plants for the landscape mitigation measures. 許可證持有人須按照環境許可證(EP-376/2009)條件2.11向署長存放的營辦期景觀美化計劃維護園景美化區。園景種植如有任何重大更改,須由下文條件第2.2項所述的經理確定為符合環評報告(登記冊編號:AEIAR-040/2001及AEIAR-125/2008)所載的相關資料及建議,相當於景觀影響緩解措施所建議種植樹木的類別及大小。

    - a relevant horticultural certificate issued by a training/educational institute for example the Institute of Horticulture (Hong Kong), the Hong Kong Productivity Council, the Vocational Training Council and an institute under the Skills Upgrading Scheme of the Education Bureau of the Hong Kong Special Administrative Region Government.

1. This Permit consists of three parts, namely, <u>PART A</u> (Main Permit), <u>PART B</u> (Description of Designated Project) and <u>PART C</u> (Permit Conditions). Any person relying on this permit should obtain independent legal advice on the legal implications under the Ordinance, and the following notes are for general information only.

- The Permit Holder may apply under Section 13 of the Ordinance to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit by the amended permit.

- 4. - 5. Under Section 14 of the Ordinance, the Director may with the consent of the Secretary for the Environment and Ecology, suspend, vary or cancel this Permit. 根據條例第 14 條的規定,署長可在環境及生態局局長的同意下暫時吊銷、更改或取消環境許可讚。
- 6. If this Permit is cancelled or surrendered during operation of the Project, another environmental permit must be obtained under the Ordinance before the Project could be continued. 
