PART A (MAIN PERMIT) A 部 (許可證主要部分)

Pursuant to Sections 10 and 12 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) grants this further environmental permit to the <u>Canvest – Paul Y. Joint Venture</u> (hereinafter referred to as the "Permit Holder") to construct and operate the designated project described in <u>Part B</u> subject to the conditions specified in <u>Part C</u>. PART C (PERMIT CONDITIONS) C 部 (許可證條件)

1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

- 1.2 The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

- The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in this Permit. - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the original

Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

1.6 The Permit Holder and any person constructing or operating the Project shall construct and operate the Project in accordance with the project description in <u>Part B</u> of this Permit.

1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the Project Profile (Register No.: PP-646/2022); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under ongoing surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

- All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director. 所有按本許可證規定提交的文件,須在接獲署長的意見(如有者)後1個月內或署長另行指定的期限內,根據署長的意見加以修正及重新提交。
- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499).

1.10 The Permit Holder shall release all finalised submissions as required under this Permit to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places, or any internet websites as specified by the Director, or by any means as specified by the Director, for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

- The Permit Holder shall submit and / or deposit all submissions within the time as 1.11 specified in the Conditions of this Permit. All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies. 許可證持有人須在本許可證條件所列明的時間內,提交及/或存放所有文件。 本許可證規定向署長提交的所有文件,須親身送交或以掛號方式郵寄至環境 影響評估條例登記冊辦事處 (現址為:香港灣仔軒尼詩道 130 號修頓中心 27 樓)。所有按本許可證規定提交的文件定稿的電子複本,均須以超文本標示 語言(HTML)(第 4.0 或較後版本)和便攜式文件格式(PDF)(第 1.3 或較後版本)製 作,除非另獲署長同意,電子複本須與硬複本同時提交。
- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 1 month prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction. 許可證持有人須在工程項目建造工程展開前最少一個月,以書面方式把工程項目建造工程的展開日期通知署長。建造工程的展開日期如有任何更改,許可證持有人必須立即以書面方式通知署長。
- 1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation, or other works as agreed by the Director. 為執行本許可證,「建造工程的展開」不包括有關工地清理和預備的工程,或署長同意的其他工程。
- The Permit Holder shall notify the Director in writing the commencement date of operation of the proposed Grease Trap Waste Treatment Facility (GTWTF) no later than 1 month prior to the commencement of operation of the proposed GTWTF. 2. <u>Specific Conditions</u> 特定條件

- 2.1 The Permit Holder shall employ an Independent Environmental Checker (IEC) to audit the implementation of the environmental mitigation measures recommended in the Project Profile (Register No. PP-646/2022), including the construction & demolition waste disposal record, during the construction phase of the Project. 許可證持有人須聘用一名獨立環境查核人審核所有工程項目簡介(登記冊編號:PP-646/2022)內建議的環境緩解措施的實施,包括施工階段處置拆建物料的紀錄。
- 2.2 The Permit Holder shall, no later than one month before the operation of the proposed GTWTF, deposit an Audit Report to the Director to confirm all environmental protection measures and design measures described in the Project Profile have been fully implemented. The Audit Report shall pay particular attention to the proposed odour control measures and be verified by the IEC employed under Condition 2.1 above. 許可證持有人須在擬議隔油池廢物處理設施開始營辦前最少一個月向署長存放一份審核報告書,以確定工程項目簡介(登記冊編號:PP-646/2022)所說明的所有環境緩解措施及設計措施均已全面予以實施。有關審核報告書須特別關注氣味控制措施並按上文條件第 2.1 項內所述的獨立環境查核人核實。
- 2.3 To minimise odour impact during operation of the Project, the proposed GTWTF shall be enclosed and maintained at negative pressure with the odourous gas extracted and diverted to a two-stage deodorisation system comprising wet chemical scrubbers and activated carbon filters for treatment before discharge to the atmosphere.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit. 許可證持有人可根據環評條例第 13 條的規定向署長申請更改本環境許可證的條件。許可證持有人須以經修改的許可證替換在工程項目工地內展示的原有許可證。
- 4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit. 承擔工程項目整項或部分工程的責任的人,在承擔責任之前,可根據環評條例第12條的規定向署長申請新的環境許可證。
- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site. 根據環評條例第 14 條的規定,署長可在取得環境及生態局局長的同意下暫時吊銷、更改或取消本許可證。遭暫時吊銷、更改或取消的許可證必須從工程項目工地除下,不再展示。
- 6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

 - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;
 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

- (v) 在任何情況下如該罪行屬持續性質,法院或裁判官可就其信納該罪行持續的每天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證 的任何條件提出上訴。
- 9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.
