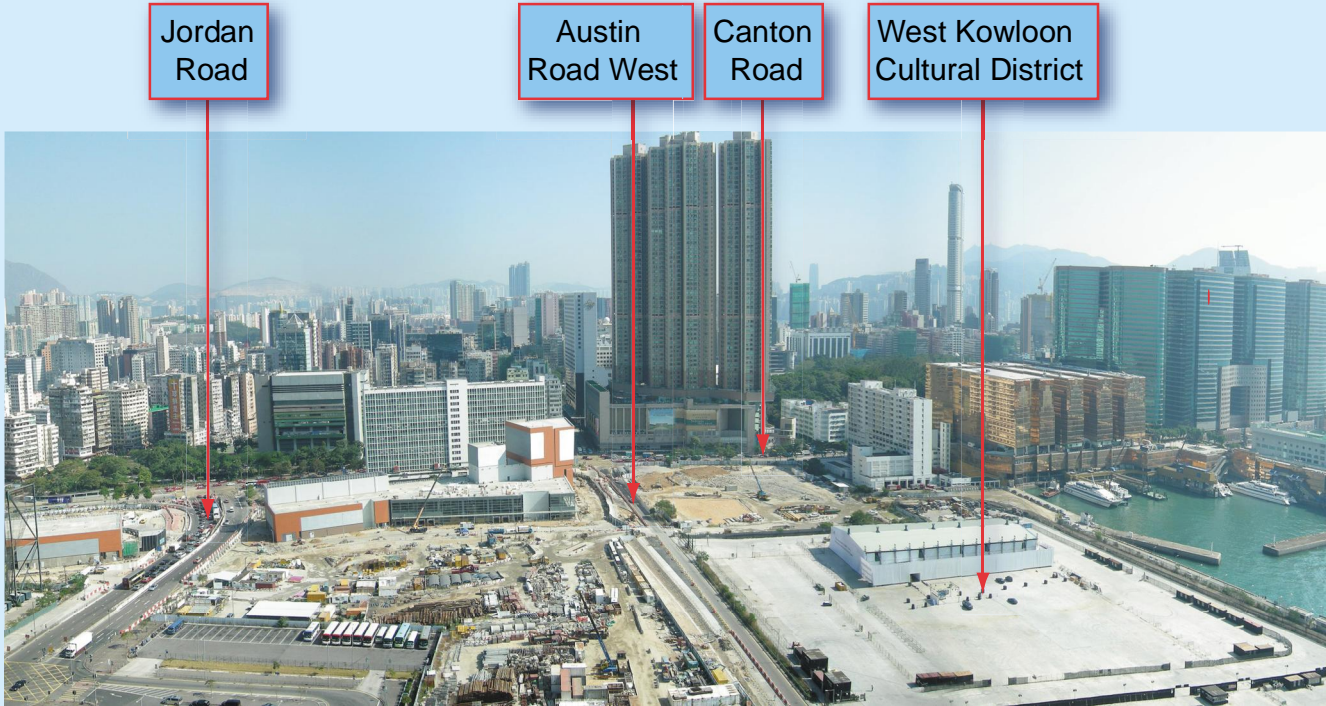
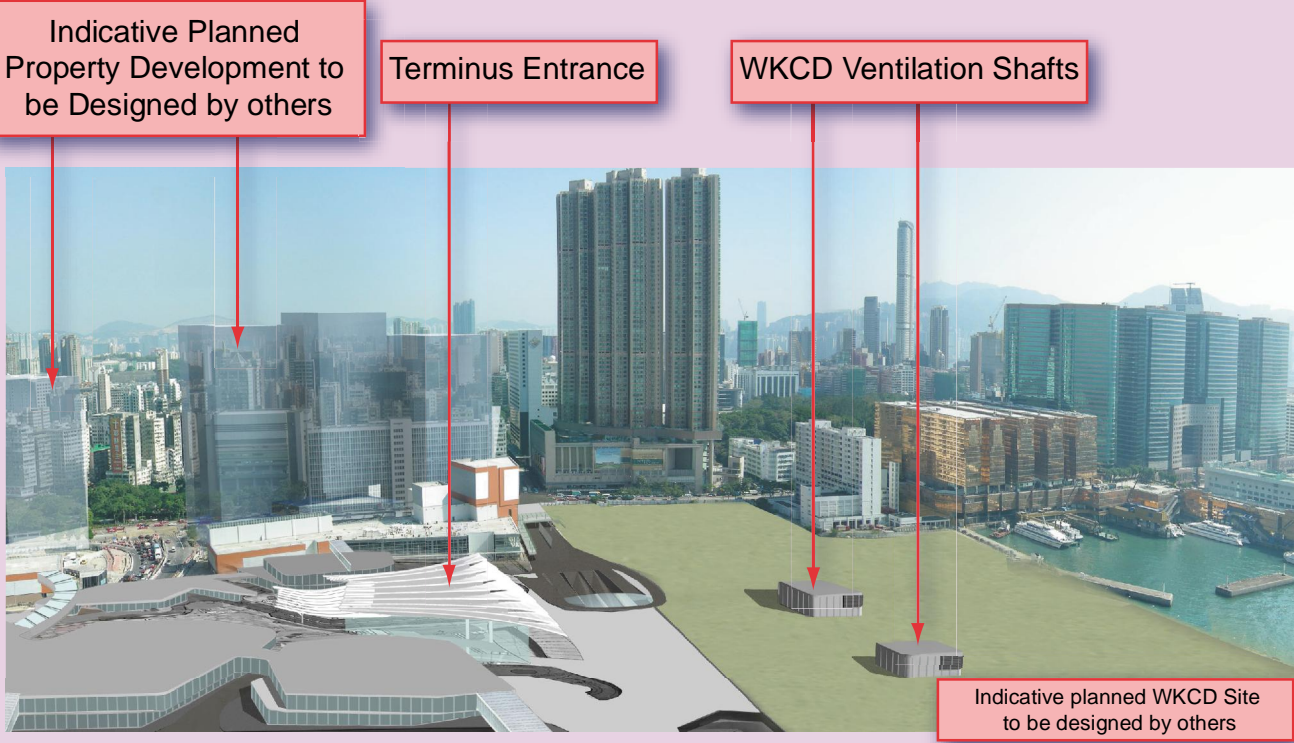

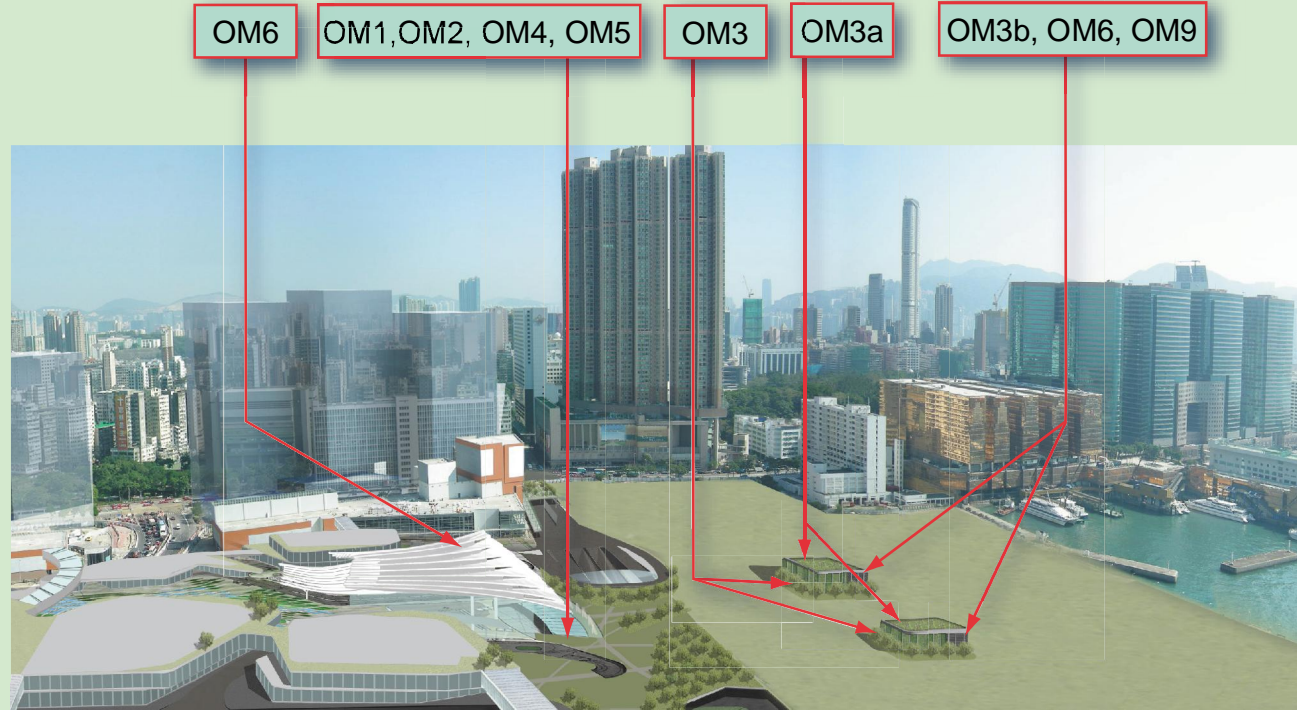
Day 1 without Mitigation Measure



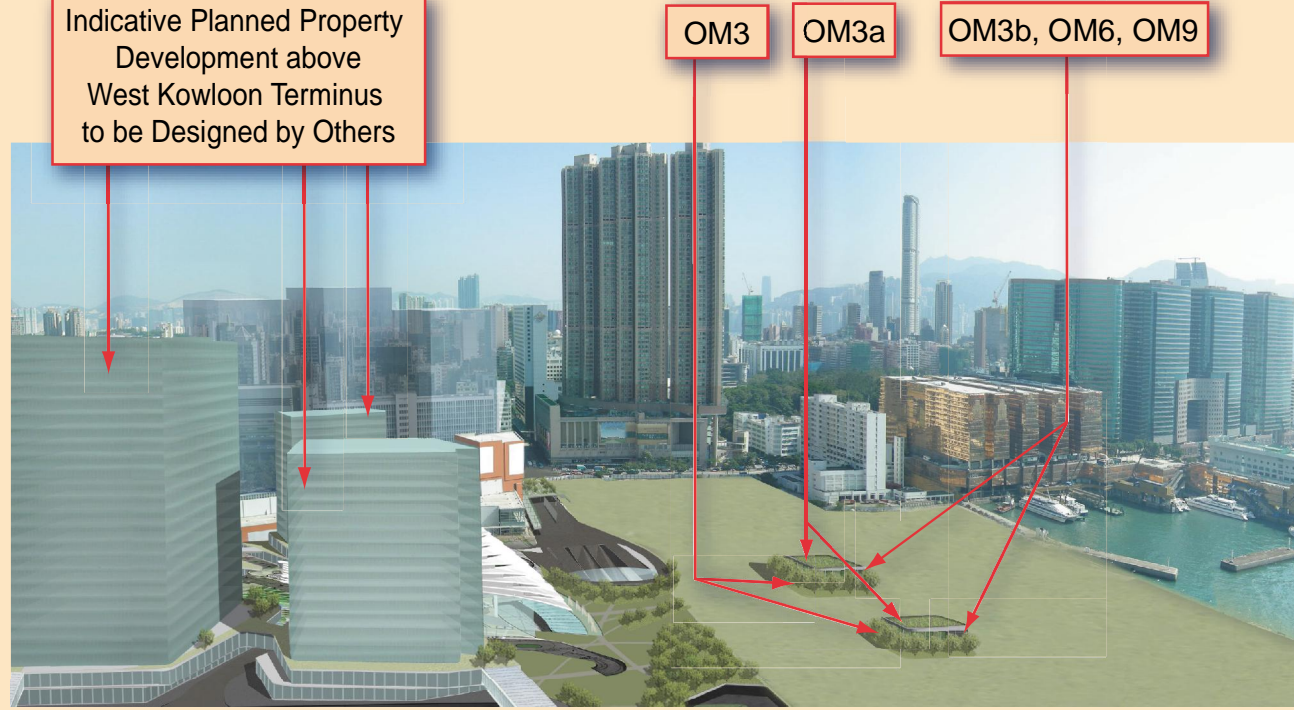
