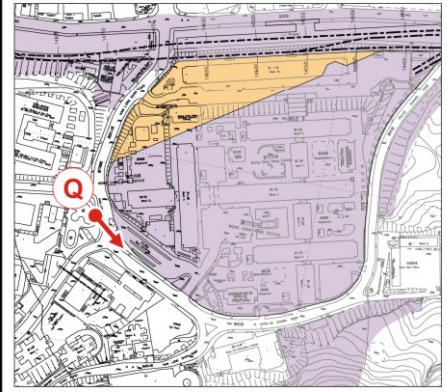

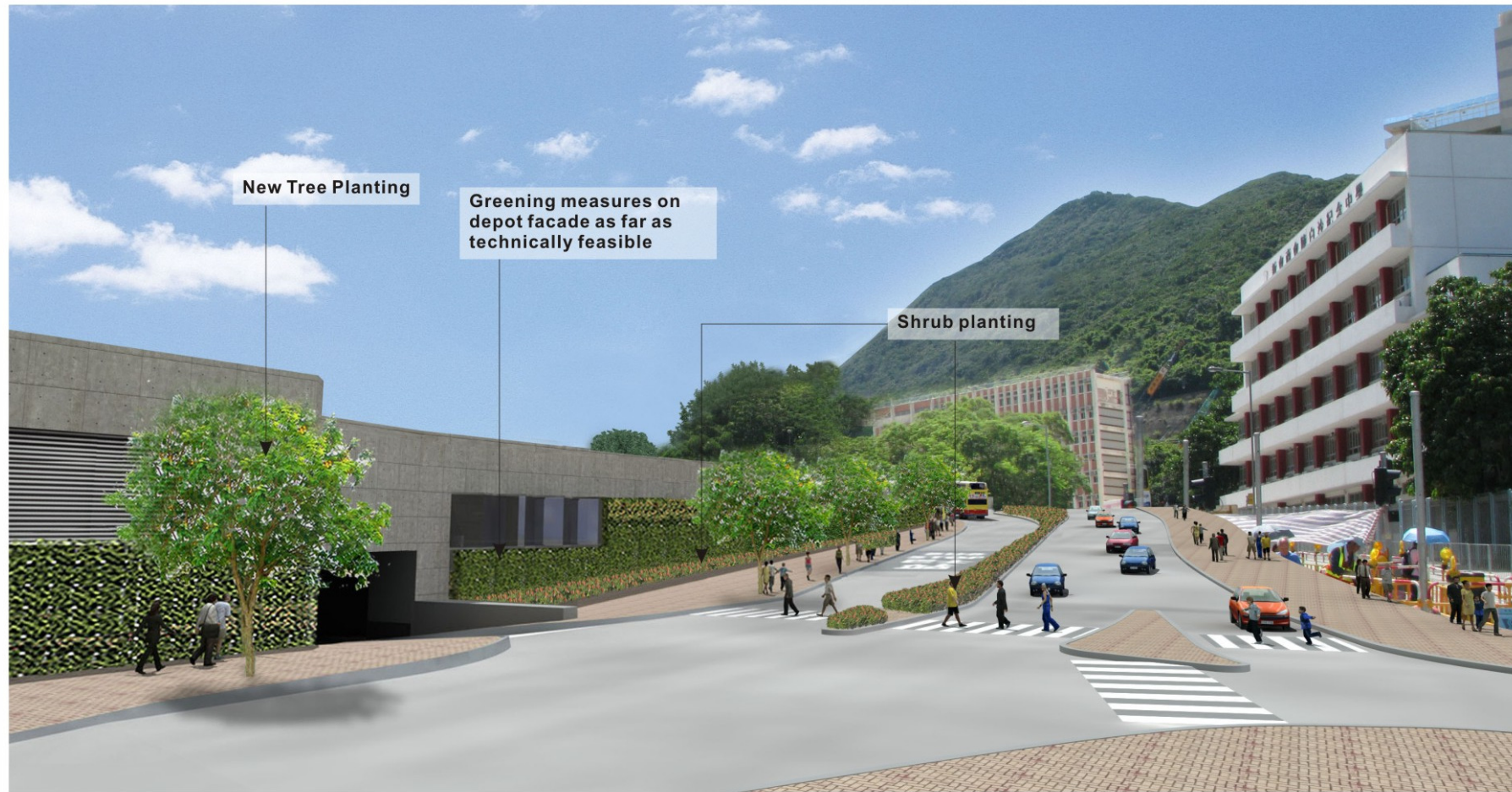

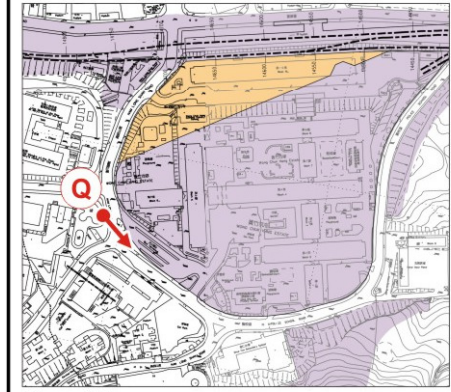
Day 1 of Operation Phase with landscape mitigation measures

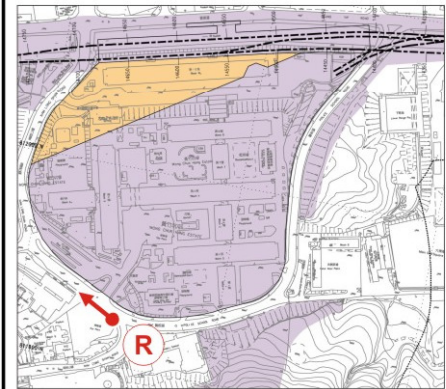
