


VSR 40 Photomontage- with mitigation at Day 1

Description:

- This VSR represents the residents and visitors near the Tuen Mun South Coast area, facing south to Tung Chung Town. The visual impacts would mainly result from the appearance of new development on the proposed • reclamation land of TCE.
- Following application the mitigation measures including maximise greening on structures with aesthetic design of built development, it is considered that they can assist greatly in breaking up the appearance of the proposed development and help to assimilate the proposed development into the receiving landscape, which can alleviate the potential visual impact.
