<sup>(2)</sup> According to Appendices G and H of the Annual Traffic Census 2014, all of the trafficable lengths of minor road networks in New Territories belong to local distributors with possible cold-start trips. For the major road networks in Hong Kong, however, a small portion (about 28%) of the trafficable lengths belong to local distributors or rural roads with possible cold-start trips, whereas the remaining large portion (about 72%) belong to expressways, trunk roads; primary or district distributors, all of which have stopping/parking restrictions and hence no cold-start trips. Therefore, the % of daily vehicle-km for local distributors and rural roads in Hong Kong, which is on the low side and will in return result in conservative estimates for the no. of trips.
