# Police Facilities at Kong Nga Po Operation Information of Police Facilities

#### **General**

The Project site will be incorporated with at least 2.5m height perimeter wall / boundary wall so as to avoid the direct line of sight from the nearby NSRs to its noise sources (e.g. Helipad, Reprovisioning of Lo Wu Firing Range, Re-provisioning of Ma Tso Lung Firing Range, Police Training Facilities (PTF), Weapon Training Facilities (WTF) and Police Driving and Traffic Training Facilities (PD&TTF)).

#### **Helipad**

## Reply from HKPF:

• (Replied by HKPF on 20 June 2016) The necessary information of the helicopter training during day-time period in the EIA report can be minimised as in the following Table:

- (Replied by HKPF on 21 June 2016) Maximum of 2 helicopters would be on the site, and only one helicopter will be in action during emergency use / non-emergency use.
- (Replied by HKPF on 23 June 2016) The emergency use at the planned KNP helipad includes air ambulance, search & rescue, supporting law enforcement agencies and fire fighting.

#### Re-provisioning of Lo Wu Firing Range

# Reply from HKPF:

- (Replied by HKPF on 4 March 2015) Rifles, Sub-machine guns & Handguns; 20 firing lanes; 10M, 15M, 25M, 50M, 100M, 200M and 300M; Barricade location at 15M, 25M and 50M; 100 shots/lane/30 minutes.
- (Replied by HKPF on 22 June 2015) The operation hours of the firing ranges would normally be between 0800 and 1800 hrs.
- (Replied by HKPF on 22 June 2015) Examples of common types of firearms used: .38 revolver, 9mm pistol, 9mm sub-machine gun (H&K MP5), 5.56mm rifle (AR 15), 12 guage shotgun.
- (Replied by HKPF on 22 June 2015) The average firing rate on the 20 lanes of the range in a 30-minute period would be circa. 1,000 rounds. There are no restrictions on the firing rate for the range.
- (Replied by HKPF on 22 June 2015) The range should be orientated from north to south (firing from the north side to the south side).

# Police Facilities at Kong Nga Po Operation Information of Police Facilities

- (Replied by HKPF on 21 July 2015) The operation hours of the all planned facilities (i.e. firing ranges, PTF, WTC, police driving and training facilities) would be from 7am to 11pm, i.e. not operated during night-time period as the police facilities is closed during night-time except for urgent police operation.
- (Replied by HKPF on 21 July 2015) No new weapon would be planned to use in the planned firing ranges up to now.
- (Replied by HKPF on 27 October 2015) HKPF has no plan and normally will not conduct shooting activities or driving/traffic training activities during night-time period (i.e. 11pm to 7am). Activities involved in "urgent operations" (e.g. combating serious crimes, large-scale rescuing operations, etc.), if any, would be more than justifiable case by case. Activities may involve the return of concerned officers to the campus to get dressed in uniform, drawing gear and equipment, and then leaving campus by police vehicles, etc. These activities will not involve any potential fixed noise source such as powered mechanical equipment, skidding/braking driving, sirens, simulation shooting or shooting.

### Re-provisioning of Ma Tso Lung Firing Range

#### Reply from HKPF:

- (Replied by HKPF on 4 March 2015) Sub-machine guns, Shotguns and Handguns; 6 firing lanes;
   10M, 15M, 20M and 25M; Barricade location at 10M, 15M and 20M; 70 shots/ lane/ 30 minutes.
- (Replied by HKPF on 4 March 2015) 4-Side walls at 5m height.
- (Replied by HKPF on 22 June 2015) The operation hours of the firing ranges would normally be between 0800 and 1800 hrs.
- (Replied by HKPF on 22 June 2015) Examples of common types of firearms used: .38 revolver,
   9mm pistol, 9mm sub-machine gun (H&K MP5), 12 gauge shotgun.
- (Replied by HKPF on 22 June 2015) There are no restrictions on the firing rate for the range.
- (Replied by HKPF on 22 June 2015) A sand trap is used as the bullet trap.
- (Replied by HKPF on 22 June 2015) Range should be orientated from north to south.

# **Existing San Uk Ling Firing Range**

#### Reply from HKPF:

(Replied by HKPF on 21 July 2015) The existing San Uk Ling Firing Range will use the same type of weapons as those on the Lo Wu Range and the operating times will also be the same. There are 8 firing lanes and the maximum number of shots per lane in a 30-minute period would be 250. There are no specific noise mitigation measures.

### Reply from HKPF:

# Police Facilities at Kong Nga Po Operation Information of Police Facilities

- (Replied by HKPF on 29 May 2015) No live firing will be conducted at this location.
- (Replied by HKPF on 21 July 2015) PTF would be a new training complex.
- (Replied by HKPF on 21 July 2015) No outdoor weapons shooting would be expected in PTF.
- (Replied by HKPF on 21 July 2015) Limited noisy outdoor activity/facilities, confined to occasional vehicle sirens/simulation shooting maximum of 4 times per day for no more than 30 minutes on each occasion.

### Weapon Training Facilities (WTF)

#### Reply from HKPF:

- (Replied by HKPF on 22 June 2015) No live firing will be conducted at this location.
- (Replied by HKPF on 21 July 2015) Noisy activities would be housed indoor with non-openable window and central air-conditioning at WTF.
- (Replied by HKPF on 21 July 2015) Limited noisy outdoor activity/facilities, confined to occasional vehicle sirens/simulation shooting maximum of 4 times per day for no more than 30 minutes on each occasion.
