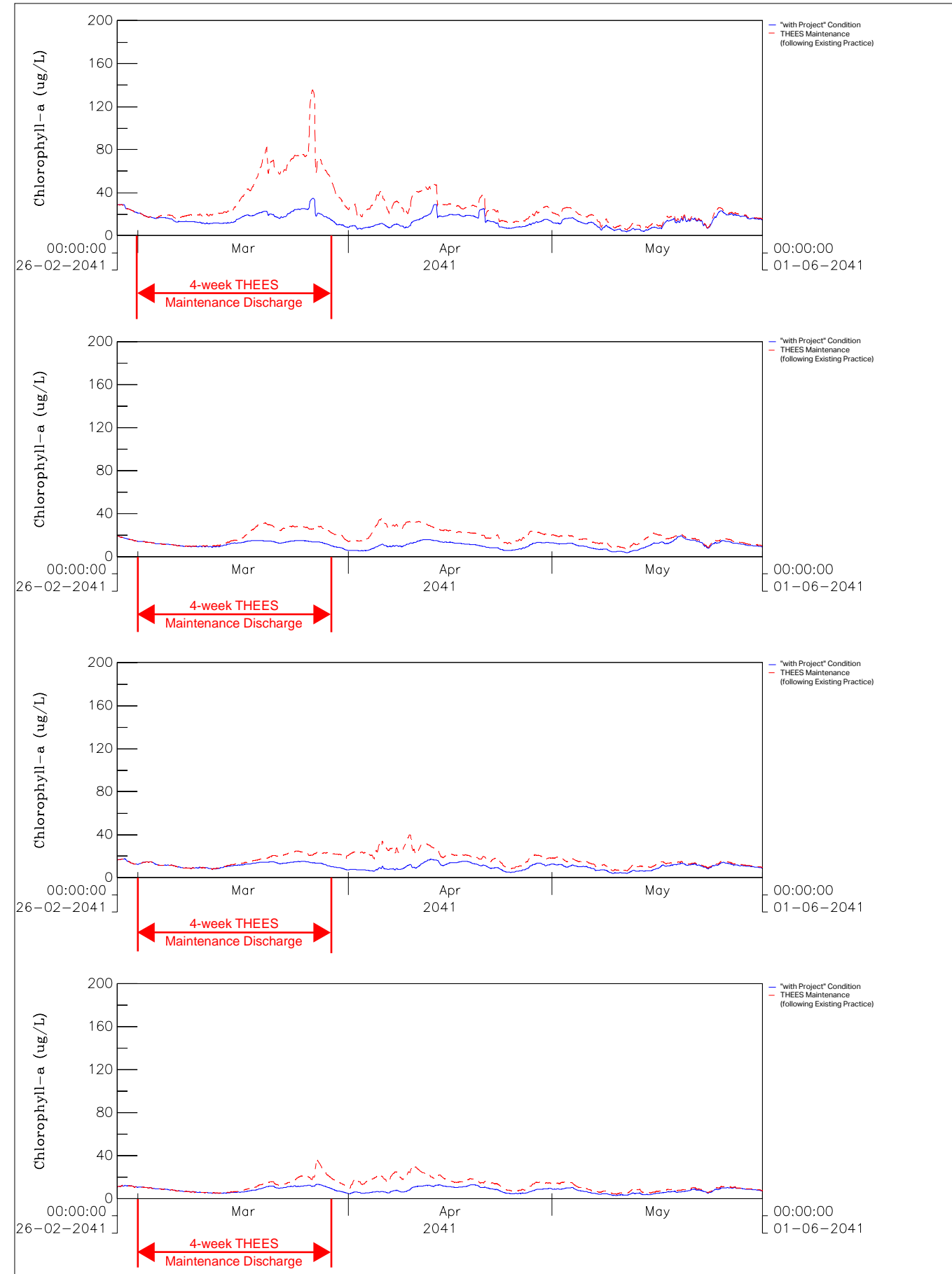

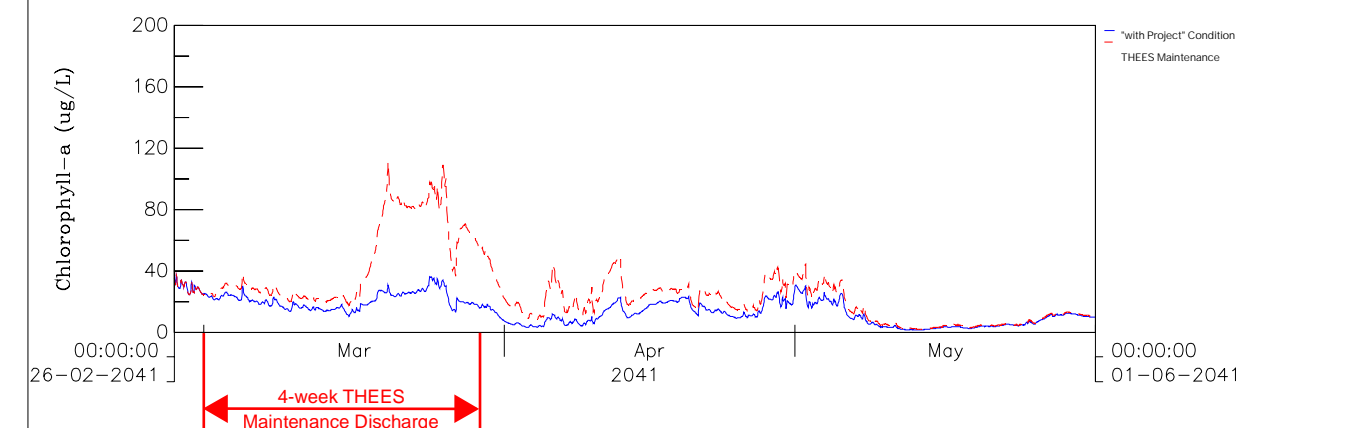
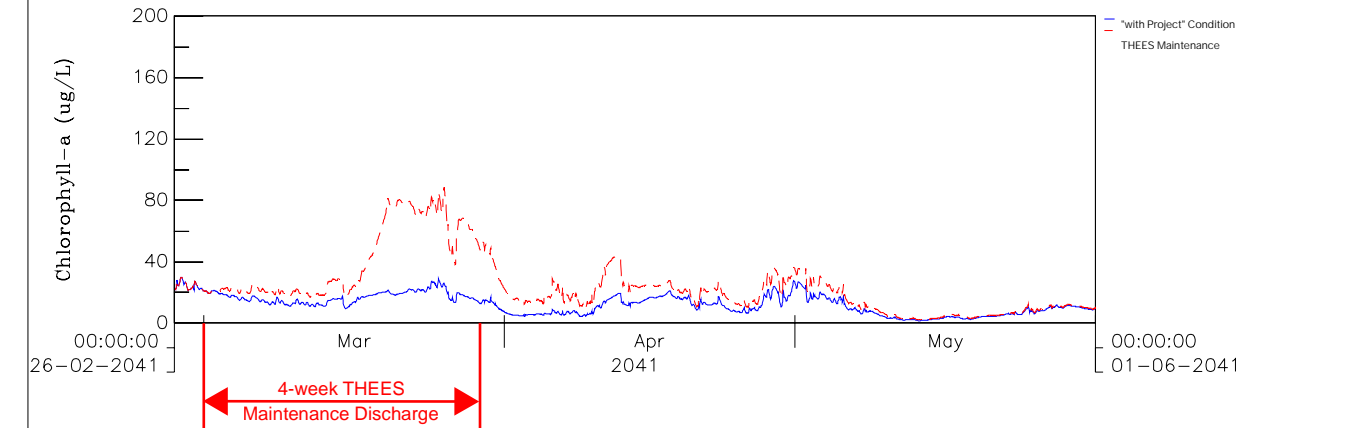
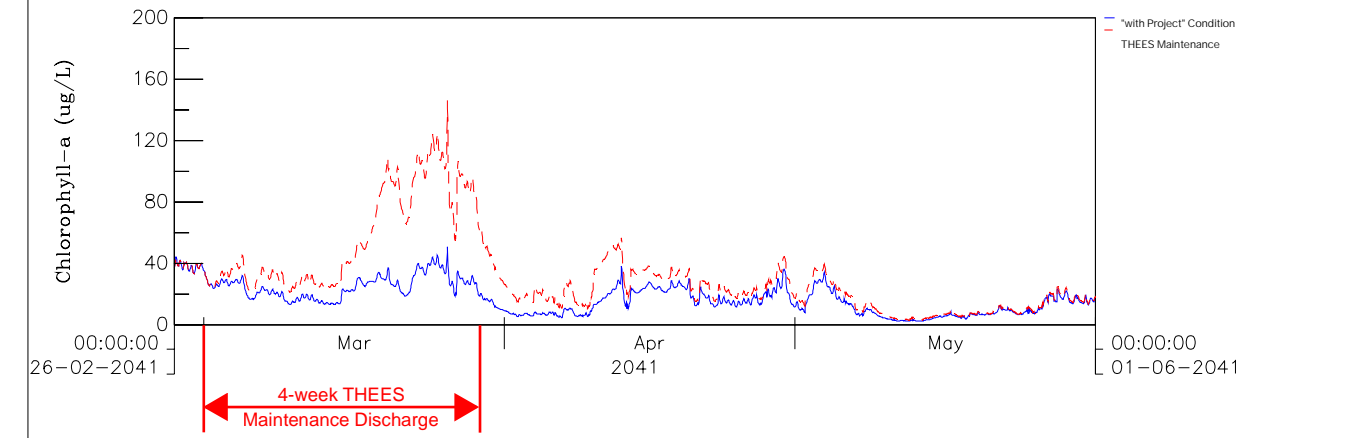
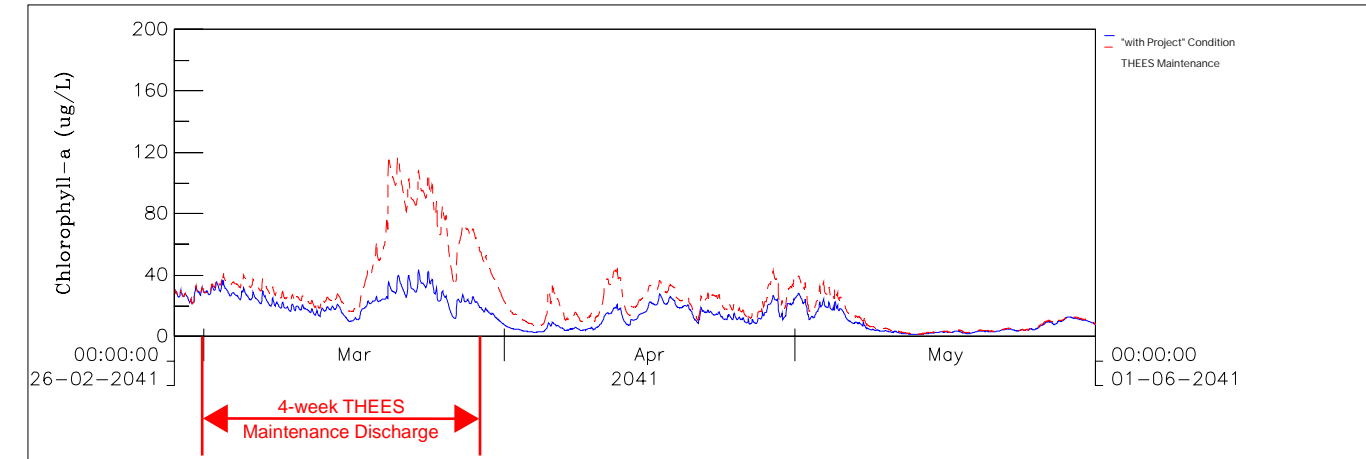
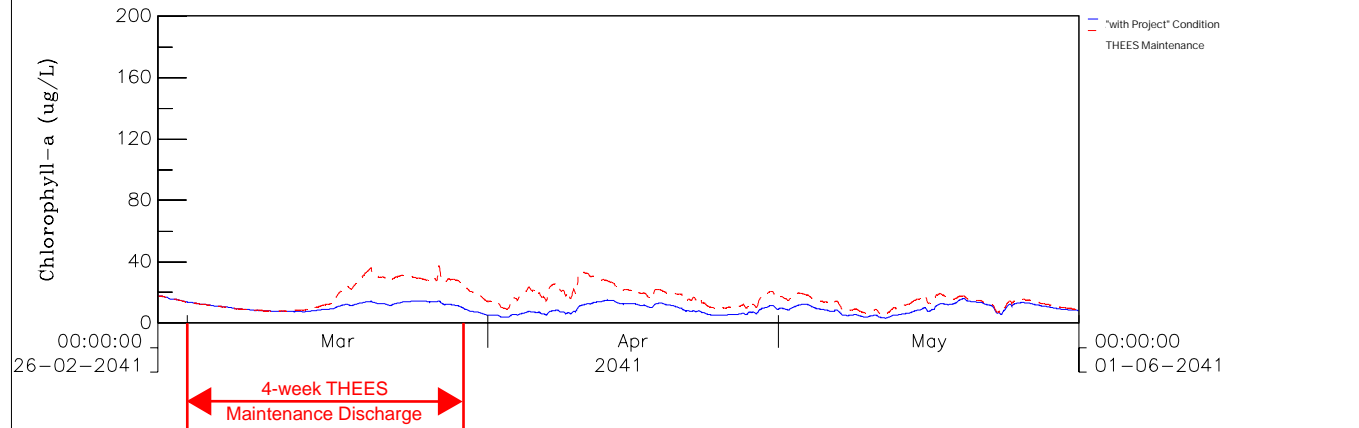
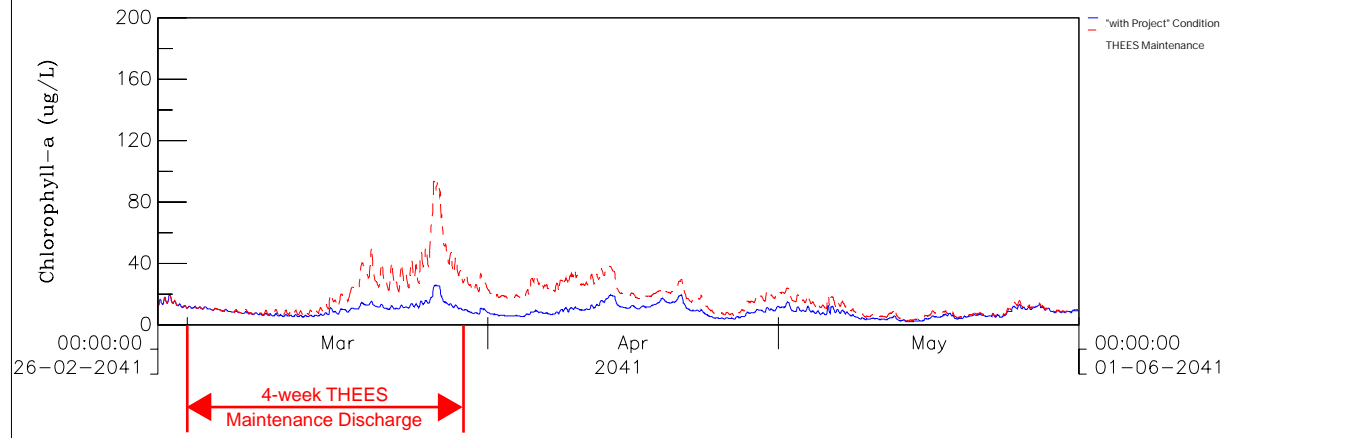
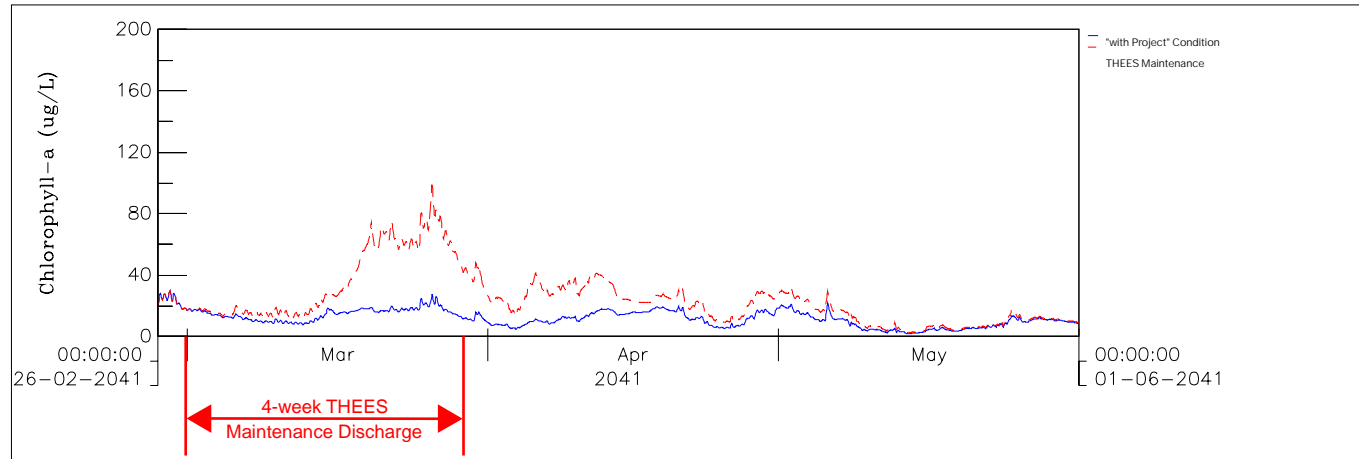
Timeseries Plot for Surface Chlorophyll-a (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

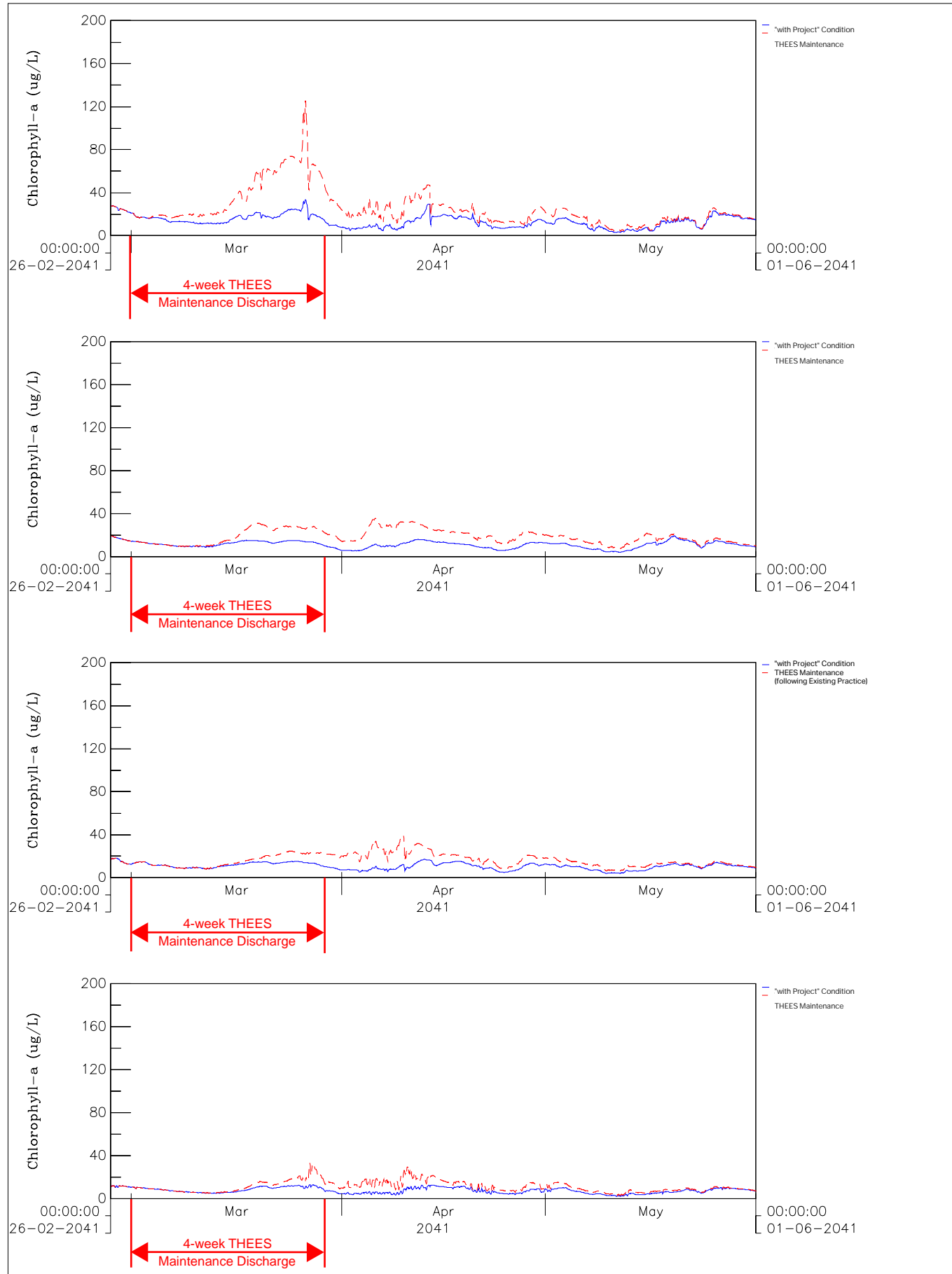

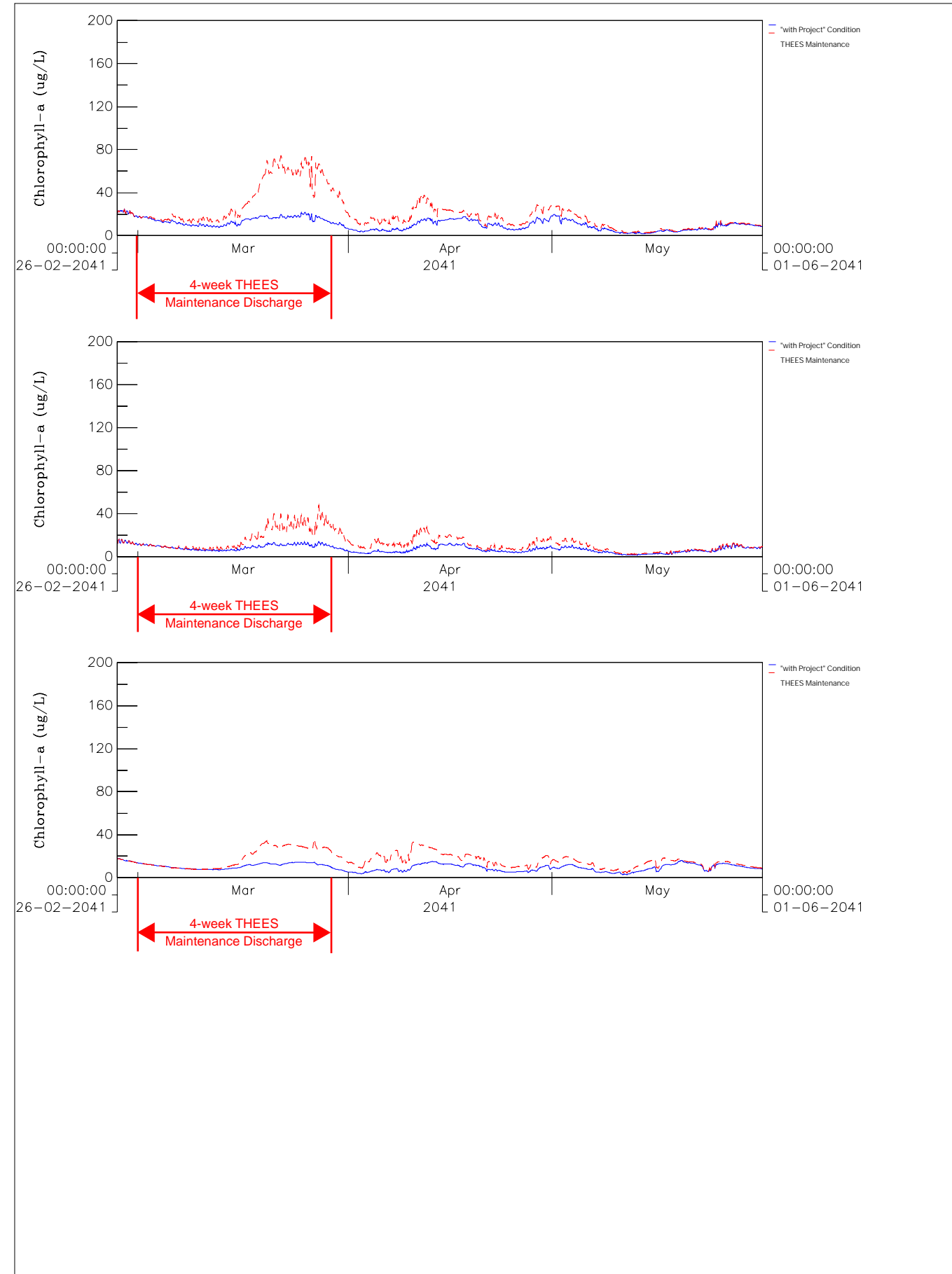
Timeseries Plot for Mid-Depth Chlorophyll-a (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

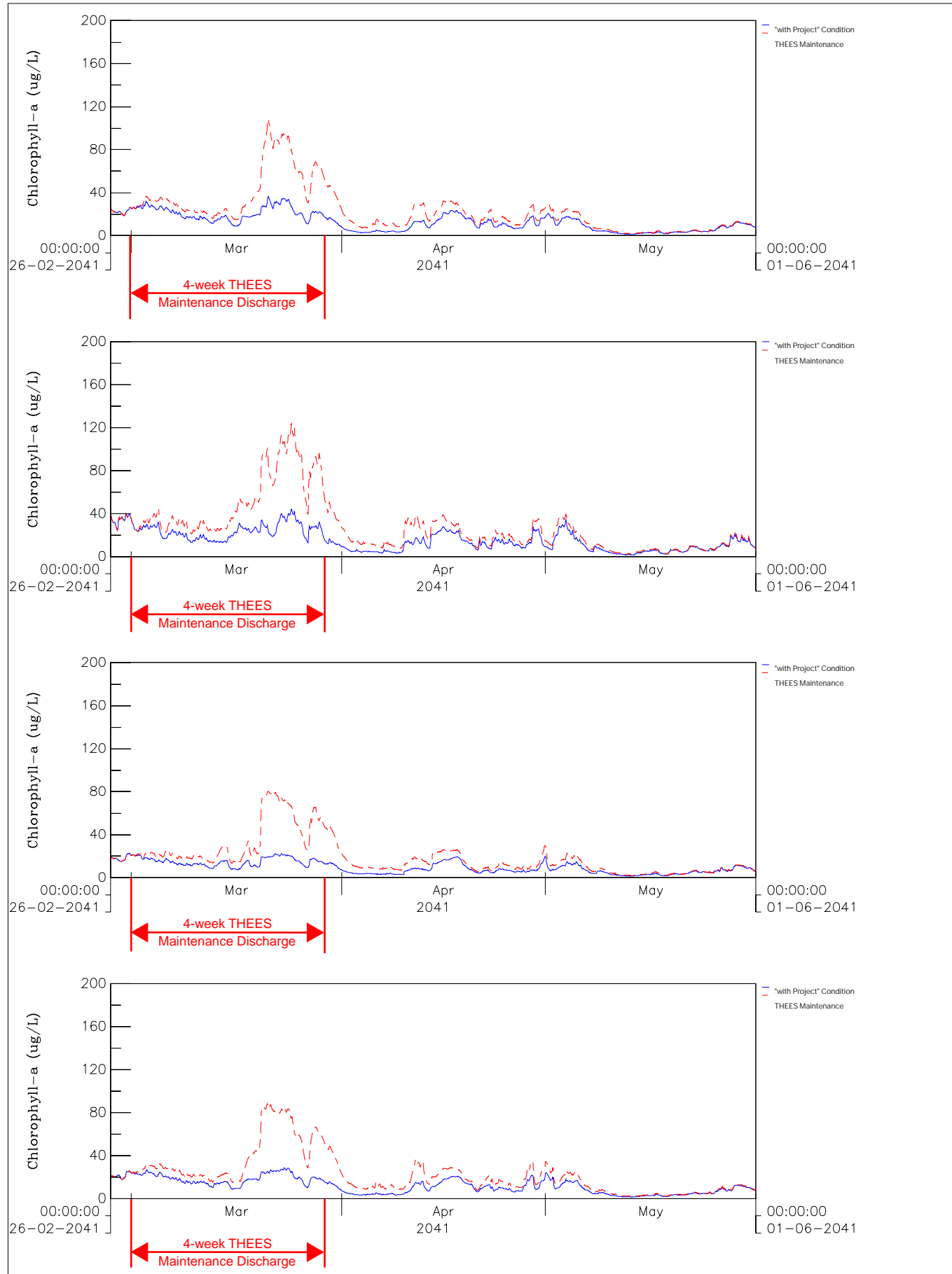
Timeseries Plot for Mid-Depth Chlorophyll-a (Top: TM4; Upper: TM6; Lower: B1)

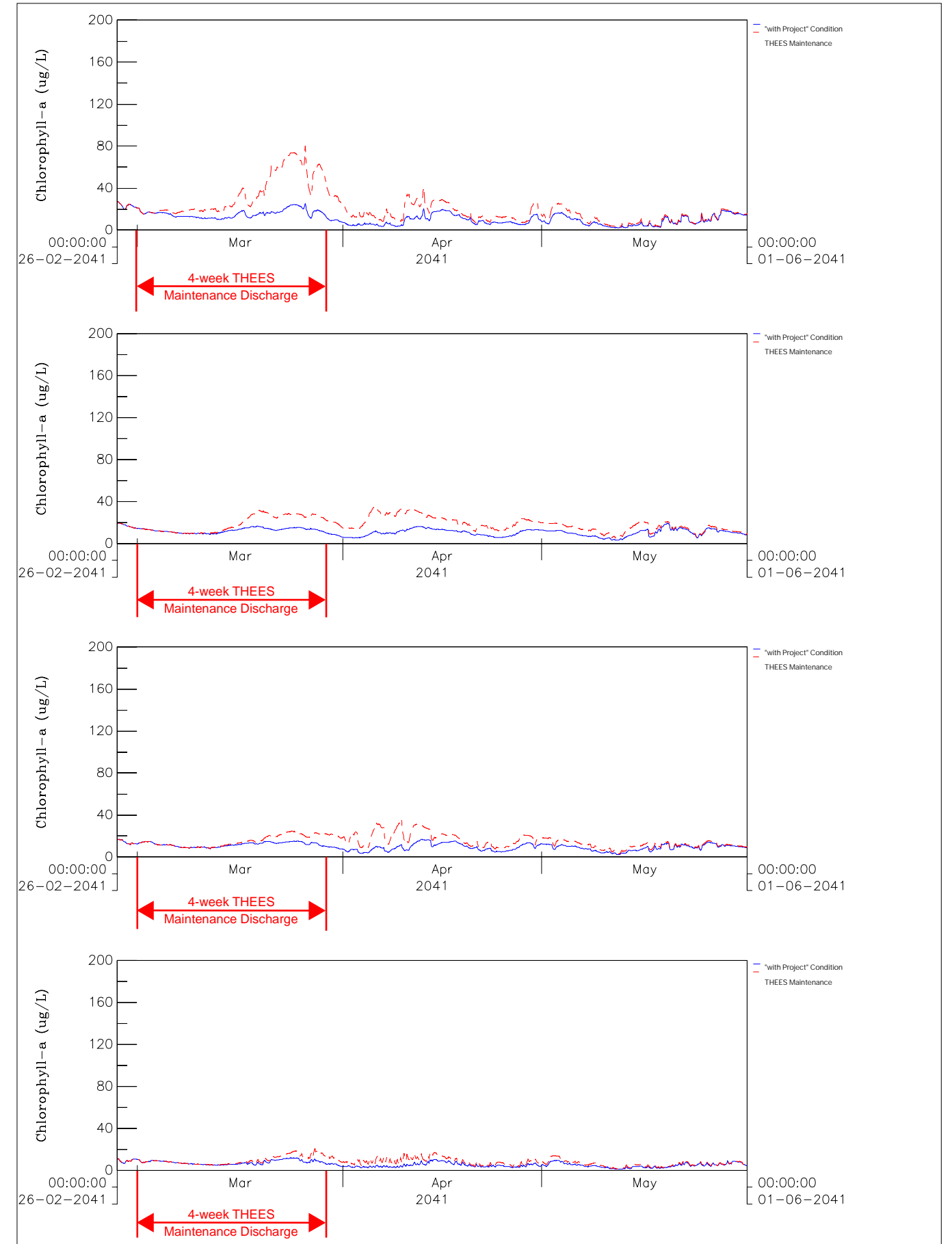
Timeseries Plot for Bottom Chlorophyll-a (Top: W1; Upper: W2; Lower: CR16; Bottom: CR17)

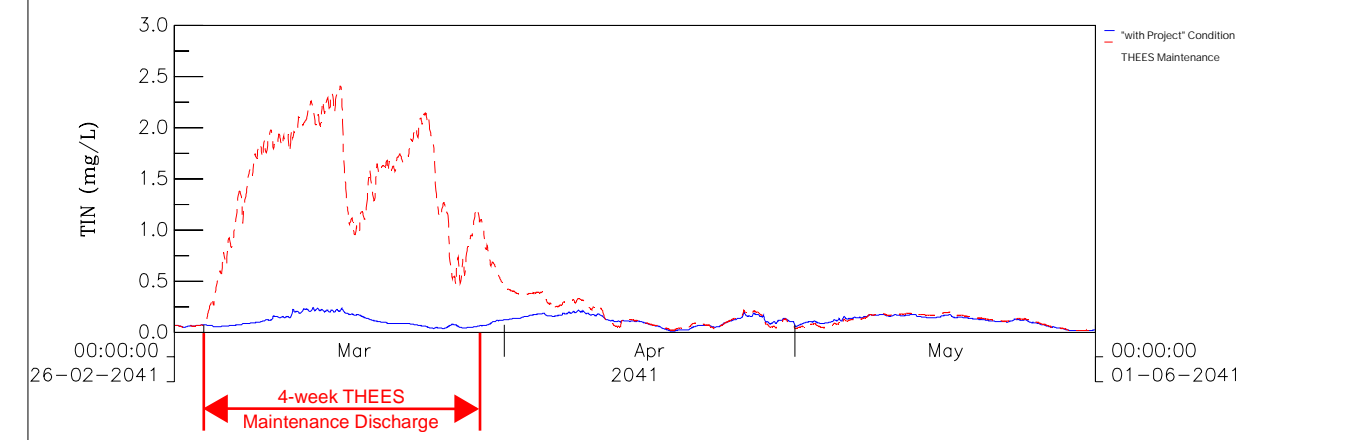
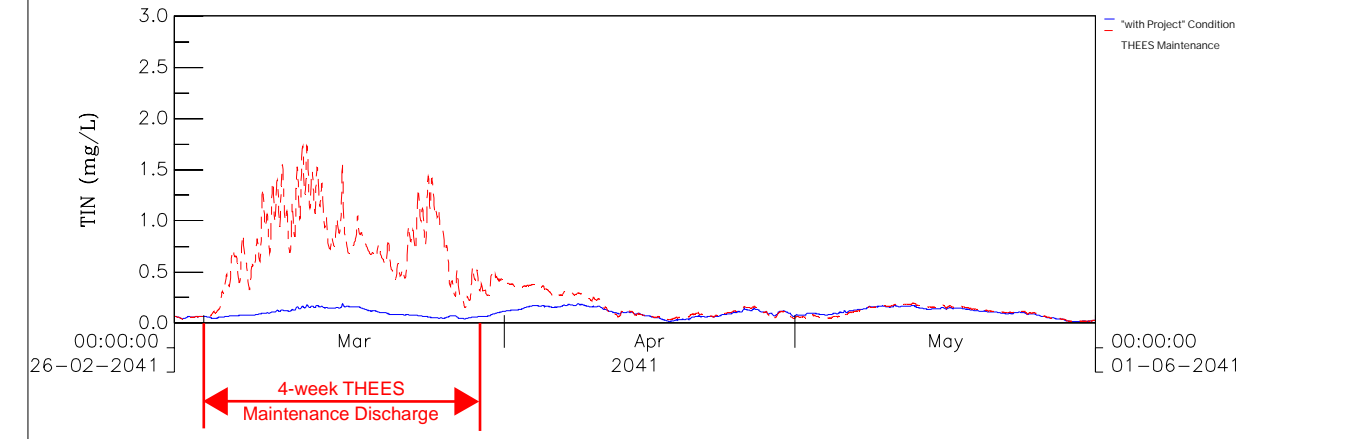
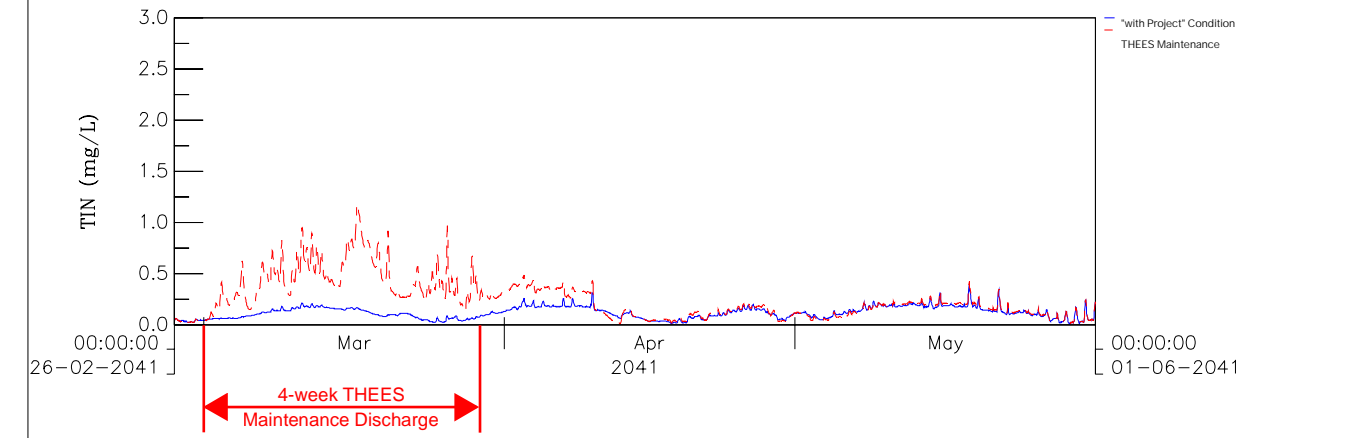
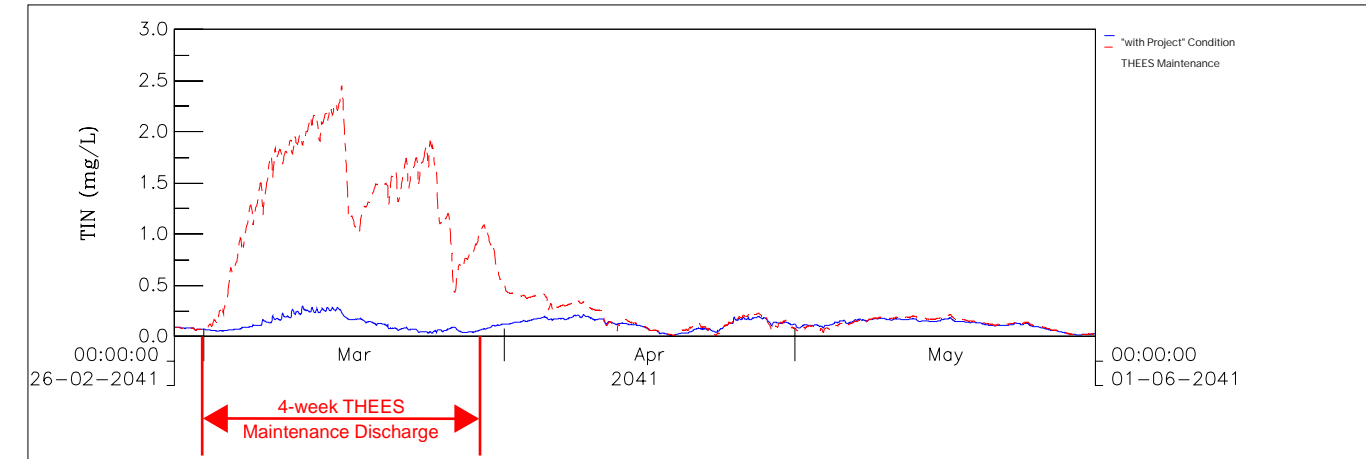
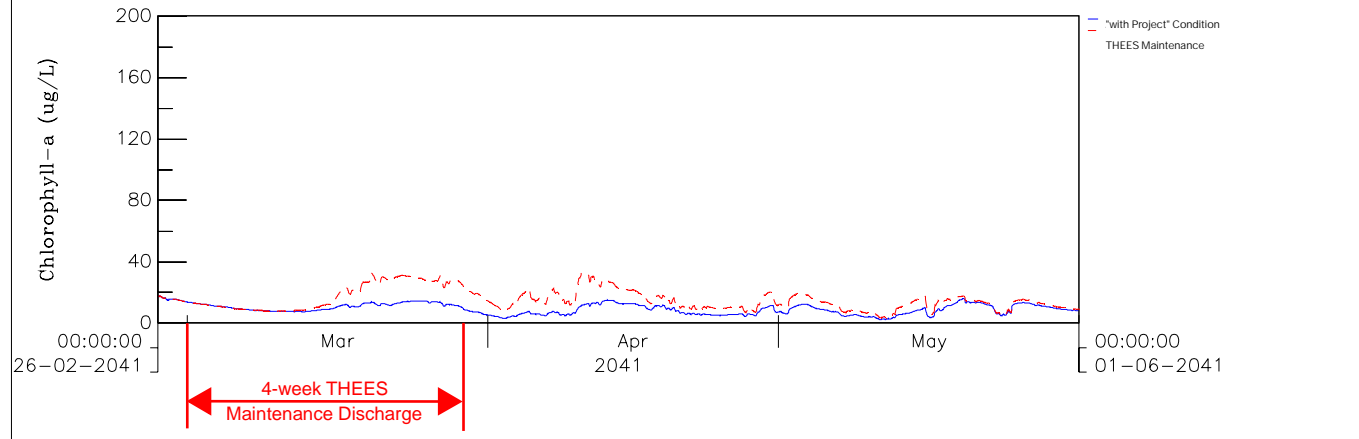
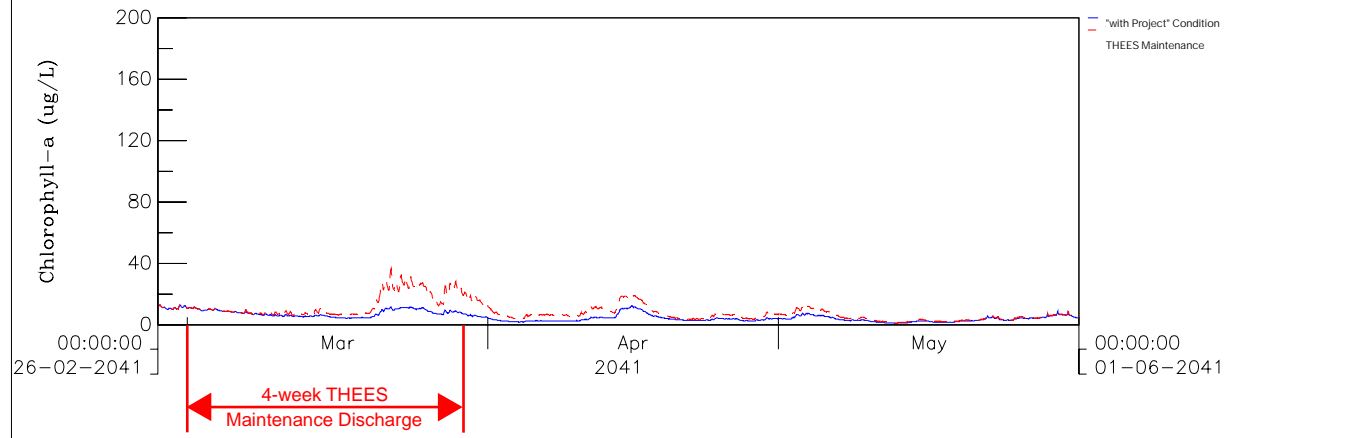
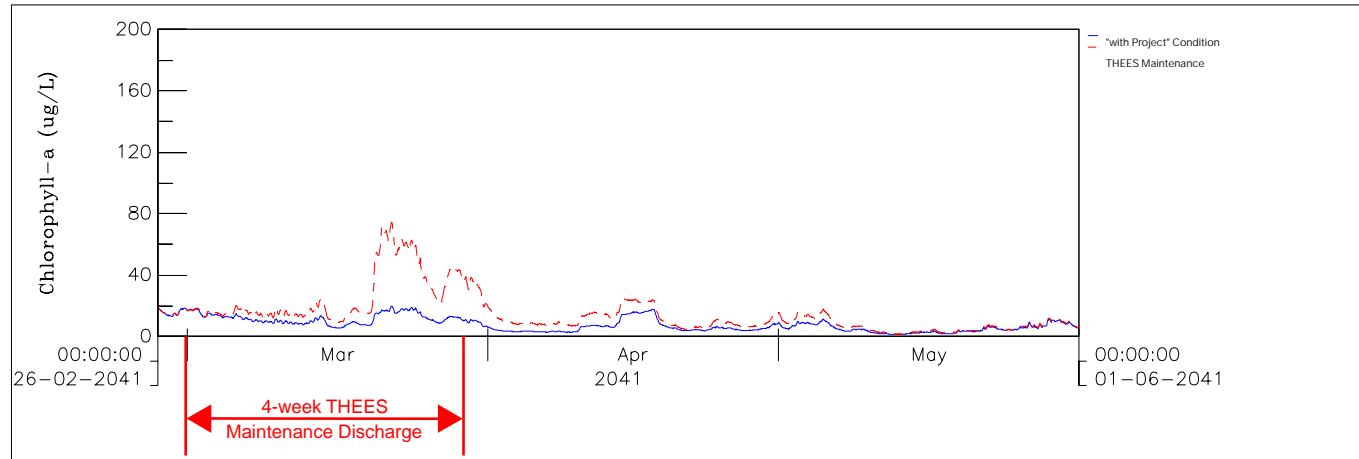
Timeseries Plot for Bottom Chlorophyll-a (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

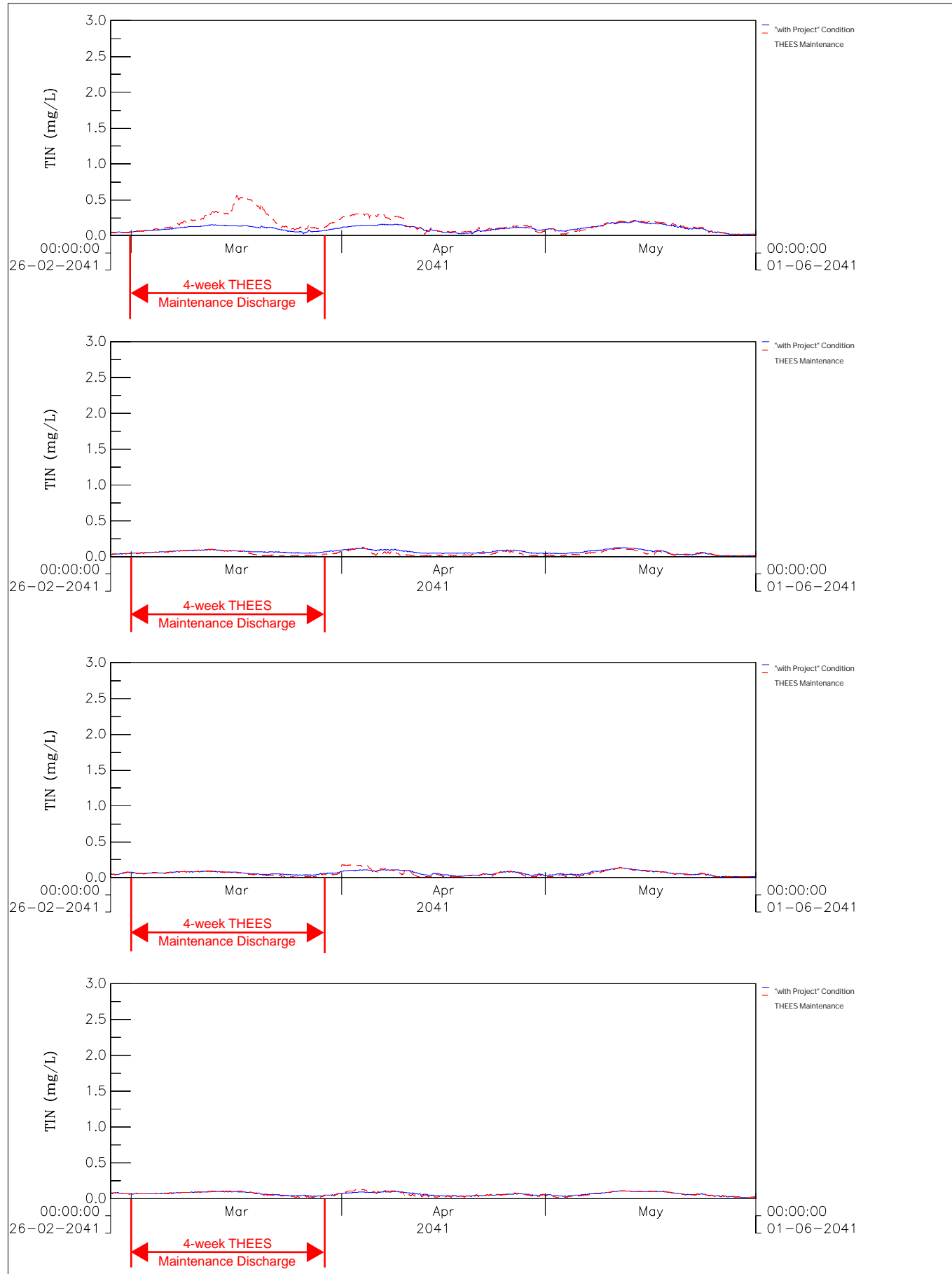

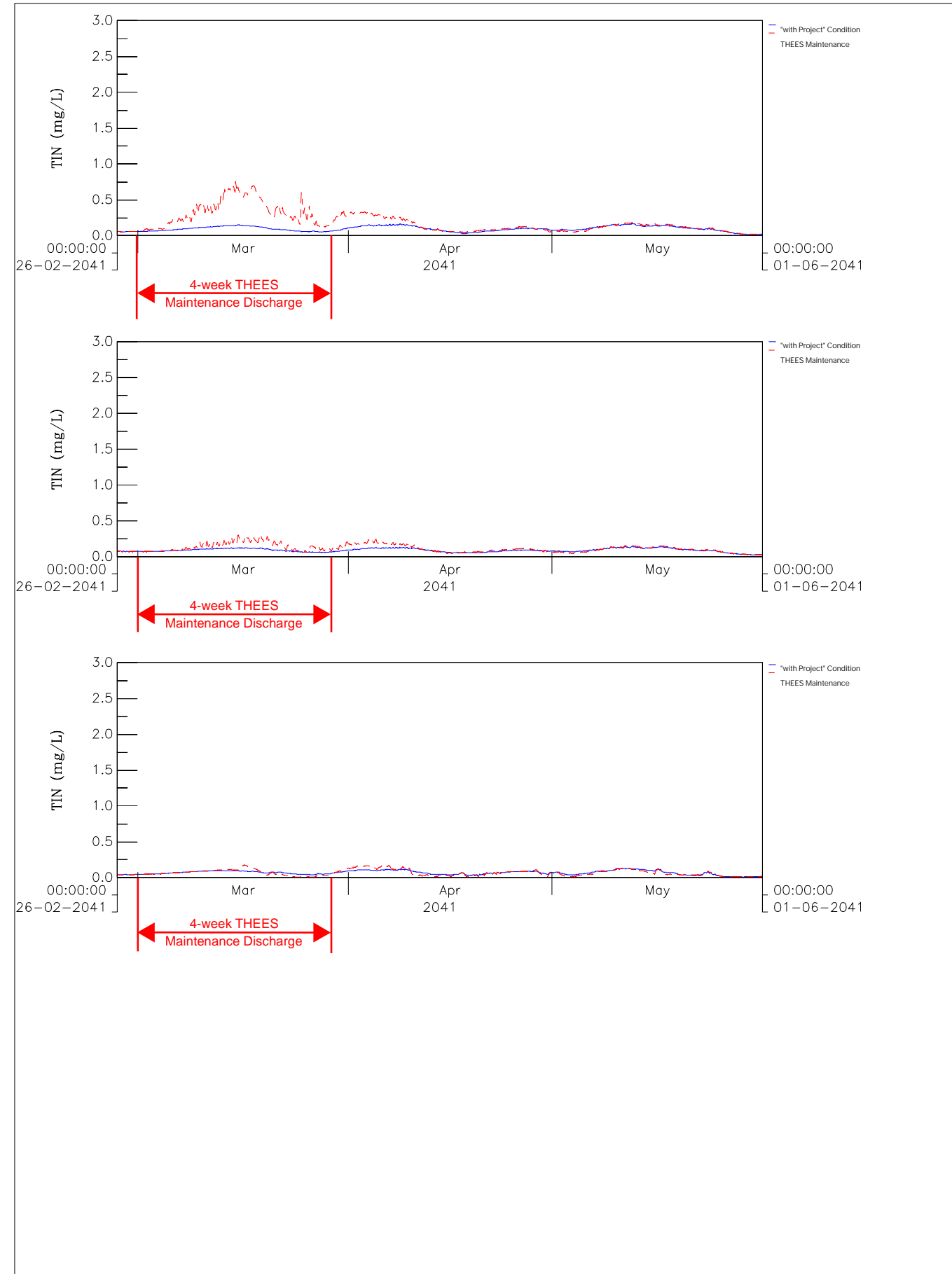
Timeseries Plot for Depth-Averaged Total Inorganic Nitrogen (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

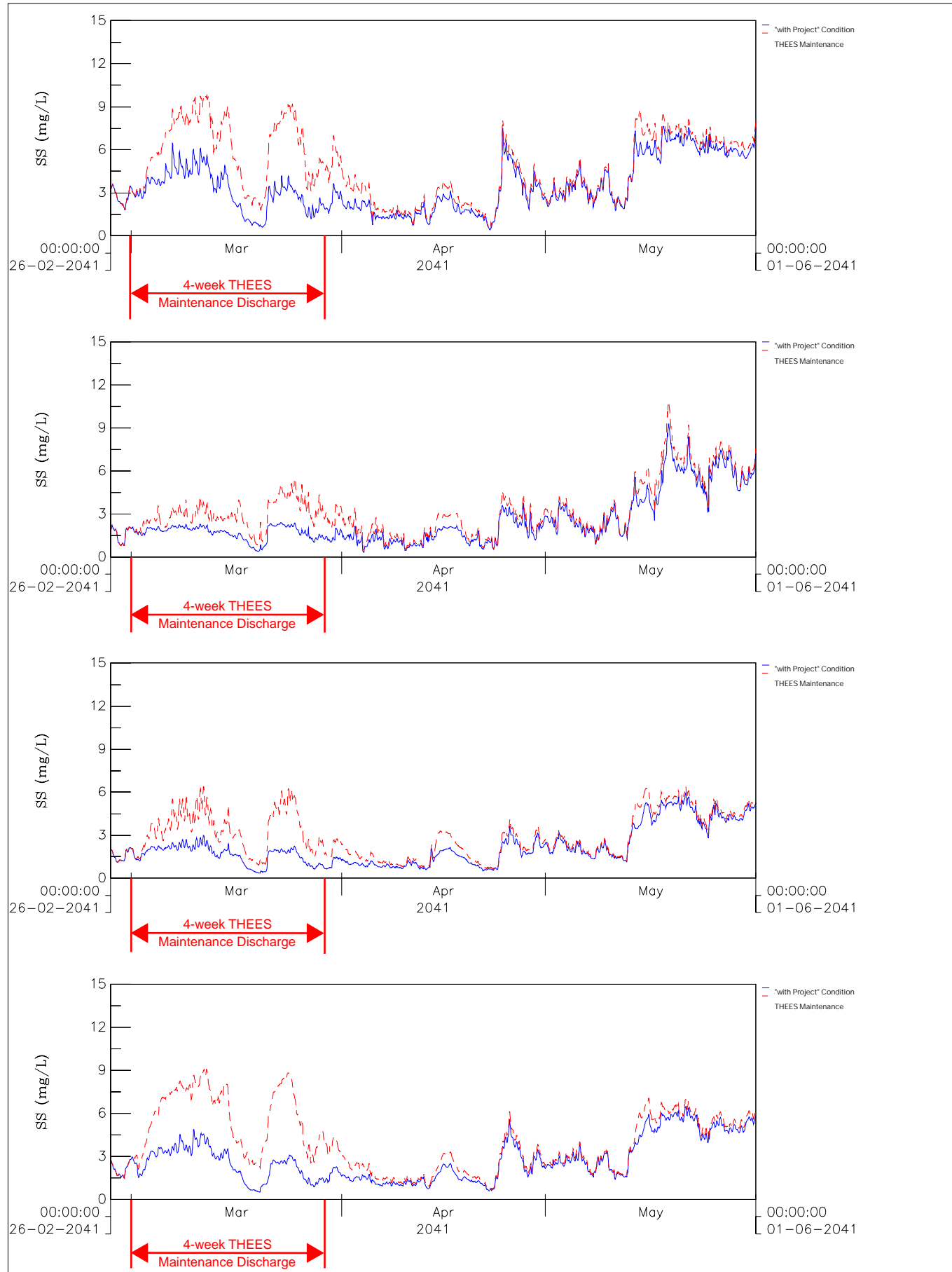
Timeseries Plot for Depth-Averaged Total Inorganic Nitrogen (Top: TM4; Upper: TM6; Lower: B1)

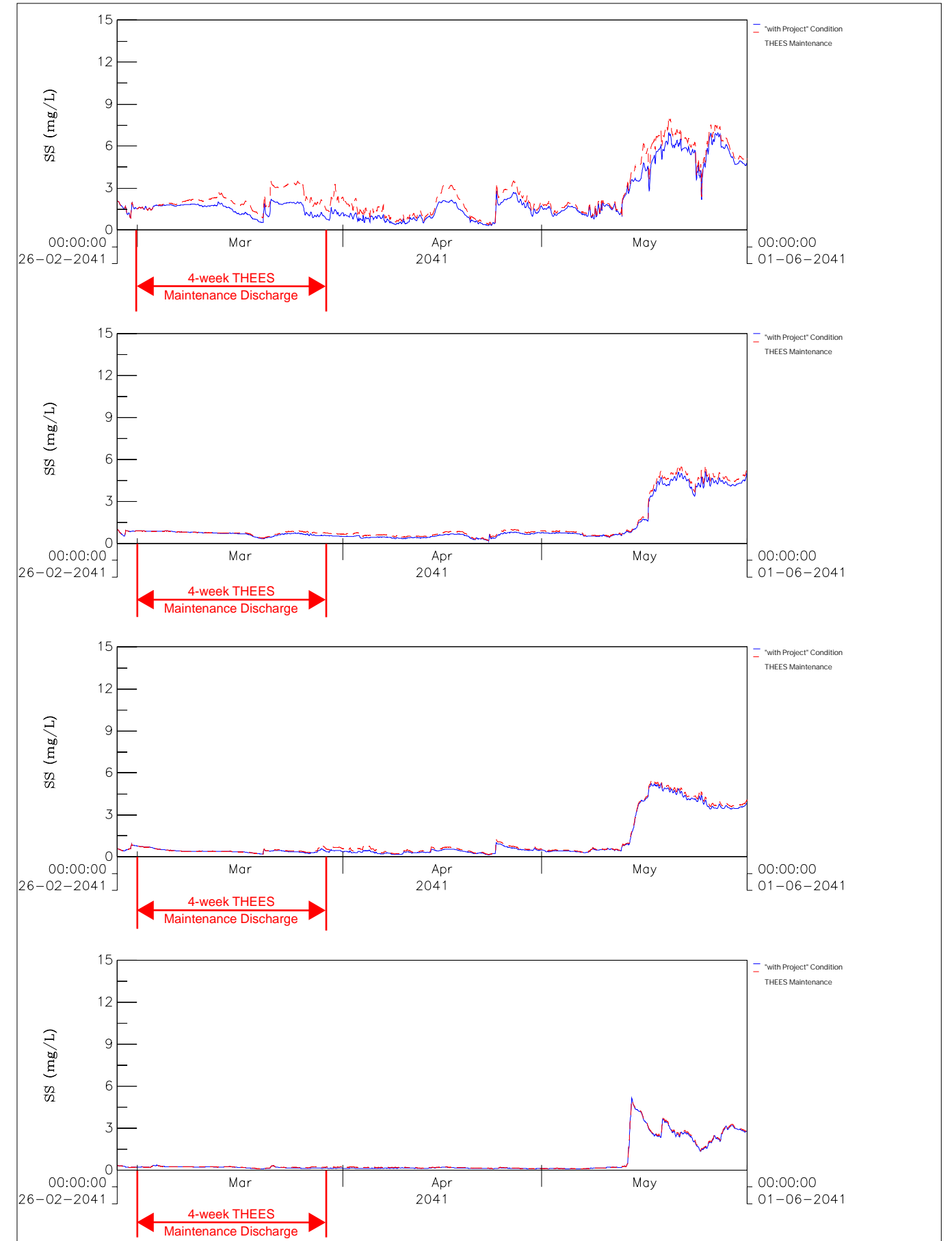

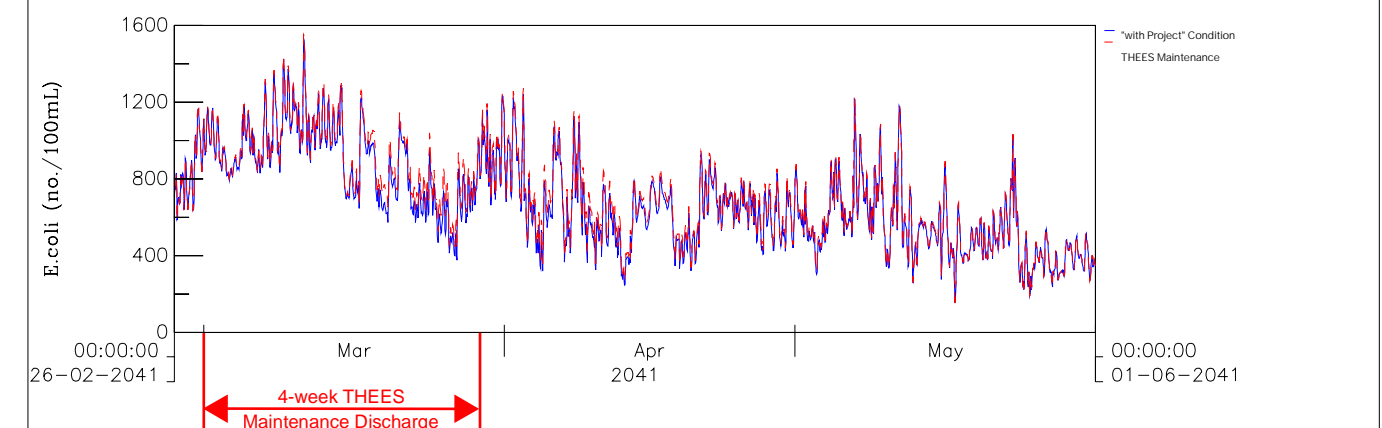
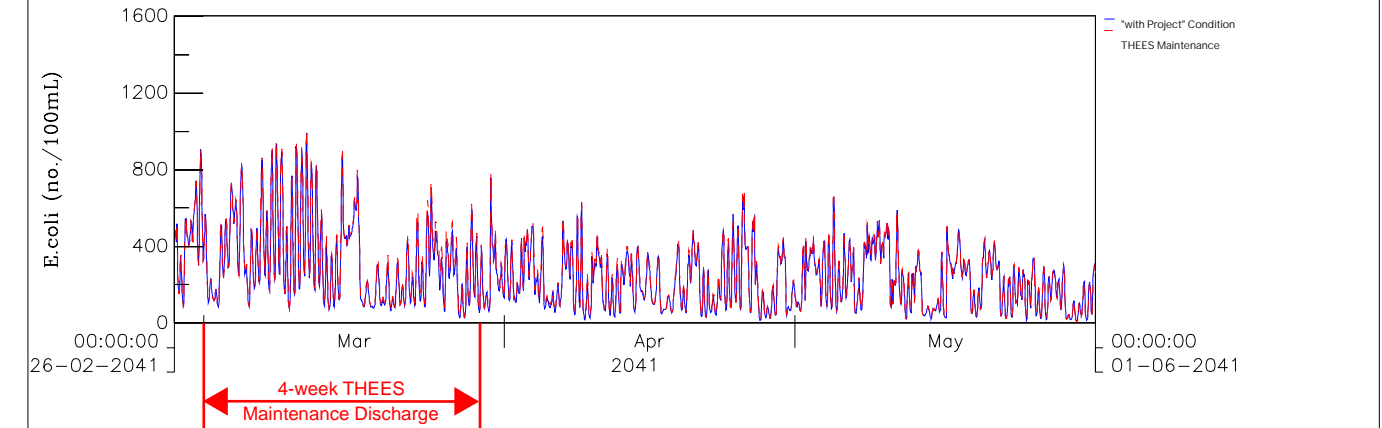
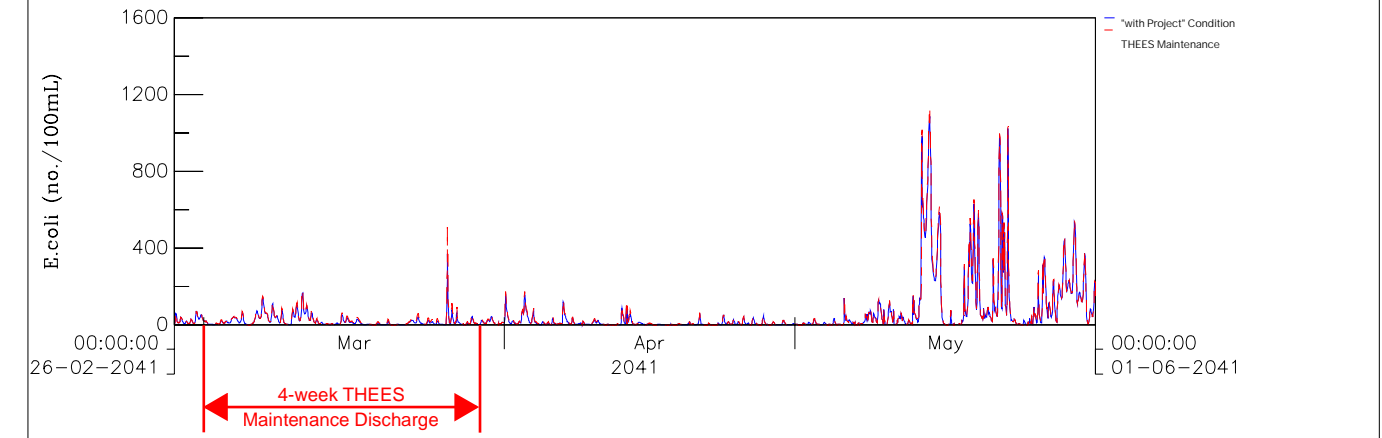
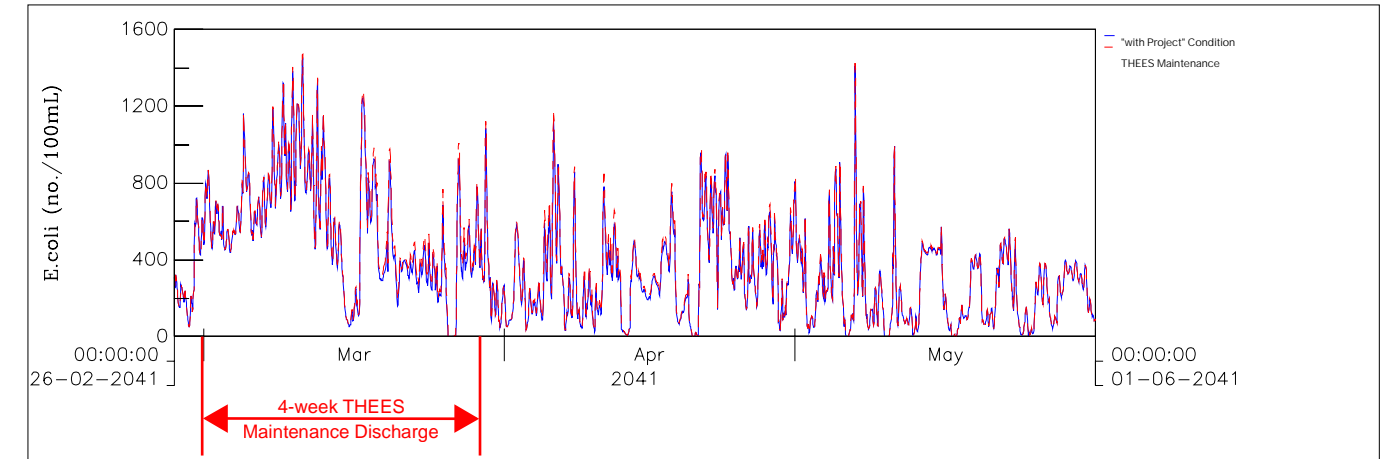
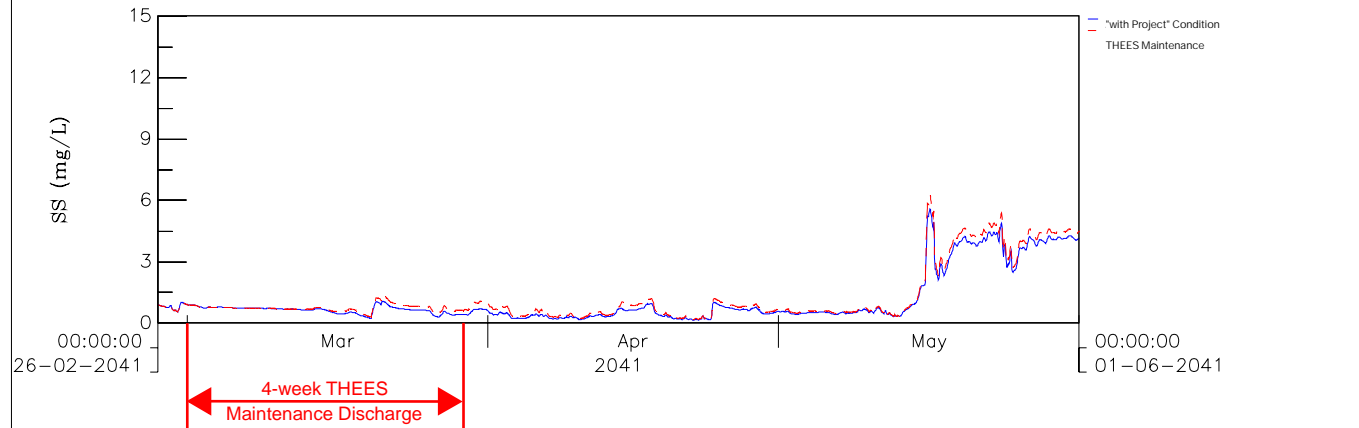
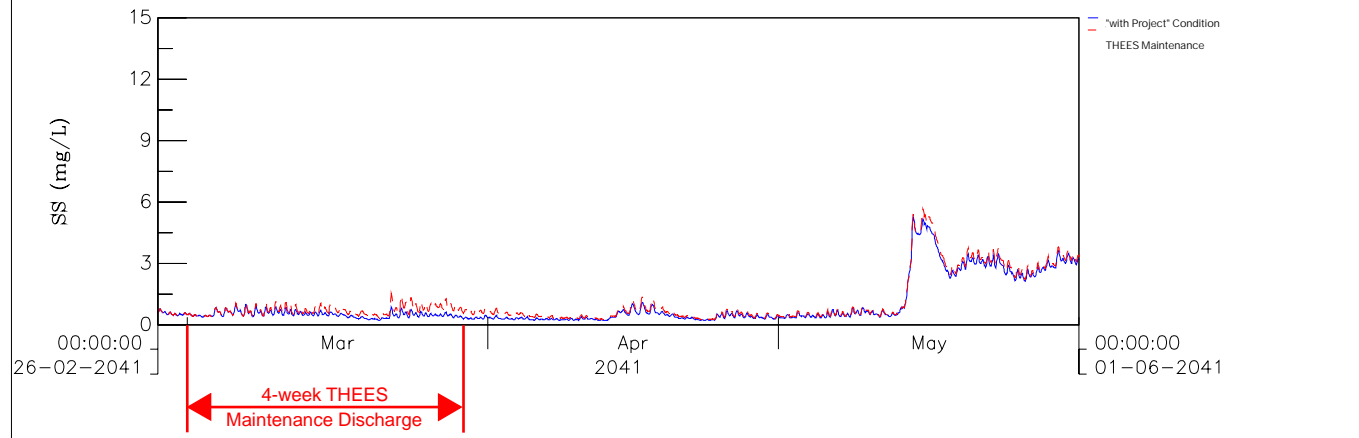
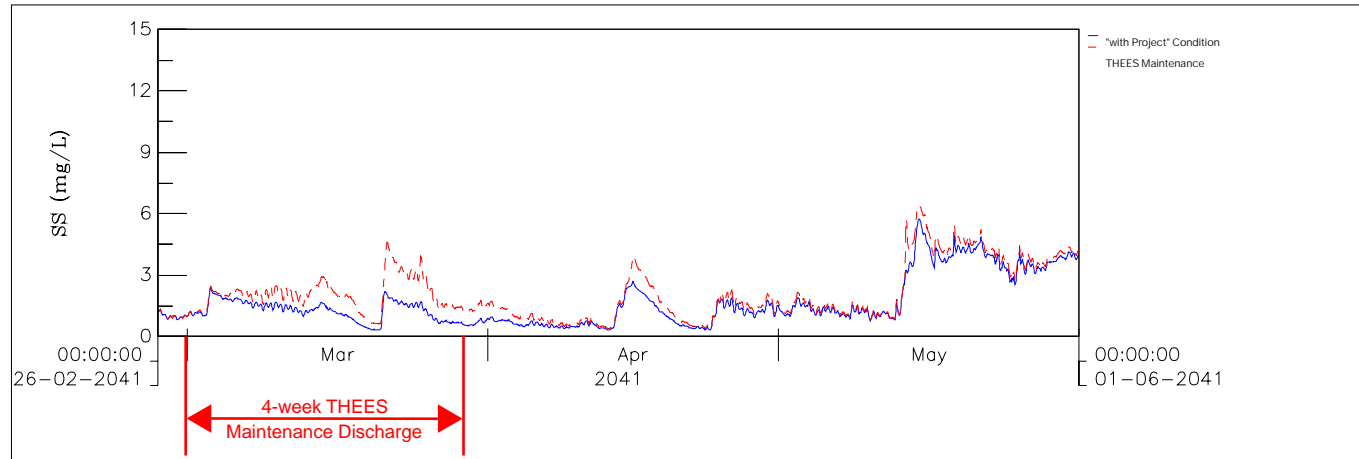
Timeseries Plot for Depth-Averaged Suspended Solids (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

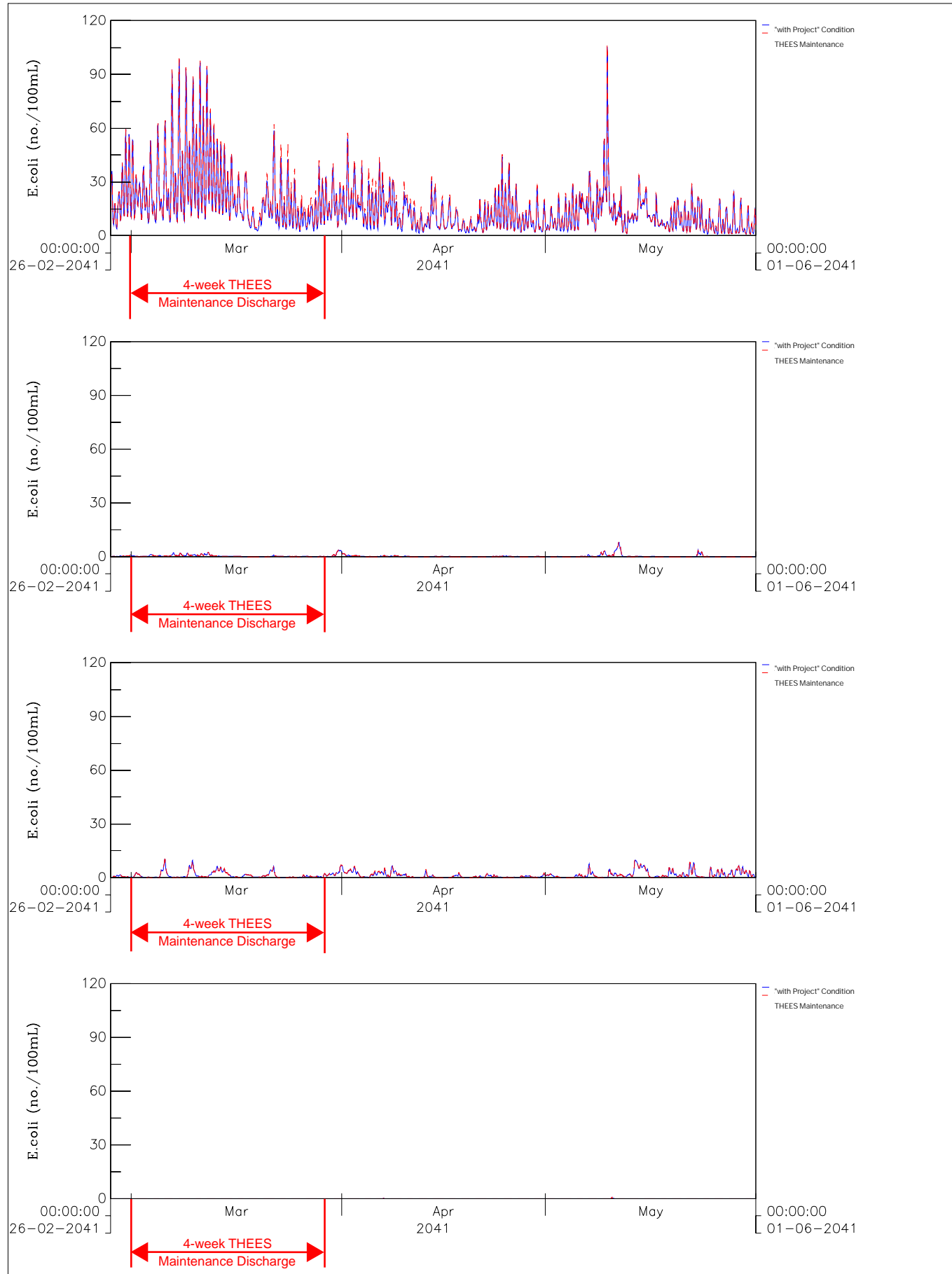

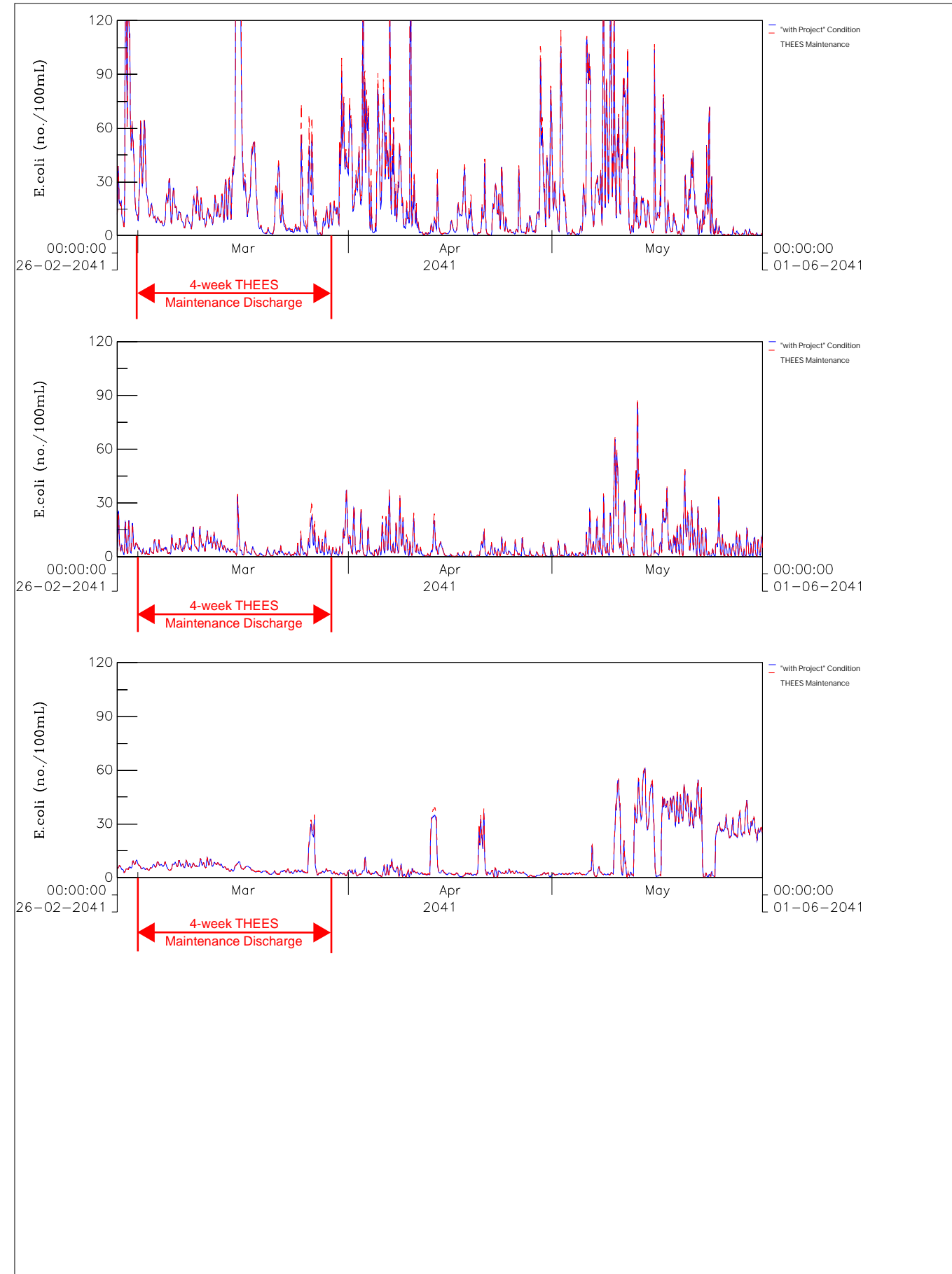
Timeseries Plot for Depth-Averaged E.coli (Top: F1; Upper: F2; Lower: F3; Bottom: F4)

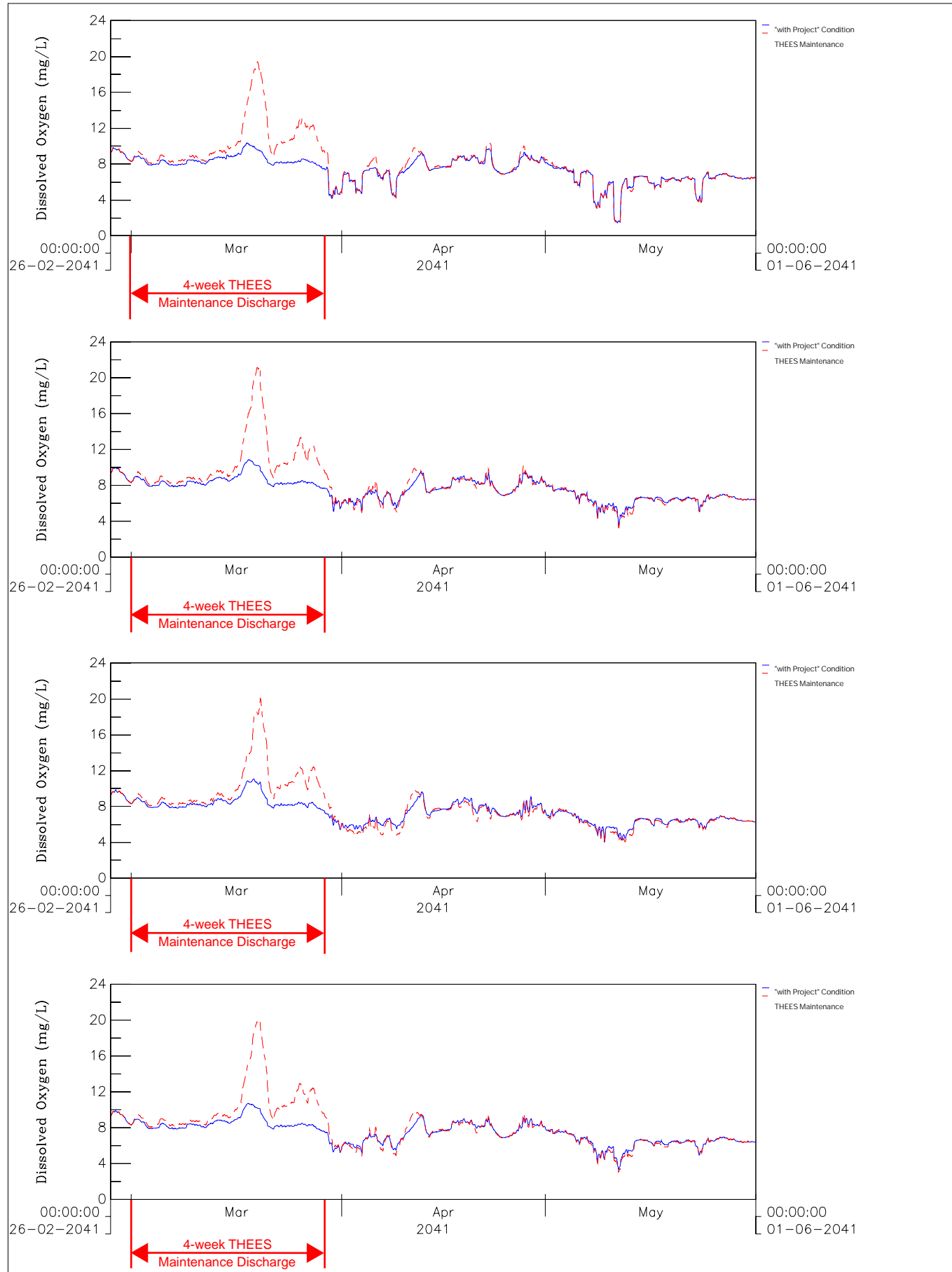
Timeseries Plot for Depth-Averaged E.coli (Top: TM4; Upper: TM6; Lower: B1)

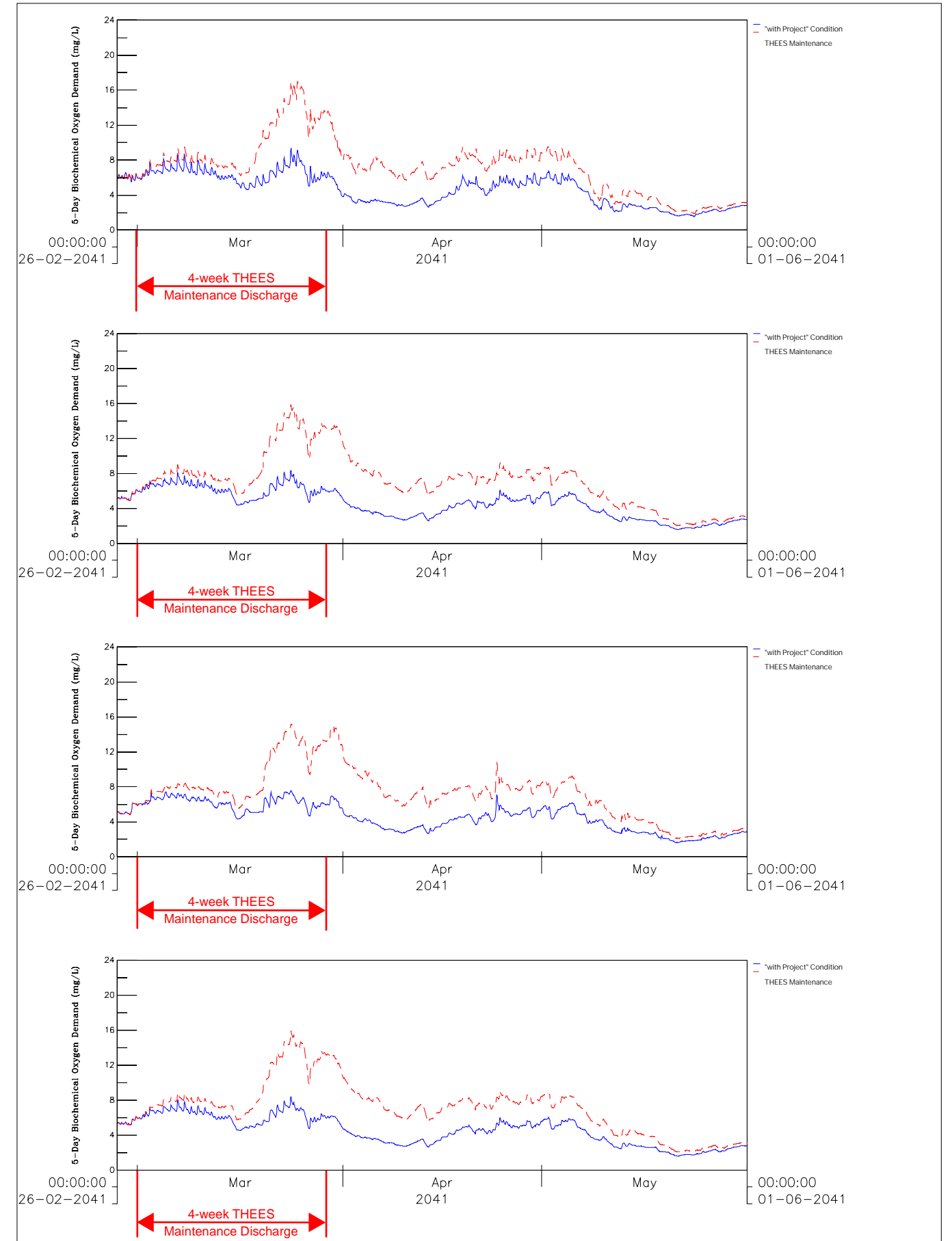

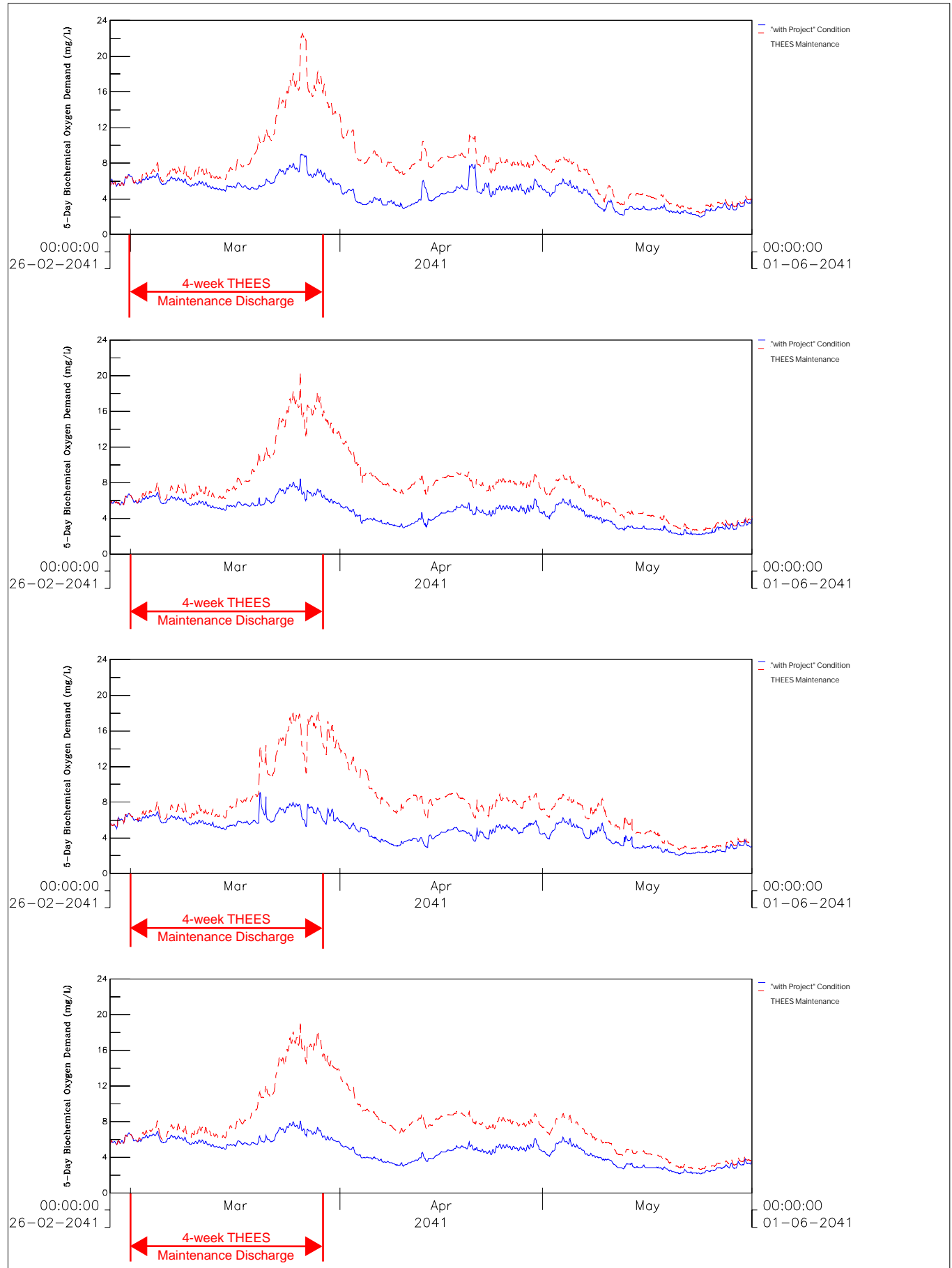
