You may wish to note that while the IMO regulation that commenced in January 2020 mandates bunker sulfur content of <0.5% for ocean-going vessels, the bunker for sale in Hong Kong is generally ~0.03% sulfur content, far lower than the legal requirement. It's because the bunker providers use the same fuel for local vessels, which have a requirement of <0.05% sulfur content. The refiners keep the sulfur content comfortably below the limit.
