2．A participant may withdraw from the Scheme at any time by serving a written notice to the EPD to that effect．The EPD may terminate or suspend the eligibility of a participant if the participant has failed to comply with the terms and conditions，or made false declarations deliberately．

3．A participant will be issued with a Scheme logo and QR code stickers for display on online platforms or at conspicuous location（s）of its retail outlet（s）and point（s）of sale． The Scheme logo and QR code stickers are the property of the EPD．If a participant intends to use the Scheme logo in its advertisements，promotional materials，busines websites，mobile apps social media platforms or other channels，application must be submitted to the EPD for obtaining prior approval．
