



符合法例及其他要求

Compliance to Legal Requirements & Other Requirements

- 地區性的法例與規例
 - 有害物質使用限制指引 禁止在歐盟國家出售含有(或製造過程中利用)某些禁用物質的電器及電子設備
 - 電器及電子設備廢料處理指引-限制電器及電子設備的廢物,要求製造商負責電器及電子設備的回收及循環再造已使用的產品
- Regional based Legislations & Regulations
 - Restriction of Hazardous Substances (RoHS) ban the sale in the EU of certain categories of E&E equipment containing (or manufactured using) certain banned substances
 - Waste Electrical and Electronic Equipment (WEEE) restrict the types of hazardous in E&E equipment as well as to require manufacturers to be responsible for the collection, recovery and recycling of used products



環境管理體系及ISO 14001的認證要求 EMS & ISO 14001 Certification Requirements

- 承諾保護環境、符合法例及良好的環境表現
 - 長期合作伙伴的「必須」要求
 - 在指定期間取得ISO 14001認證
 - 要求二線供應商取得 ISO 14001認證
- demonstrate of commitment to environmental protection, fulfillment of legislations and good environmental performance
 - A "MUST" requirements for long-term partners
 - ISO 14001 certification acquisition within a scheduled timeframe
 - Require second tier contractor to acquire ISO 14001





Cleaner Production & Eco-Design Requirements 清潔生產及環保設計要求

清潔生產

(生產過程中):節約原料、水及能源;消除有毒及危險的物料; 及有毒氣體的排放及廢物的產生

- 環保設計
 - 考慮產品的生命週期
 - 可循環再用性、可循環再造性、耐用性或容易處理
 - 控制或禁止使用有害化學物質,及能源效益

Cleaner Production

(During Production) conserving raw materials, water and energy; eliminating toxic and dangerous materials; and reducing toxic gases emission, waste generation

- Eco-design
 - Concern life cycle of a product
 - the reusability, recycleability, durability and ease of disposal
 - the control or non-use hazardous chemical substances & energy efficiency

Other Environmental Requirements

achieve sustainability compliance/ follow the customers' code of conduct (HSE considerations) / Conducts safety inspections
