


## 香港中小企業 SMEs in Hong Kong

- → Non-manufacturing: < 50 employees




## 香港中小企業 SMEs in Hong Kong

Upon receipt of duly completed applications for guarantee from participating lending institutions, the Trade and Industry Department will take three clear working days to consider whether to provide the guarantee


