# **Glass Container Recycling Charter**

The Environmental Protection Department (EPD) has launched the "Glass Container Recycling Charter" (the "Charter") and invites all interested parties in the community to become our Partners to participate actively in and jointly promote glass container recycling.

#### **Objectives**

The objectives of the Charter are to –

- Raise public awareness on glass container recycling and drive behavioural change towards practising source separation and clean recycling of waste glass containers so as to cultivate good recycling habits;
- Promote participation and increase recycling of waste glass containers progressively to achieve the overall recovery target of 50,000 tonnes a year, which is about half of their amount generated; and
- Facilitate different sectors in the community to actively participate in glass container recycling.

#### How to become our Partner

- Promoting the Charter and disseminating the information to members;
- Encouraging members to practise source separation and clean recycling of waste glass containers and engage the free collection services of the Government-appointed Glass Management Contractors; and
