

Invitation for a Briefing on Development of Integrated Waste Management Facilities Phase 2 (I•PARK2)

In the Waste Blueprint for Hong Kong 2035, the Government of the Hong Kong Special Administrative Region sets out the vision to move away from the reliance on landfills for direct disposal of MSW by around 2035. The Government's strategy has two main directions. The first is to mobilise the entire community to practise waste reduction and waste separation for recycling in the upstream. The second is to proactively drive the development of downstream WtE facilities for sustainable disposal of the remaining MSW. The Environmental Protection Department (EPD) are working at full steam on developing of the first modern waste-to-energy (WtE) incinerator project in Hong Kong (Integrated Waste Management Facilities Phase 1 (I•PARK1)) which currently under construction near Shek Kwu Chau, is expected to handle 3 000 tonnes of MSW per day. The EPD are also actively planning for the development of the Integrated Waste Management Facilities Phase 2 (I•PARK2) at Tuen Mun, Tsang Tsui, with an expected MSW handling capacity of about 6 000 tonnes per day.

The EPD, together with our consultant Binnies Hong Kong Ltd, will organize a Briefing on the proposed I•PARK2 and provide the industry with the latest development of the project:
