NOTES :

1. The applicant shall fill in an application form for each model.
2. The applicant shall submit all relevant trade leaflets, brochures or similar documents for the Authority's consideration.
3. The applicant must submit for the Authority's consideration either—
 - (a) a noise testing report certificated by—
 - (i) a corporate member of the Hong Kong Institute of Acoustics Limited;
 - (ii) a professional member of the Hong Kong Institute of Qualified Environmental Professionals Limited; or
 - (iii) a registered professional engineer (as defined by section 2(1) of the Engineers Registration Ordinance) in the building services, environmental or mechanical discipline, that the testing was conducted in accordance with the conditions set out in Schedule 2 to the Noise Control (Hand Held Percussive Breakers) Regulations; or
 - (b) supporting documents showing that the hand held percussive breaker complies with a standard that is substantially the same as or more stringent than that set out in Schedule 1 to the Regulations when tested under conditions comparable to those set out in Schedule 2 to the Regulations.
4. The applicant shall submit a fee of \$530 for each label applied for. The fee payable on submission of this application will not be refunded. Cheques, drafts or cashier orders shall be made payable to "The Government of the Hong Kong Special Administrative Region" or "The Government of the HKSAR" and crossed.
5. *Regulation 8(3)* of the Noise Control (Hand Held Percussive Breakers) Regulations provides that not later than 28 days after an application is received by the Authority, the Authority shall issue a noise emission label or labels applied for or serve on the applicant written notice of his refusal to issue the label or labels, and if at the end of those 28 days he has done neither of those things, a label or labels shall be deemed to have been issued.
6. A noise emission label that is issued in consequence of misleading, false, wrong or incomplete information furnished by an applicant in connection with the application is liable to be cancelled.
7. The applicant is advised to read the Noise Control Ordinance and the Noise Control (Hand Held Percussive Breakers) Regulations.

Checklist in sending application for Noise Emission Label

1. Checklist of items to be submitted when applying for Noise Emission Labels (NELs):

Supporting documents	Supporting documents showing that the equipment complies with a standard that is substantially the same as or more stringent than that set out in Schedule 1 to the Noise Control (Air Compressors) Regulations or the Noise Control (Hand Held Percussive Breakers) Regulations when tested under conditions comparable to those set out in Schedule 2 to the respective Regulations. For example, EC Declaration of Conformity & relevant documentation under the Directive 2000/14/EC of the European Union: (1) An EC Declaration of Conformity as required under Article 8 of EU Directive 2000/14/EC (subject to latest version of the Directive)); AND (2) Assessment report/ Certificate of conformity issued by Notified Body as required under Annex VI, VII of the Directive; or document demonstrating that the quality assurance system has been approved by the Notified Body as required under Annex VIII of the Directive; AND (3) The relevant technical report of noise measurement / noise emission assessment / noise test (confirming compliance to the relevant noise limits as specified under Article 12 of the Directive) or A noise testing report certifying compliance of noise emission standards issued by a corporate member of the Hong Kong Institute of Acoustics Limited*; a professional member of Hong Kong Institute of Qualified Environmental Professionals Limited; or a registered professional engineer (as defined by section 2(1) of the Engineers Registration Ordinance) in the building services, environmental or mechanical discipline

2. The application form must be duly completed and signed by the applicant.
3. The application fee for each NEL applied for is HK\$530. Cheques, drafts or cashier orders shall be crossed and made payable to “The Government of the Hong Kong Special Administrative Region” or “The Government of the HKSAR”. The fee payable on submission of the applications will not be refunded.
4. The application will be processed within 28 days (90% in 15 days under EPD's performance pledge).

Control of Noise from Hand Held Percussive Breakers & Air Compressors

1. The Control

The Noise Control (Hand Held Percussive Breakers) Regulations and Noise Control (Air Compressors) Regulations made under the Noise Control Ordinance require that

- (a) **hand held percussive breakers** having a mass of above 10 kg and **air compressors** (for construction work) capable of supplying compressed air at 500 kPa or above shall comply with the following noise emission standards as stipulated in the regulations; and

2. Penalties for an offence

Any person who contravenes the requirements mentioned in paragraph 1(a) or 1(b) above commits an offence and shall be liable to a fine at level 6 on first conviction and up to HK\$200,000 on second or subsequent conviction and in any case a fine up to HK\$20,000 for each day during which the offence continues.
