Submission of tenders : Tenderer should submit the completed Tender Documents and all accompanying documents in triplicate under one sealed envelope, as described in Clause 3 and 6 of the Terms of Tender (Supplement) of Tender Document, marked “TENDER REF. CR19015” (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Tender Opening Committee, Government Logistics Department, and deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12:00 noon (Hong Kong Time) on **31 October 2019\***. Tenders must be deposited in the tender box as specified in this tender notices (“Specified Tender Box”) before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. In the event of tropical cyclone warning signal No. 8 or above or a black rainstorm warning signal is in effect at any time between 9:00 a.m. and 12:00 noon on **31 October 2019\***, the tender closing time will be postponed to 12:00 noon on the first working day after the tropical cyclone warning signal No.8 is lowered or the black rainstorm warning signal has ceased to be in effect. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on **31 October 2019\***, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website of Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Important Notes : The Tenderer for this contract must comply with all the essential requirements described in Paragraph 8.3 of the Terms of Tender (Supplement) of Tender Document. The Tenderer shall include all the relevant supporting documents / documentary proof to demonstrate that the Tenderer have fully complied with the essential requirements. A Tenderer’s claim with respect to essential requirements that is not supported by supporting documents / documentary proof shall not be considered valid. Tenderer who fails to demonstrate that it has fully complied with all essential requirements will not be considered further.

Remarks : 1. This tender is NOT covered by the Agreement on Government Procurement of the World Trade Organization.

2. The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or, as the assessment of the tenders is based on a marking scheme, the tender has the highest combined score of financial offer and technical proposal.

3. The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any or all tenderers about the terms of the offer.
