

# Guidance Note for Ozone Depleting Substances (ODS) Destruction at the Chemical Waste Treatment Centre (CWTC)

Ozone Depleting Substance (ODS) including halons, Chlorofluorocarbons (CFCs) and Hydrochlorofluorocarbons (HCFCs) requiring disposal are classified as chemical waste under the Waste Disposal (Chemical Waste) (General) Regulation and should be disposed of at a licensed facility.

# **ODS Destruction Facility**

# Waste Producer Registration

Any person or company requiring disposal service should first register with the Environmental Protection Department (EPD) as waste producer.

Packaging labelling and storage of chemical waste will need to comply with the above-mentioned Regulation.

For the disposal of gaseous ODS waste, prior notification to the EPD is required.

### Waste Collection and Disposal

Waste producers are also required to engage licensed waste collectors to collect and deliver waste to the CWTC for disposal.
