Objectives

- Facilitate different sectors in the community to actively participate in glass container recycling so as to progressively achieve the overall recovery target of 50% of the amount of waste glass containers generated.

How to become our Partner

Any interested organization/company may sign up the Charter to become our Partner committing to

- Practising source separation and clean recycling of waste glass containers at the premises (e.g. setting up glass container reycling bins);
- Engaging the Government-appointed Glass Management Contractors (or operators of the Green@ Community¹) for free collection service of the separated waste glass containers for proper recycling and treatment; and
- Supporting the Charter and related activities.

Benefits of the Participants

Support: Government-appointed Glass Management Contractors (or operators of the Green@ Community¹) would provide free collection service of waste glass containers and the collection record. Commendation: The Participants will be provided with a Charter certificate and a Charter sticker label for display on their premises as recognition of their commitment and effort taken in glass container recycling, as well as other publicity materials for use in promoting glass container recycling.
